SESSION DESCRIPTIONS

∞ MORNING BREAK-OUT SESSIONS (Select one) ∞

SESSION #A1: Differences in Exterior Routes (Plumeria Room)

This session will focus on the differences between a pedestrian access route in the public right-of-way, accessible shared use paths and accessible routes on-site. The session will address questions such as: When are you required to provide one versus another? Is an accessible route required to sporting areas such as tennis courts, play fields, etc.? Also to be discussed are the requirements for providing on-site accessible parking versus on-street accessible parking. (1.5 HSW/CEU)

SESSION #B1: Accessible Transient Lodging (Garden Lanai)

Hotels and dormitories are both required to comply with transient lodging provisions of the ADAAG. This session will focus on the design and construction requirements for providing accessible transient lodging sleeping rooms designed for mobility access and communication access. In addition, the session will cover lobby and registration areas, public/common use toilet rooms, drinking fountains, telephones and signage. (1.5 HSW/CEU) **Speaker: Marsha Mazz** (U.S. Access Board)

SESSION #C1: Common Errors and Barriers to Access (Carnation Room)

The Department of Transportation (DOT) and the Department of Land and Natural Resources (DLNR) will discuss the common errors these agencies have seen during design and construction. The Disability and Communication Access Board (DCAB) will be discussing the common mistakes and errors they find when conducting their document reviews. These common mistakes create barriers that do not provide the required access for persons with disabilities. (1.5 HSW/CEU)

SESSION #A2: Accessible Education Facilities (Plumeria Room)

It's important to ensure all students are provided access to classrooms and facilities on campus. This session will focus on the requirements for not just typical classrooms, but specialized classes such as science labs and common areas such as cafeterias, exercise rooms and locker rooms. (1.5 HSW/CEU) **Speaker: Mona Higa** (DCAB)

SESSION #B2: Accessible Swimming Pools and Spas (Garden Lanai)

Everyone needs access to swimming pools and spas where they are provided at hotels or on a school campus. This session will focus on the design and construction requirements for providing access to swimming pools and spas in new construction and alterations. (1.5 HSW/CEU)

Speaker: Bill Botten (U.S. Access Board)

SESSION #C2: DOT/DOJ/HUD – Differences in Design Standards (Carnation Room)

Both the Department of Justice (DOJ) and the Department of Transportation (DOT) enforce standards under the ADA. Curtis Motoyama of Hawaii DOT will explain the differences between DOJ's and the DOT's ADA design standard. The Department of Housing and Urban Development (HUD) is allowing the use of the 2010 ADA Standards in lieu of UFAS, except for certain provisions. Duane Buote of DCAB will discuss those areas in the 2010 Standards that HUD feels is less stringent than UFAS. (1.5 HSW/CEU) **Speakers: Curtis Motoyama** (DOT) and **Duane Buote** (DCAB)
