From the time Alvin C. Bronstein, MD, FACEP joined the Hawaii State Department of Health as the new chief of the Emergency Medical Services and Injury Prevention System Branch on Aug. 31, he has been fully immersed in carrying on the branch’s goal of reducing trauma-related deaths, injuries, and permanent long-term disability and improving trauma response capabilities statewide.

“I am honored to join the Hawaii State Department of Health as the new EMS Injury Prevention System Branch chief. The branch has a history of excellence and service, and building on the branch’s achievements is very important to me. My top priority as described in the Governor’s vision statement is to be “pono” – always do the right thing for the people of Hawaii.”

In his new role, Dr. Bronstein is responsible for the overall statewide coordination of the delivery of health care services under emergency conditions. This includes optimizing medical and surgical treatment for all seriously injured individuals in Hawai‘i. He will work with hospitals and health care providers to identify problems and collaboratively develop and implement solutions to improve patient treatment and outcomes.

He will also support the Statewide Trauma Advisory Committee and Regional Trauma Committees, and serve as a resource to hospitals to develop and maintain their trauma centers. He will develop procedures for the designation and periodic re-verification of hospitals as trauma centers, and ensure a statewide trauma registry is used to drive improvements in trauma care at hospitals at the state and county levels.

Kapi'olani Medical Center for Women and Children (KMCWC) is proud to announce that the hospital has officially received re-designation approval from the Hawai'i State Department of Health as a Level III Pediatric Trauma Center. An on-site evaluation was

conducted at KMCWC on May 28 and 29, 2015, by a team of trauma surveyors from the Trauma Center Association of America (TCAA). The trauma surveyors verified that KMCWC meets the state criteria for trauma center designation and recommended approval to the Hawai'i State Department of Health officials. The DOH was present at the time of the evaluation and subsequently granted the Level III Pediatric re-designation status to KMCWC, effective July 15, 2015.

## Preventing Infant Deaths through Safe Sleep Education

Unintentional suffocation is a leading cause of fatal and nonfatal injury among infants<sup>1</sup> and Sudden Infant Death Syndrome (SIDS) is the leading cause of death among infants between the age of one month and one year; the third leading cause of infant mortality overall in the United States.



In Hawai'i, data<sup>3</sup> SIDS was the leading cause of death among post-neonate resident infants in Hawai'i, accounting for 13% of the deaths over the 2010-2014 period. Data<sup>2</sup> also indicates that only 35.4% of babies usually sleep in an environment that meets all of the American Academy of Pediatrics' (AAP) recommendations for a safe sleep environment. As many families are unaware of the simple preventative steps, as well as the behaviors and risk factors that endanger their infant, education is an ongoing area of importance for the nearly 19,000 births each year in Hawai'i.<sup>2</sup>

## Safe Kids Hawai'i is the state coalition led by Kapi'olani Medical Center for Women & Children.

Preventable injuries are the number one killer of kids in the U.S. According to Safe Kids Worldwide, 8,000 families lose a child every year because of a preventable injury. Hawai'i State Department of Health data shows an average of 13 children die each year. For every death, 14 children are hospitalized and 740 are treated at emergency departments. Too many times a parent experiences the dreadful moment that their child has died from an injury. And too often when a parent asks "was there something I could have done to prevent this" doctors are forced to say "yes". This was the case for Dr. Marty Eichelberger. In 1988, Dr. Marty Eichelberger, a pediatric surgeon and Herta Feely, a public relations professional from Children's Health System in Washington, DC founded Safe Kids Worldwide from the frustrations of seeing kids being killed from preventable injuries.



## Resources and Tools

- **Hawai'i Public Health Training Hui [Needs Assessment Report](#)** assess the training needs of the public health workforce in the State of Hawai'i, a needs assessment was conducted using a survey tool developed and modified by Denise Nelson-Hurwitz, Valerie Yontz, and other members of the steering committee members of the Hawai'i Public Health Training Hui (PHTH). The survey was developed online and distributed to potential participants by email primarily between July 14, 2015 and August 4, 2015. Survey participants were asked for demographic information, as well as information about self-assessed skill/expertise level and potential interest in eight public health workforce skill domains and specific workforce skills within each domain. Further information was asked to assess the level of training interest.

- **The Western Pacific Injury Prevention Network** began in 2011 as a result of a CDC-funded initiative for a Regional Network. Washington State was awarded the grant to convene Health and Human Services regions 9 and 10 and the US Affiliated Pacific Islands. Will Hitchcock, PhD, is the new Regional Network Leader Coordinator, responsible for the regional project by planning and providing facilitation to build capacity amongst membership. Membership is open to all injury and violence prevention state and territorial staff, injury control research centers and public and private sector injury prevention advocates within the region. We work collaboratively through shared leadership to exchange information and resources, share best practices, and strengthen the relationships of all members in order to build injury and violence prevention capacity across the network.




- [Concussion at Play: Opportunities to Reshape the Culture Around Concussion.](#) This report provides a snapshot on the current concussion research pertaining to knowledge, awareness, attitudes and behaviors. This new report also describes opportunities to help build a culture in sports where athletes take steps to: lower their chances of getting a concussion, recognize concussion symptoms, and report concussion symptoms. This involves moving beyond our general concussion knowledge and changing the way we talk about and respond to concussion. This will empower athletes to not play with a concussion or hide their symptoms.


