- 1. Be a resident of the State of Hawaii
- 2. Be at least 21 years of age
- 3. Be at least a nurse aide
- 4. Have a home/facility meeting Hawaii Administrative Rules (HAR) Title 11 Chapter 100.1 ARCH (Rules & Regulations)
- 5. Have completed department-approved ARCH training
 - If you have attended the ARCH teaching modules over 5 years ago, you must retake all modules
 - a. Kapiolani Community College (KCC)
 - <u>RN /LPN</u>: ARCH module for RN/LPN (<u>ONLY AVAILABLE AT KCC</u>) Phone: (808) 734-9211
 - <u>Nurse aide</u>: Module 12 (Diseases, Diet & Medications) Module 13 (Helping Therapies & Behavior Management) Module 14 (Regulations, Accounts, Community Resources) Phone: (808) 734-9305

- 6. Have at least one year experience working full time or its equivalent providing direct nurse aide care as an employee of a state licensed and approved ICF, SNF, home health agency, or hospital
- 7. Have knowledge of and be able to practice the principles of resident care incorporating the concepts of the social model through family and community centered activities and approaches
- 8. Demonstrate to the department sufficient skill in the use of the English language to fully accomplish the objectives of the program and to comply with the requirements of Title 11 Chapter 100.1
