## ADMINISTRATOR'S REPORT January 2013

### Subarea Health Planning Councils (SACs) Activities

**Kauai** Members are scheduled to meet on January 30, 2013, and continue their work on the development of a community assets map.

**Honolulu** Members met on December 6, 2012. Members participated in an online meeting with Mr. Kleber Palma, Director of the New York City Department of Education's Translation and Interpretation Unit. Mr. Palma gave a general overview of how an organization can establish language access services within their organization. He also reviewed tactics to ensure quality of translation services delivered. Finally, he provided additional advice as how to build upon translation work already completed and how to use entry points when establishing language access services. Next meeting is scheduled for February 7, 2012.
