ADMINISTRATOR'S REPORT June 2012

Subarea Health Planning Councils (SACs) Activities

- Kauai** Members met on May 2, 2012, and heard from Mr. David Peters, Chief Executive Officer, Ho`ola Lahui Hawaii, about "Meeting Kauai's Primary Care Needs".
- Honolulu** Members met on May 3, 2012 and heard from Ms. Dee Dee Nelson, of Mountain-Pacific (Mountain-Pacific) Quality Health—Hawaii. Ms. Nelson provided an overview of Hawaii's Quality Improvement Organization (QIO) Program, history of Mountain-Pacific, its statutory mission, vision, and scope of work. Quality measures to improve individual patient care include reducing healthcare associated infections, reducing various healthcare associated conditions (e.g. pressure ulcers, physical restraints) and providing technical assistance regarding hospital clinical process of care measures. Mountain-Pacific also works to integrate care (e.g. reduce readmissions) and improve health for populations and communities (e.g. work with physicians and staff to improve flu immunizations).
- West Oahu & Windward Oahu** Members met on May 9, 2012 and heard from Ms. Maria Pacheco, Board President of the Ko`olauloa Community Health and Wellness Center, on "Addressing Windward Oahu Health Needs".
