Subarea Health Planning Councils (SACs) Activities

Kauai Members are scheduled to meet on October 30, 2012 and continue their work on the development of a community assets map. The members are compiling information for an assets map that will include the various components of the health care delivery system and the community resources/assets available to improve health.
