### Subarea Health Planning Councils (SACs) Activities

**Kauai** The Kauai County Subarea Health Planning Council (KCSAC) met on April 14, 2016. The next meeting will be on June 24, 2016.

**Honolulu** The Honolulu Subarea Health Planning Council (HONSAC) met on April 7, 2016 and April 27, 2016. HONSAC continued their discussions on the elder abuse project. The next meeting is May 5, 2016.

**West Oahu** The West Oahu Subarea Health Planning Council (WOSAC) did not have a scheduled meeting in April 2016. The next meeting will be on June 15, 2016.
