### **MEMORANDUM**

SUBJECT:

**Designated Smoking Areas** 

Section 8.20.030 of the Maui County Code prohibits smoking in any enclosed or partially enclosed area or building (including areas covered by a permanent or temporary roof, canvas, awning, canopy, or overhang) owned, leased, operated, or maintained by the County and in vehicles owned or leased by the County.

Employees have objected to smoking in areas at Kalana O' Maui such as next to the loading dock near Civil Defense and the landings outside the doors to the stairwell on each floor. Smoking so close to the building causes smoke to enter the stairwells and permeate offices and creates a potential fire hazard.

This memorandum is to inform all employees who work in, and visit, the Kalana O' Maui, Kalana Pakui and Old Wailuku Courthouse buildings that effective immediately, smoking is allowed only in the following designated areas:

- 1. The picnic tables adjacent to the Directors' parking area.
- The front of the buildings adjacent to the public parking lot.
- 3. The mezzanine level, when it becomes accessible.

As a guide for the recommended distance of smoking areas, the County's Fire Prevention Plan specifies that an ignition source be at least twenty-five feet away from anything combustible.

## Effective November 16, 2006 Hawaii's Smoke-Free Law

- The purpose of the law is to ensure that workers have a safe work place, and that non-smokers and those with respiratory conditions can breathe smoke-free air in the public places they visit.
- Signs shall be posted at entrances and places of employment where smoking is prohibited.
- All personnel are required to follow the requirements of the law.
