NOTICE OF PUBLIC PARTICIPATION AND INPUT ON THE PROPOSED
WATER POLLUTION CONTROL REVOLVING FUND
INTENDED USE PLAN FOR STATE FISCAL YEAR (SFY) 2015
AND FEDERAL FISCAL YEAR (FFY) 2014 APPROPRIATION

(DOCKET NO. 15-WW-SRF-1)

Pursuant to Chapters 342 and 91, Hawaii Revised Statutes, Section 101(e) of Public Law 92-500 and the U.S. Environmental Protection Agency (EPA) Regulations, 40 CFR 35.2015, notice is hereby given that a 30-day public comment period is being initiated to allow public participation and input on the proposed Intended Use Plan (IUP) for SFY 2015 and the FFY 2014 appropriation.

The EPA grants monies to the State of Hawaii annually to construct wastewater pollution control facilities. During FFY 2014, approximately \$11 million will be allocated to the State of Hawaii. In order to utilize the state revolving funds, proposed projects must be prioritized and listed on the Project Priority List for SFY 2015. The IUP also includes the implementation schedule for the projects proposed to receive loans from the State Revolving Fund during SFY 2015.

The IUP is also available for public inspection during regular office hours, Monday through Friday, 7:45 a.m. to 4:30 p.m. from **January 3, 2014** to **February 2, 2014** at the locations listed below.

All comments on the IUP and any request for a public hearing must be made in writing, addressed to the Oahu Wastewater Branch, and postmarked or received by **February 2, 2014**. Upon request, a public hearing may be scheduled for any county. If public hearings are deemed appropriate, a second public notice will be published with the scheduled date, time, and location of the hearings.
