ORDER AMENDING PARAGRAPH II.8 OF THE SCHEDULING AND PRE-HEARING ORDER, FILED DECEMBER 14, 2021, REGARDING "PRE-HEARING FILINGS"

In Paragraph II.8 of the Scheduling and Pre-Hearing Order, filed December 14, 2021, it states, in pertinent part: "The parties and the proposed intervenors must ensure that pre-hearing filings are filed no later than Friday, December 17, 2021, at 3:00 p.m. . . ."

On December 15, 2021, counsel for proposed intervenor Sierra Club, Kylie Wager Cruz, Esq., made a respectful request by email that the deadline for pre-hearing filings be extended to Saturday, December 18, 2021, at 12:00 p.m. (noon), for the reasons stated in her email. Counsel for the Navy, Mr. Craig D. Jensen, Esq. and the Department of Health, Deputy Attorney General Wade D. Hargrove III, Esq., and counsel for proposed intervenor Honolulu Board of Water Supply, Ella Foley Gannon, Esq., all affirmatively stated via email that they do not object to the request. The relevant string of emails is attached to this order.

The Hearings Officer finds that the Sierra Club's request is reasonable under the

circumstances of this proceeding. The request is granted.

Therefore, it is ordered that Paragraph II.8 is amended to read as follows:

8. Pre-Hearing Filings

The parties and the proposed intervenors must ensure that pre-hearing filings are

filed no later than Saturday, December 18, 2021, at 12:00 p.m. (noon). Such filings

include a pre-hearing brief, an exhibit list, all exhibits on the exhibit list, a witness list,

and any anticipated demonstratives. If any party or proposed intervenor wishes to file

anything beyond this, it shall raise it at the December 17, 2021 status conference, or

earlier.

Dear Hearings Officer Day,

Upon reviewing the scheduling order, we noticed that you set Friday, 12/17, at 3 p.m. as the prehearing filing deadline.
