

## Provider Update: CARE Hawaii Increases Forensic Residential Capacity

CARE Hawaii, a valued AMHD provider and key partner in our continuum of care, has increased its forensic residential services on O'ahu.

The Palekana Residential Program at Leahi Hospital will add two new beds, increasing access to 24-hour, recovery-focused treatment for individuals with severe mental illness involved in the forensic system. This increase helps address the high demand for specialized, community-based forensic residential placements.
