**SUBJECT: Courtesy Reminder for 2026 Annual Fees for Covered Source Permits (CSPs)
For Operation in Calendar Year 2025**

The Annual Fees for CSPs are required to be submitted to the Department of Health, Clean Air Branch (CAB), by **April 30, 2026** (120 days after the end of the calendar year). The annual fees are based on the tons of regulated criteria air pollutants and greenhouse gases (both biogenic and nonbiogenic) emitted during the prior calendar year. Fees are being charged for primary particulate matter (including both filterable and condensable portions), sulfur dioxide, nitrogen oxide, and carbon dioxide equivalent emissions.

In addition to submitting the Annual Fee payment, all holders of a CSP must submit five (5) forms: F-1CP, F-1GHG, F-2CP, F-2GHG, and F-3CP/GHG. The forms may be downloaded from the CAB website at:

Other documents to assist with calculating and submitting annual fees are also available on the website, including a copy of the 40 Code of Federal Regulations (CFR) Part 98, Table A-1 and "Annual Fee Instructions for Covered Sources." If you are unable to access the forms, please contact CAB staff at the phone number or e-mail address provided below.

If additional time is needed to submit your 2026 annual fees, a written request for an extension must be submitted at least fifteen (15) days prior to the required submission date in accordance with the Hawaii Administrative Rules §11-60.1-114(b).

The following are reminders of other requirements:

- Annual Emissions Reports, Semi-annual Monitoring Reports (for July through December), and Annual Emissions/Monitoring Reports:

With a few exceptions, March 1, 2026, is the due date for Annual Emissions Reports, Semi-annual Monitoring Reports (for July through December), and Annual Emissions/Monitoring Reports.

- State and Local Emissions Inventory System (SLEIS):

If the Federal Air Emissions Reporting Requirements apply to your facility, emissions inventory data is required to be reported using SLEIS. The SLEIS web page can found at: <https://eha-cloud.doh.hawaii.gov/sleis>.
