GENERAL INFO

The Family Court Liaison Branch (FCLB) is a branch of the Child and Mental Health Division (CAMHD) of the State of Hawaii Department of Health. The FCLB is located at the Hawaii Youth Correctional Facility (HYCF) and provides direct clinical mental health services to the youth at the HYCF. The FCLB works in collaboration with the HYCF Staff in order to provide mental health services to youth throughout their incarceration. The HYCF staff includes Social Workers, Youth Corrections Officers, medical staff and Department of Education Staff. Additionally, the FCLB is comprised of Workers. Social **Psychiatrists** Psychologists with whom the Intern can expect to work closely. Many youth also receive services from the CAMHD via a Family Guidance Center (FGC) outside of the HYCF, and the FCLB works closely with the youth's home FGC in order to ensure continuity of care and successful transition back to community based mental health services.

HAWAII YOUTH CORRECTIONAL FACILITY (HYCF)

The HYCF works closely with the courts and the Office of Youth Services to ensure that any commitment to the HYCF is a "last resort" – after all community-based services have been exhausted. Identification of community-based programs as alternatives to incarceration is ongoing.

To better coordinate the State's abilities and efforts to provide services, the HYCF continues building partnerships with various public agencies, including the DHS, DOE, DOH, Family Court, county agencies including law enforcement agencies, and non-profit agencies. A multi-disciplinary team, comprised of the DOE, DOH, HYCF, Contract Service Providers, youth and parents, is involved in development of the at-risk youths' Individual Service Plan and reintegration back into their community. HYCF continues to provide an intensive Aftercare/Reentry Program through the Parole Section for youth transitioning out of the HYCF and returning to their families/communities.

FAMILY COURT SERVICES

Hale Ho'omalu Juvenile Detention Facility - The Hale Ho'omalu Juvenile Detention Facility is a 24-hour secure facility. At the facility, a team of juvenile detention staff, cooks, probation officers, and a nurse provide educational, recreational, health, guidance, and diagnostic services to juveniles who require temporary secure custody.

Home Maluhia - Home Maluhia, a nonsecured facility, provides therapeutic counseling and rehabilitative services for status offenders and minor law violators who do not require detention.
