



## **INSTRUCTIONS FOR ACCESSING PRACTICEWISE: FREE CLINICAL TRAININGS**

### **Introduction**

“PracticeWise offers innovative tools and services to help clinicians and organizations improve the quality of health care for children and adolescents. You may also view the same trainings for continuing education credits (approved by the American Psychological Association) by viewing and participating in the paid version of the training.

### **Instructions**

1. Visit <https://www.practicewise.com/Home>
2. Register by clicking on the red “Join Now” button.
3. Read the terms of use by clicking on “Service Use Agreement”.
4. Register with pertinent information, username, password, and email for confirmation of orders. There is no cost to setting up an account.
5. Enter security code and click “Join”. This will also indicate you have read and accept the terms of use.
6. Hover cursor over “Store” at the top right and select “Browse Courses” from the drop down.
7. Browse courses and review the course descriptions.
8. Click the “Free Edition” button under your selected course. Click “Add to Cart”. (Note: If you are interested in receiving continuing education credits, you must purchase the paid versions of the courses)
9. Review the cart with \$0.00 (if free) and check out by clicking “Secure Checkout”, agreeing to the terms of use, and clicking “Place Order”.
10. A confirmation will be sent to you with your registered email.
11. View your course by clicking on “My Courses” and selecting your course under “Online Learning”.

#### **The Evidence-Based Services System Model:**

##### **Course Objectives:**

1. Recognize components of the EBS System Model as a way to effectively guide service decisions.
2. Describe how the EBS System Model can enhance clinical decision-making by considering the importance of multiple sources of information and people involved in treatment when answering common questions that arise during service planning and delivery.
3. Describe the rationale for using the EBS System Model to better inform clinical decision-making.
4. Identify some of the common perennial service-related questions that arise in youth mental health treatment, the persons involved in answering these questions, and how the EBS System Model supports both.
5. Examine two applications of the EBS System Model in service delivery: 1) a provider application of the model in planning treatment, and 2) a service administrator application of the model in determining the best service design for improving service quality in an efficient manner.
