School Reporting of COVID-19, Influenza, and Gastrointestinal Illness: Quick Reference

Communicable Disease	Symptoms	Incubation Period	Reporting Process for Schools
COVID-19 (SARS-CoV-2 Virus)	No symptoms or a wide variety of symptoms of variable severity including: <ul style="list-style-type: none"> • Cough, sore throat, and other respiratory symptoms with or without fever 	Usually 2–14 days after exposure	DOE School Staff: <ol style="list-style-type: none"> 1. Input all positive cases into the DOE Case Reporting Tool (CRT) 2. Contact DOH for support with outbreaks when positive cases and related probable cases combined are greater than 10% for entire school OR greater than 20% for one grade or classroom.
			Public Charter & Independent School and DHS Facilities Staff: <ol style="list-style-type: none"> 1. Required to report COVID-19 illness to the DOH when positive cases and probable cases combined are greater than 10% for entire school OR greater than 20% for one grade or classroom. 2. Influenza-like Illness (ILI) / Influenza (FLU)	Symptoms can include: <ul style="list-style-type: none"> • Cough and/or sore throat with an accompanying fever or history of fever 	Usually 1–4 days after exposure	DOE Schools <ol style="list-style-type: none"> 1. Required to report outbreaks of Influenza Like Illness (ILI) criteria (fever with cough and/or sore throat) to the DOH when positive influenza cases and related probable cases combined are greater than 10% for entire school OR greater than 20% for one grade or classroom. 2. To report ILI school outbreaks to HDOH, please email the School ILI Outbreak Form and the School ILI Line list to doh.docd.dib@doh.hawaii.gov
			Public Charter School, Independent School, and DHS Facilities Staff: <ol style="list-style-type: none"> 1. Required to report ILI to the DOH when positive cases and related probable cases combined are greater than 10% for entire school OR greater than 20% for one grade or classroom. 2. Gastrointestinal (GI) illness or suspected norovirus outbreaks	Symptoms can include: <ul style="list-style-type: none"> • Vomiting • diarrhea • abdominal pain/cramps 	Norovirus: 12-48 hrs. Other GI Illness: variable (link)	<p>DOE Schools</p> <ol style="list-style-type: none"> 1. Required to report outbreaks of gastrointestinal (GI) or suspected norovirus criteria (vomiting and/or diarrhea) to the DOH when: <ul style="list-style-type: none"> • Two or more cases of GI illness within 24 hours among student/staff who share an exposure or are close contacts AND do not live in the same household <u>OR</u> • Student absenteeism doubles due to GI illness, exceeding the normal rate for the time period based on school records 2.
