1. Introductions

3. Tools to assess and plan language development services

The assessment tool matrix is being finalized and will be provided at the next meeting.

A follow up discussion to a request from the last meeting was initiated. The request was to develop a list of informal resources that are available in the community to better support families. This is in addition to formal resources such as from the DOE and other State programs. The list of informal resources will assist in identifying gaps and may help in making recommendations on institutionalizing resources so that they are available to more people. A concern was expressed about the Working Group not being adequately prepared to present anything for the next legislation. (Note – Act 177 (2016) includes the Working Group making recommendations for a resource guide that includes national and state organizations and resources for families, and improvements concerning the statewide system of services that support age-appropriate language development for children from 0-5 years who are deaf, hard-of-hearing, or deaf-blind.)

The working group began to conceptualize a directory.

Criteria for Information Resources: The recommendation is to have a resource listing of community resources which would be searchable by age, focus, qualification of the individual, and financing (cost) of the opportunity.
