- A. Parking for Persons with Disabilities
 - HB 1869/SB 2341 Parking for Disabled Persons. Amends the
 definitions of "certificate of disability" and "person with a disability" to allow
 a person with a disability that does not limit or impair the ability to walk
 and needs special accommodations to enter and exit their vehicle to be
 issued a disability parking permit.
 - HB 2141 Parking for Disabled Persons. Requires private businesses selling goods and services to the public, including retail malls and shopping centers, to provide a minimum of 6 per cent of its parking spaces for persons with disabilities. Imposes a penalty for failure to comply.
- B. Nondiscrimination Against Persons with Disabilities/Civil Rights
 - HB 2053/SB 2312 Relating to Civil Rights. Prohibits discrimination against any individual in selection, termination, terms, or conditions of an internship or training program because of the individual's race, sex including gender identity or expression, sexual orientation, age, religion, color, ancestry, disability, marital status, arrest and court record, or reproductive health decision.
 - HB 2119/SB 2005 Relating to Voting. Requires that any person who is
 eligible to vote and applies for a new or renewal motor vehicle driver's
 license, provisional license, or instruction permit, or a new, renewal, or
 duplicate identification card be automatically registered to vote if that
 person is not already registered to vote unless the applicant affirmatively
 declines to be registered to vote. Authorizes access to and electronic
 transmission of databases maintained or operated by the counties or the
 department of transportation containing driver's license or identification

- card information to election officials and the statewide voter registration system. Effective 1/1/2021.
- HB 2418/SB 2243 Relating to Legislative Testimony. Requires the house and senate to permit remote testimony, via telephone, at public hearings.
- HB 2420/SB 2244 Relating to the Hawaii Civil Rights Commission.
 Clarifies the meaning of "program or activity receiving state financial assistance". Excludes cases within the scope of the Individuals with Disabilities Education Act from the jurisdiction of the Hawaii civil rights commission.
- SB 2032 Relating to Rental Discrimination. Prohibits discrimination, including in advertisements for available real property, based on participation in a housing assistance program, or requirements related to participation in housing assistance programs, in real estate transactions and requirements.
- SB 2137 Relating to Elections. Authorizes election officials to establish additional voter service centers.
- SB 2528 Relating to Health. Requires a retail establishment with an
 employee restroom to allow a customer suffering from an eligible medical
 condition to use that restroom during normal business hours, under
 certain conditions. Exempts a retail establishment and employees from
 civil liability in allowing a customer to use an employee restroom.
 Establishes fines.
- <u>HB 2664/SB 2676 Relating to Elections</u>. Addresses various inconsistencies in existing elections law to clarify and improve the administration of elections by mail.
- <u>SB 2794 Relating to Elections</u>. Makes housekeeping amendments to elections laws to clarify the administration of elections by mail.

C. Communication Access

- HB 2417/SB 2248 Relating to Human Services. Requires the
 Department of Human Services to establish a neighbor islands blind and
 visually impaired service pilot program to provide services and training for
 blind and visually impaired neighbor island residents. Appropriates funds.
 Repeals 06/30/2021.
- SCR 4/SR 3 Relating to Accessible Government Documents.
 Requesting the Disability and Communication Access Board, in
 collaboration with the Office of Enterprise Technology Services, to
 convene a working group on accessible government documents.

D. Service Animals for Persons with Disabilities

- SB 2200 Relating to Fair Housing Reasonable Accommodations.
 Requires licensed health care providers to make written findings whether
 a patient or client has a disability and whether the need for an assistance
 animal or service animal is related to the disability so long as certain
 circumstances are present. Requires the civil rights commission in
 consultation with the department of the attorney general to adopt rules
 and prescribe forms.
- SB 2473 Relating to Guide Dogs. Makes an appropriation for the planning and design of a professional training facility for guide dogs and

other professionally trained career dogs on a designated portion of the state animal quarantine facility in Halawa valley on Oahu.

E. Building Code/Design

- F. Community Based Services and Employment for Persons with Disabilities
 - HB 1613 Relating to Persons with Disabilities. Requires the department of human services to establish a Medicaid buy-in program for workers with disabilities.
 - HB 1633/SB 2245 Relating to Auditory Devices. Exempts gross
 receipts from the sale of auditory devices, such as hearing aids, from the
 general excise tax. Amends the definition of "prosthetic device" to include
 devices worn on the body. Exempts gross receipts from the repair of
 prosthetic devices from the general excise tax.
 - HB 2419/SB 2247 Relating to the Employment of Persons with Disabilities. Establishes Employment First as a state policy for persons with disabilities. Requires state and county agencies to implement Employment First in hiring and in all programs and services administered or funded by the State or counties. Applies Employment First principles to Medicaid home- and community-based waiver programs.
 - HB 2656/SB 2479 Relating to Access to Justice. Establishes the Hawaii Justice League Program to provide loan repayments on behalf of eligible lawyers that pursue public interest work in Hawaii. Provides for loan repayments by the University of Hawaii William S. Richardson School of Law. Creates the Hawaii Justice League Revolving Fund. Makes an appropriation. Effective July 1, 2020.
 - SB 2583 Relating to Hearing Aids. Requires health insurance policies and contracts issued after 12/31/2021 to provide coverage for the cost of hearing aids at a minimum of \$1,500 per hearing aid for each hearingimpaired ear every thirty-six months in their base plans. Exempts mandatory health care coverage from impact assessment report.

G. Transportation and Mobility

- HB 1676 Relating to Highway Safety. Establishes a three-year photo red light imaging detector system pilot program. Authorizes any impacted county to administer the photo red light imaging detector system pilot program. Establishes a photo red light imaging detector systems pilot program account as a special account within the general fund. Requires proceeds of fines expended in the county from which they were collected for operation of the photo red light imaging detector system pilot program. Appropriates funds. Sunsets 6/30/2023.
- HB 2253 Relating to the Traffic Code. Amends the statewide traffic code to allow for the chairperson of the Board of Land and Natural Resources and county chiefs of police to designate state or county employees or contractors to issue citations for traffic violations.

H. Emergency Preparedness

 SB 2080 – Relating to State Buildings. Requires the Department of Accounting and General Services to purchase and install, at minimum, one emergency evacuation chair per floor, excluding the floor of exit discharge, in each state building having two or more floors. Requires the Department of Accounting and General Services to maintain a list of and perform yearly inspection on emergency evacuation chairs in state buildings. Requires the Disability Communication and Access Board to conduct annual training and produce written informational material regarding the appropriate use of emergency evacuation chairs. Provides a phase-in period for the installation of emergency evacuation chairs. Appropriates funds. Effective 7/1/2020.

I. Administrative

 HB 2200/SB 2075 – Relating to the State Budget. To adjust and request appropriations for Fiscal Biennium 2019-21 funding requirements for operations and capital improvement projects of Executive Branch agencies and programs and to include appropriations from other departmental budget acts deemed necessary for program operations and capital improvements.

J. Other

- HB 1667 Relating to Health. Designates the month of October as "Disability Awareness Month: Employment, Enrichment, and Inclusion" in recognition of the employment challenges and successes of persons with disabilities in the State.
- HB 1958 Relating to Taxation. Amends the income tax credit for expenses for household and dependent care services necessary for gainful employment by changing the taxpayer's applicable percentage of employment-related expenses that constitutes the tax credit and cap amount.
- HB 2421/SB 2246 Relating to the Hawaii School for the Deaf and Blind.
 Creates a Board of Trustees for the Hawaii School for the Deaf and Blind to establish an independent governance structure for the school.

HB 1869/SB 2341 – Parking for Disabled Persons. Amends the
definitions of "certificate of disability" and "person with a disability" to allow
a person with a disability that does not limit or impair the ability to walk
and needs special accommodations to enter and exit their vehicle to be
issued a disability parking permit.

ACTION: SUPPORT (In accordance with the DCAB Legislative Position Statements)

 HB 2141 – Parking for Disabled Persons. Requires private businesses selling goods and services to the public, including retail malls and shopping centers, to provide a minimum of 6 per cent of its parking spaces for persons with disabilities. Imposes a penalty for failure to comply.

ACTION: SUPPORT (In accordance with the DCAB Legislative Position Statements)

- B. Nondiscrimination Against Persons with Disabilities/Civil Rights
 - HB 2053/SB 2312 Relating to Civil Rights. Prohibits discrimination against any individual in selection, termination, terms, or conditions of an internship or training program because of the individual's race, sex including gender identity or expression, sexual orientation, age, religion, color, ancestry, disability, marital status, arrest and court record, or reproductive health decision.

ACTION: SUPPORT (In accordance with the DCAB Legislative Position Statements)

• HB 2119/SB 2005 – Relating to Voting. Requires that any person who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification card be automatically registered to vote if that person is not already registered to vote unless the applicant affirmatively declines to be registered to vote. Authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver's license or identification card information to election officials and the statewide voter registration system. Effective 1/1/2021.

 HB 2418/SB 2243 – Relating to Legislative Testimony. Requires the house and senate to permit remote testimony, via telephone, at public hearings.

ACTION: SUPPORT WITH COMMENTS (In accordance with the DCAB Legislative Position Statements, explain the need to ensure that all programs, services, or activities associated with livestreaming and remote testimony are accessible to the full spectrum of persons with disabilities, especially persons with communication access needs.)

HB 2420/SB 2244 – Relating to the Hawaii Civil Rights Commission.
 Clarifies the meaning of "program or activity receiving state financial assistance". Excludes cases within the scope of the Individuals with Disabilities Education Act from the jurisdiction of the Hawaii civil rights commission.

ACTION: SUPPORT (In accordance with the DCAB Legislative Position Statements)

SB 2032 – Relating to Rental Discrimination. Prohibits discrimination, including in advertisements for available real property, based on participation in a housing assistance program, or requirements related to participation in housing assistance programs, in real estate transactions and requirements.
