 - A. Non-Discrimination

[SB1496](#) – Relating to Civil Rights. Establishes that it is an unlawful discriminatory practice for places of public accommodation to deny a person with a disability full and equal enjoyment of information related to their services, facilities, privileges, advantages, or accommodations using information and communication technology intended for use by the general public as applicants, participants, customers, clients, or visitors. Establishes exceptions.

[HB325](#) – Relating to Medical Cannabis. Prohibits an employer from discriminating against a person in hiring, termination, or any term or condition of employment based on the person's status as a medical cannabis registry card holder, under certain conditions. Authorizes an employer to use a fit-for-duty test for medical cannabis qualifying patients in potentially dangerous occupations. Exempts certain occupations.
 - B. Communication Access

[SB1371](#) – Relating to the Universal Service Program. Clarifies that the Public Utilities Commission under the Universal Service Program may provide, and may use funds from the Universal Service Fund to provide, free telecommunications access to certain individuals with a print disability.

C. Service and Other Animals

D. Building Code, Design, and Facility Access

[SB160](#) – Relating to Mental Health. Requires the Department of Health to construct a mental health facility for inmates or detainees with mental health needs in the custody of the Department of Corrections and Rehabilitation. Appropriates moneys.

[SB230](#) – Relating to Electric Vehicle Charging Infrastructure. Requires that if parking is to be included in any new state building construction, the design provide that at least twenty-five per cent of parking stalls be electric vehicle charger-ready. Requires the Hawai'i State Energy Office, in consultation with the Department of Accounting and General Services and the Department of Transportation, to conduct a survey and identify certain high-priority state facilities. Establishes a goal of the State to retrofit state facilities to be electric vehicle charger-ready. Requires a report to the Legislature. Appropriates funds.

[SB415](#) – Relating to Trail Accessibility. Establishes the Accessible Wilderness and State Parks Trails Program within the Division of State Parks of the Department of Land and Natural Resources. Establishes the Accessible Wilderness and State Parks Trails Program Special Fund. Requires reports to the Legislature. Appropriates funds.

[SB718](#) – Relating to Equity. Requires all places of public accommodation and public entity constructions constructed after 7/31/2026, to provide universal changing accommodations that are equally accessible regardless of gender.

[HB346](#) – Relating to Electric Vehicle Charging Infrastructure. Provides rebates for the installation of eligible electric vehicle-ready parking stalls for new construction of affordable housing.

[HB868](#) – Relating to Disabilities. Requires the Department of Land and Natural Resources to evaluate its facilities for compliance with the Americans with Disabilities Act and compile a list of non-compliant facilities. Requires report to the Legislature.

E. Community Based Services and Employment

[SB32](#) – Relating to the Psychological Interjurisdictional Compact. Adopts the Psychology Interjurisdictional Compact to regulate the practice of telepsychology and temporary in-person, face-to-face practice of psychology by psychologists across state boundaries in the performance of their

psychological practice. Requires the Department of Commerce and Consumer Affairs to adopt rules to implement and administer the Compact.

[SB34](#) – Relating to Mental Health. Requires the Department of Education to identify an absence due to the mental health of a student as an excused absence. Defines the term "excused absence". Exempts an absence due to the mental health of a student from the enforcement of penalties relating to compulsory attendance at school. Limits the number of excused absences that may be taken by a student due to mental health reasons.

[SB37](#)- Relating to Mental Health. Beginning with the 2025-2026 school year, requires all public and private schools that serve students in grades 6 through 12 and issue student identification cards to have information on mental health and suicide prevention hotlines printed on the student identification cards. Establishes exceptions and penalties.

[SB49](#) – Relating to Terminal Illness. Authorizes manufacturers of investigational drugs or biological products that are pending approval by the United States Food and Drug Administration to make the drugs or products available to terminally ill patients under certain conditions. Effective 1/1/2026.

[SB64](#) – Relating to Education. Beginning with the 2027-2028 school year, requires each public school in the State, including charter schools, to employ, or retain under contract, at least 1 mental health professional for every 250 students enrolled, subject to certain conditions. Requires the Department of Education to submit a progress report to the Legislature no later than 20 days prior to the convening of the Regular Session of 2026. Appropriates moneys for the Department of Education to contract for mental health professionals and to establish an unspecified number of full-time equivalent mental health professional positions within the Department of Education. Declares that the general fund expenditure ceiling is exceeded.

[SB87](#) – Relating to Mental Health at the University of Hawaii. Appropriates funds to the University of Hawai'i at Manoa to establish three additional permanent mental health practitioner positions within the Division of Student Success' Counseling and Student Development Center.

[SB642](#) – Relating to Insurance. For policies, contracts, plans, and agreements issued or renewed after 12/31/2025, requires the insurers, mutual benefit societies, and health maintenance organizations to provide coverage for standard fertility preservation services for persons undergoing medically necessary treatment that may cause iatrogenic infertility.

[SB648](#) – Relating to Department of Health. Requires the Developmental Disabilities Division of the Department of Health to amend its eligibility criteria for the home and community-based services Medicaid waiver to include individuals having an intellectual or a developmental disability and a comorbid mental illness. Appropriates funds.

[SB720](#) – Relating to Workers Compensation. Requires the independent medical examination and permanent impairment rating examination of an injured employee under the Workers' Compensation Law to be conducted by a qualified physician selected by the mutual agreement of the parties and paid for by the employer. In absence of a mutual agreement, requires the Director of Labor and Industrial Relations to appoint a duly qualified impartial physician to be paid by the employer.

[SB880](#) (companion [HB705](#)) – Relating to Executive Office on Aging Establishes a temporary Medi-Medi Project within the Hawai'i State Health Insurance Assistance Program administered by the Executive Office on Aging to assist older adults, Medicare beneficiaries, individuals with disabilities, and other underserved populations who may qualify for various low-income subsidy programs to gain access to their benefits. Requires the Executive Office on Aging to submit reports to the Legislature. Appropriates funds.

[SB1001](#) – Relating to Education. Requires the Department of Education to implement dyslexia sensitive universal screenings and evidence-based interventions, offer professional development on structured literacy and evidenced-based interventions, and support pre-teacher programs in training candidates in structured literacy instruction.

[SB1389](#) – Relating to Therapy Services. Expands the scopes of practice for occupational therapists, physical therapists, and speech pathologists to allow those professionals working for or contracted by the Department of Education to diagnose medical conditions that can be treated with their respective services.

[SB1392](#) – Relating to Education. Requires the Department of Education to implement dyslexia-sensitive universal screenings, provide evidence-based interventions, and offer professional development on dyslexia and structured literacy.

[SB1445](#) – Relating to Youth Mental Health. Establishes a two-year digital youth mental health platform pilot project under which the child and adolescent mental health division of the department of health develops and makes publicly available a digital platform providing tools and resources designed to help young people address and manage mental health challenges.

[HB11](#) – Relating to Healthcare. Eliminates the certificate of need requirement for all health care facilities and health care services except for nursing homes, hospices, intermediate care facilities for individuals with intellectual disabilities, and ambulance service providers.

[HB13](#) – Relating to Workers Compensation. Establishes notice requirements for employers under Hawai'i's Workers' Compensation Law. Requires employers who deny the compensability of an employee's injury to submit a written report supporting the denial to the Director of Labor and Industrial Relations within a specified period. Requires employers to furnish to the

injured employee up to \$10,000 for medical care, services, and supplies for the period immediately following the injury and so long as reasonably needed or until the employer files a written report with the Director denying the compensability of the injury, whichever is earlier. Clarifies that failure to give an employer notice of an employee's injury does not bar a claim for compensation if any person having authority in the interest of the employer had knowledge of the injury.

[HB185](#) – Relating to Care Homes. Prohibits the licensing of an adult residential care home, expanded adult residential care home, or developmental disabilities domiciliary home that is financed, managed, operated, supervised, directed, or owned in whole or in part by a person convicted of a gambling offense.

[HB245, HD1](#) – Relating to Student Heat Exposure Study. Requires the Department of Education, in collaboration with the Department of Health, and State Charter School Commission, to conduct a study on the current practices of managing heat exposure in state public and charter schools to protect students' health during outdoor activities and to develop a plan if the current practices are insufficient in managing heat exposure. Effective 7/1/3000.

[HB302, HD1](#) – Relating to Cannabis. Repeals the requirement that a provider-patient relationship be established in person. Allows applicants or primary caregivers to temporarily purchase medical cannabis after the submission of the applicant's certification form. Effective 7/1/3000

[HB687](#) – Relating to the Supplemental Nutrition Assistance Program. For the Supplemental Nutrition Assistance Program, requires the Department of Human Services to: (1) prorate or exclude certain income from household members who are ineligible for the Program; (2) establish a standardized medical expense deduction option for elderly or disabled household members; (3) establish a pre-release Program application form for individuals who are incarcerated and scheduled for release; and (4) report to the Legislature. Specifies that, for purposes of the Supplemental Nutrition Assistance Program, the federal restriction of providing Program benefits to certain individuals does not apply in Hawaii.

[HB695](#) – Relating to Paid Family Leave. By 1/1/2027, requires the Department of Labor and Industrial Relations to establish a family and medical leave insurance program and begin collecting payroll contributions to finance payment of benefits. By 1/1/2028, requires the Department to start receiving claims and paying benefits under the program. Specifies eligibility requirements and employee protections under the program.

[HB725](#) – Relating to Medicaid. Appropriates funds to increase the funding of certain Medicaid home and community-based services, including adult day programs and residential services offered in community care foster family homes and expanded adult residential care homes.

[HB115](#) – Relating to Driving Under the Influence. Requires defendants convicted of causing the death or disability of a parent or legal guardian of a minor child by the operation of a vehicle while under the influence of an intoxicant to make restitution in the form of financial support to each child of the victim.

[HB551](#)- Related to Care Homes. Increases the state supplemental payment ceilings for type I adult residential care homes, licensed developmental disabilities domiciliary homes, community care foster family homes, certified adult foster homes, and type II adult residential care homes.

[HB903, HD1](#) – Relating to Student Health. Authorizes a school to maintain a stock supply of bronchodilators to be administered under certain conditions. Authorizes certain employees of a school and department personnel to administer certain medication in emergency situations, under certain conditions. Amends prescription drug labeling requirements to include certain information related to a school, if applicable. Effective 7/1/3000.

[HB1131](#) – Relating to an Intensive Mobile Team Pilot Program for Houseless Individuals Suffering from Serious Brain Disorders. Establish a pilot program in the Department of Health to provide intensive mobile treatment-type services, e.g., "street psychiatry," to chronically houseless people suffering from serious brain disorders like schizophrenia and schizoaffective disorder.

F. Transportation and Mobility

[SB1008](#) – Relating to Parking. Authorizes the counties to adopt ordinances to enforce the accessible parking space requirements for parking spaces reserved for persons with disabilities and electric vehicles.

[SB1446](#) – Relating to Parking for Disabled Persons. Authorizes each county to enact ordinances to enforce the design and construction requirements for the provision of accessible parking spaces, including the establishment of penalties for failure to comply with the ordinances.

[SB1492](#) – Relating to Mobility Management. Appropriates funds to the Department of Transportation to implement the recommendations of the Task Force on Mobility Management, established pursuant to Act 214, SLH 2013, in consultation with the Aging and Disability Resource Center of the Executive Office on Aging and other stakeholder groups.

[HB59](#) – Relating to Disabled Veterans. Exempts qualifying disabled veterans from county vehicle registration fees, highway beautification fees, and vehicle weight taxes.

[HB469](#) – Relating to Parking for Disabled Persons. Requires the Disability and Communication Access Board to issue a disability travel placard to an applicant who has a valid removeable windshield placard and provides proof of travel. Effective 7/1/2027.

[HB517](#) – Relating to Restoring Respect and Dignity to America’s Only Royal Palace in the Nation. Prohibits parking of motor vehicles on the grounds of Iolani Palace. Requires DAPS to remove the blacktop, parking area, and paid parking adjacent to Iolani Palace. Requires DLNR to develop and maintain a pedestrian area adjacent to Iolani Palace. Requires DAPS and DLNR to report on cost analysis.

[HB657](#) – Relating to Disabled Veterans. Exempts disabled veterans from the State's vehicle weight tax and repeals the exemption for disabled veterans from the State's annual vehicle registration fee.

[HB733](#) - Relating to Electric Vehicle Parking. Removes the exemption that allowed owners of multiple parking facilities within the State to designate and electrify fewer parking spaces than required in one or more of the properties if the requirement for the total number of aggregate spaces on all of their owned properties was met. Authorizes the counties to adopt ordinances to regulate electric vehicle charging systems for places of public accommodation with fewer than one hundred parking spaces.

[HB1127](#) – Relating to Parking for Disabled Persons. Authorizes each county to enact ordinances to enforce the design and construction requirements for the provision of accessible parking spaces, including the establishment of penalties for failure to comply with the ordinances.

[HB1471](#) – Relating to Transportation. Requires and appropriates funds for the Department of Transportation to install traffic actuated signals, including leading pedestrian intervals and accessible pedestrian signals and detectors. Imposes an additional fee of \$5 for a certificate of registration for motor vehicles, to be deposited into the Safe Routes to School Program Special Fund.

G. Emergency Management

[SB239](#) – Relating to Disaster Preparedness. Requires all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

[HB358](#) – Relating to Disaster Preparedness. Requires all public buildings, including public school buildings, constructed after January 1, 2026, to be designed to withstand category five hurricanes and be used as shelters in the event of an emergency.

H. Administration

[SB1253](#) – Relating to Boards and Commissions. Clarifies that the prohibition against board and commission holdover members from holding office beyond the end of the second regular legislative session following the expiration of the member's term of office takes precedence over any conflicting statutes.

[SB1255](#) - Relating to Government Records. Clarifies that government records subject to disclosure requirements under the Uniform Information Practices Act include information that is created, received, maintained, or used by private contractors in performance of a government function outsourcing contract. Establishes requirements for parties to government function outsourcing contracts. Establishes civil penalties. Requires reports to the Legislature. Allows the Office of Information Practices to conduct inquiries regarding compliance by a private contractor and investigate possible violations.

[SB1422](#) – Relating to Non-General Funds of the Department of Health. Repeals the birth defects special fund and deposits a portion of fees for certified copies and marriage licenses into the vital statistics improvement special fund.

I. Other

[HB636](#) – Relating to Capital Improvement. Establishes a school capital improvement project modernization initiative in the School Facilities Authority to create a planning database for school facilities. Appropriates funds.



I. Chairperson Violet Horvath called the meeting to order at 11:05 a.m.

II. Committee members, staff, and public participants introduced themselves.

III. Bills and Resolutions

- A. [SB1496](#) – Relating to Civil Rights. Establishes that it is an unlawful discriminatory practice for places of public accommodation to deny a person with a disability full and equal enjoyment of information related to their services, facilities, privileges, advantages, or accommodations using information and communication technology intended for use by the general public as applicants, participants, customers, clients, or visitors. Establishes exceptions.

Kirby Shaw explained that the bill aligns with recent U.S. Department of Justice (DOJ) regulations requiring state and county websites and mobile apps to be accessible to people with disabilities. The bill holds private entities accountable for website and app accessibility, as the DOJ has not yet enforced it. The Committee discussed the bill's lack of enforcement mechanisms and penalties but acknowledged its importance in civil rights.

Peter Fritz raised concerns about the bill's jurisdiction and its potential to be enforced similarly to the ADA.

MOTION: MONITOR (M/S/P Horvath/Townsend)

- B. [HB325](#) – Relating to Medical Cannabis. Prohibits an employer from discriminating against a person in hiring, termination, or any term or condition of employment based on the person's status as a medical cannabis registry card holder, under certain conditions. Authorizes an employer to use a fit-for-duty test for medical cannabis qualifying patients in potentially dangerous occupations. Exempts certain occupations.

Discussion focused on caregiver protections within the medical cannabis bill. Committee member Charlotte Townsend, raised concerns about caregivers, whose names appear on medical cannabis cards, facing workplace discrimination despite not being users themselves. Elizabeth Pearson clarified that the bill includes protections for caregivers, ensuring they comply with the requirements of the medical cannabis program. Chairperson Violet Horvath suggested the issue might require further coordination with the Hawaii Civil Rights Commission, which has been addressing updates to regulations on disability discrimination and accommodations. Peter Fritz, recommended that DCAB engage with other agencies to align positions on the matter.

MOTION: MONITOR (M/S/P Horvath/Akamine)

- C. [HB346](#) – Relating to Electric Vehicle Charging Infrastructure. Provides rebates for the installation of eligible electric vehicle-ready parking stalls for new construction of affordable housing.

Bryan Mick noted that DCAB may want to monitor electric vehicle (EV) bills due to the pending final rule from the U.S. Access Board, which will include requirements for accessible EV charging stations.

MOTION: MONITOR (M/S/P Horvath/Townsend)

- D. [SB49](#) – Relating to Terminal Illness. Authorizes manufacturers of investigational drugs or biological products that are pending approval by the United States Food and Drug Administration to make the drugs or products available to terminally ill patients under certain conditions. Effective 1/1/2026

Chairperson Violet Horvath inquired about the conditions for administering investigational drugs to terminally ill patients under the bill. Elizabeth Pearson explained that the bill applies to patients who have exhausted all treatment options, cannot join a clinical trial, have a recommendation from their healthcare provider, and provide informed consent. It excludes patients receiving inpatient care at regulated facilities.

MOTION: MONITOR (M/S/P Horvath/Akamine)

- E. [SB642](#) – Relating to Insurance. For policies, contracts, plans, and agreements issued or renewed after 12/31/2025, requires the insurers, mutual benefit societies, and health maintenance organizations to provide

coverage for standard fertility preservation services for persons undergoing medically necessary treatment that may cause iatrogenic infertility.

MOTION: MONITOR (M/S/P Townsend/Horvath)

- F. [SB880](#) (companion [HB705](#)) – Relating to Executive Office on Aging. Establishes a temporary Medi-Medi Project within the Hawai'i State Health Insurance Assistance Program administered by the Executive Office on Aging to assist older adults, Medicare beneficiaries, individuals with disabilities, and other underserved populations who may qualify for various low-income subsidy programs to gain access to their benefits. Requires the Executive Office on Aging to submit reports to the Legislature. Appropriates funds.

Bryan Mick explained that the bill aims to assist low-income individuals by reducing out-of-pocket costs and includes three goals: developing a community outreach program, streamlining the application process for subsidy programs, and providing services to help underserved populations access benefits.

MOTION: SUPPORT (M/S/P Horvath/Akamine)

- G. [SB1445](#) – Relating to Youth Mental Health. Establishes a two-year digital youth mental health platform pilot project under which the child and adolescent mental health division of the department of health develops and makes publicly available a digital platform providing tools and resources designed to help young people address and manage mental health challenges.

Committee member Charlotte Townsend raised concerns about the digital platform's accessibility, particularly regarding internet access. Elizabeth Pearson noted it could be a cost-effective, inclusive solution, especially for youth without devices. Peter Fritz, suggested consulting the State Council on Mental Health for more background, mentioning the potential issues for people with hearing impairments.

MOTION: MONITOR (M/S/P Horvath/Townsend)

- H. [HB245](#), HD1 – Relating to Student Heat Exposure Study. Requires the Department of Education, in collaboration with the Department of Health, and State Charter School Commission, to conduct a study on the current practices of managing heat exposure in state public and charter schools to protect students' health during outdoor activities and to develop a plan if the current practices are insufficient in managing heat exposure. Effective 7/1/3000.

Elizabeth Pearson noted that many disabilities involve heat sensitivity, and applying the measure to all students would ensure those with such needs are automatically protected. Chairperson Violet Horvath questioned whether the State had studied outdoor heat exposure. Committee member Charlotte Townsend noted athletic groups already have protocols and expressed concern about duplicating efforts. Chairperson Violet Horvath agreed but wondered if schools are following best practices. Elizabeth Pearson shared

that, based on prior testimony, the Department of Education sees the study as a step toward long-term implementation.

MOTION: MONITOR (M/S/P Horvath/Kozai)

- I. [HB302](#) HD1 – Repeals the requirement that a provider-patient relationship be established in person. Allows applicants or primary caregivers to temporarily purchase medical cannabis after the submission of the applicant's certification form. Effective 7/1/3000. (HD1)

Bryan Mick noted that people with mobility-related disabilities, especially those who are homebound, could benefit from the bill. Kirby Shaw added that the bill could help people who are severely ill, like those with cancer, by allowing someone else to access cannabis for them. Elizabeth Pearson clarified that the bill would repeal the in-person requirement for establishing the provider-patient relationship.

MOTION: MONITOR (M/S/P Horvath/Townsend)

- J. [HB903](#) HD1 – Relating to Student Health. Authorizes a school to maintain a stock supply of bronchodilators to be administered under certain conditions. Authorizes certain employees of a school and department personnel to administer certain medication in emergency situations, under certain conditions. Amends prescription drug labeling requirements to include certain information related to a school, if applicable. Effective 7/1/3000

Committee member Charlotte Townsend expressed concerns about liability and the need for clear definitions of who can administer medication in schools. Chairperson Violet Horvath emphasized clarity, particularly for emergency medications. Elizabeth Pearson clarified that only trained personnel would administer medication, and the bill does not equate to medical practice. Peter Fritz-stated the bill focuses on legal protections for schools, not disability rights, and falls outside of DCAB's mission. Kirby Shaw noted it could still relate to disabilities, like asthma, under the ADA. Committee member Charlotte Townsend was concerned about stockpiling medication. Elizabeth Pearson explained it could prevent further disability issues.

MOTION: MONITOR (M/S/P Horvath/Townsend)

- K. [SB1008](#) – Relating to Parking. Authorizes the counties to adopt ordinances to enforce the accessible parking space requirements for parking spaces reserved for persons with disabilities and electric vehicles.

The Committee discussed that SB1008 and SB1446 are very similar bills, with only slight variances. They agreed to support both, with a preference for SB1008.

MOTION: SUPPORT (M/S/P Horvath/Townsend)

- L. [SB1446](#) – Relating to Parking for Disabled Persons. Authorizes each county to enact ordinances to enforce the design and construction requirements for

the provision of accessible parking spaces, including the establishment of penalties for failure to comply with the ordinances.

MOTION: SUPPORT (M/S/P Horvath/Townsend)
