Testimony or comments presented by members of the public during the Committee meetings shall be limited to three minutes per agenda item. In compliance with the Americans with Disabilities Act (ADA), a reasonable amount of additional time shall be afforded to persons with a communication disability to present testimony or comments, if needed. Any person who needs additional time to present testimony or comments is encouraged to contact the DCAB office in advance of the meeting. This rule shall be placed at the beginning of all Committee meeting agendas.

Members of the public may present comment or testimony during Committee meetings on each agenda item. Public comment or testimony, if any, shall be presented on each agenda item before the Committee deliberates on the item. After all public comment or testimony is presented, the Committee shall deliberate on the agenda item without further comment or testimony from the public unless further public comment or testimony is requested by the Committee.

 - A. [Senate Bill 1008](#) House Draft 1 Conference Draft 1 - Relating to Parking. Authorizes the counties to adopt ordinances to enforce the accessible parking space requirements for parking spaces reserved for persons with disabilities and electric vehicles.
 - B. Bill 2026-0016 HB HMSO-1 - Relating to Parking. Prohibits the issuance of a citation for encroachment into an access aisle by a vehicle with a disability parking permit unless an oral complaint is made to a law enforcement officer or 911 dispatcher by a person who also has a valid

disability parking permit and whose access was directly impeded. Requires a law enforcement officer to verify the validity of the complainant's disability parking permit before issuing a citation.

- C. [HB 469](#) – Relating to Parking for Disabled Persons. Requires the Disability and Communication Access Board to issue a disability travel placard to an applicant who has a valid removeable windshield placard and provides proof of travel.
- D. Potential bill to amend §291-55 Parking fees for Disabled Paid Parking Exemption Permit's exemption period from first two-and-a-half hours or the maximum amount of time the meter allows whichever is longer to four and a half hours.
- E. Potential bill to increase the mandated number of accessible spaces at ADA Title II and/or Title III covered parking lots.
- F. Potential bill to amend Chapter 291 Part III, HRS: Parking for Disabled Persons eligibility for a disability parking permit to include persons who are deaf and blind.
