I. Chairperson Summer Kozai called the meeting to order at 10:03 a.m.

- II. Chairperson Summer Kozai reported no written public testimony was submitted.
- III. The Committee approved the July 10, 2024 meeting minutes (M/S/P Horvath/Ohta).

IV. Old Business

A. Parking Placard Issuance Statistics

Bryan Mick reported that in the first two (2) months of fiscal year 2024-2025, around five thousand five hundred (5,500) placards were issued. Two hundred fifty (250) special license plates were reauthorized or issued. Of the placards, about one thousand four hundred (1,400) were temporary and four thousand (4,000) were long term. DCAB issued one thousand seven hundred (1,700) long term placards and eighteen (18) Disabled Paid Parking Exemption Permits (DPPEP). The placard renewal rate was seventy two percent (72%).

B. Email Notification to Permittees of Pending Parking Permit Expirations

Bryan Mick reported that in the first two (2) months of fiscal year 2024-2025, DCAB emailed one thousand two hundred ninety-two (1,292) permittees to notify them of their pending permit expirations. Applications were attached to the emails.

C. Procurement of Parking Placards and Decals

The procurement process for month and year decals has begun.

D. Death Records Crossmatch and Parking Permit Retrieval

Four thousand three hundred sixty five (4,365) death retrieval letters were sent out to the estates of permittees to retrieve the placards. Thirty-six percent (36%) of the placards were returned to DCAB.

E. <u>Public Education Efforts</u>

Webpage for Reporting Placard or Access Aisle Abuse

Four (4) inquiries were submitted through the DCAB webpage to report abuse of a disability parking permit. Two (2) letters were sent to permittees as a result.

Webpage for Reporting Non-Design Compliant Accessible Spaces

Four (4) submissions were made to the webpage on a non-design compliant parking space issue. DCAB sent one inquiry to Windward Mall and the Target store, who both replied that they would investigate and correct the situation.

Meeting with Spectrum – Television Public Service Announcements

Spectrum contacted DCAB to gauge our interest in airing television public service announcements (PSA). Several Department of Health agencies and programs such as the Newborn Safe Sleep Infant Project and the Fetal Alcohol Prevention Program have used Spectrum to create PSAs. Bryan Mick met with Spectrum and requested a quote. The Committee expressed their support for staff pursuing this effort.

Disabled Paid Parking Exemption Permit Public Service Announcement

DCAB ran a print PSA in "Midweek" for the week of August 7, 2024. The PSA reminded readers about the end of the meter fee exemption for temporary and long term placards.

F. Van Accessible Spaces

<u>Voluntary Informational Sign for Van Accessible Spaces at Places of Public Accommodation</u>

Kirby Shaw is reviewing the press release about the informational sign. The press release will be sent to the Department of Health's (DOH) Pubic Information Officer for distribution.

<u>Letter to Retail Merchants Association of Hawaii and Chamber of</u> Commerce

Kirby Shaw is reviewing the draft letter to the Retail Merchants Association of Hawaii and to the Chamber of Commerce.

G. State Capitol Building, Parking, and Accessibility Concerns

Bryan Mick shared a revised draft letter to state officials listing multiple accessibility concerns that DCAB staff observed last legislative session. Staff attended a bill signing ceremony in the Governor's Office and discovered that the ceremonial desk is arranged such that anyone using a mobility device is unable to go behind the desk and participate in the ceremony and photo. This issue was added to the letter.

V. New Business

A. Meetings with Parking Enforcement Agencies

Staff met with the Hawaii State Department of Land and Natural Resource's Division of Conservation and Resources Enforcement (DOCARE) Chief to discuss parking enforcement efforts. DOCARE will remind its officers that citations should be issued for violation of accessible parking spaces even if not on DOCARE property.

A meeting with the City and County of Honolulu's Police Chief is pending.

B. <u>Electric Vehicle License Plates and Disability Plates</u>

The Department of Transportation inquired with DCAB about a license plate design that depicts both an electric vehicle designation and a disability symbol. Bryan Mick informed them there is no such license plate in the State of Hawaii.

Possible State Legislation

Bryan Mick shared three (3) DCAB bills that may be included in the Governor's 2025 package: (1) Sharing fines for accessible parking space violations using the existing state highway enforcement program surcharge as a model, (2) authorizing the Counties to enforce design guidelines for accessible parking spaces, and (3) establishing a disability parking travel placard for Hawaii residents to use when traveling off island.

C. <u>United States Architectural and Transportation Barriers Compliance Board Notice of Proposed Rulemaking – Accessibility of Electric Vehicle Charging Stations</u>

A brief discussion was held, and the topic will be discussed at the DCAB full Board on September 26, 2024.

I. Chairperson Summer Kozai called the meeting to order at 11:01 a.m.

- II. Chairperson Summer Kozai reported no written public testimony was submitted.
- III. The Committee approved the October 3, 2024, meeting minutes as circulated (M/S/P Ohta/Horvath). The September 13, 2024, meeting minutes were deferred.

IV. Old Business

A. Parking Placard Issuance Statistics

Bryan Mick reported that, around eight thousand (8,000) placards were issued. Four hundred (400) special license plates were reauthorized or issued. Of the placards, about two thousand two hundred (2,200) were temporary and five thousand nine hundred (5,900) were long term. DCAB issued two thousand five hundred (2,500) long term placards and thirty two (32) Disabled Paid Parking Exemption Permits (DPPEP). The placard renewal rate was seventy two percent (72%).

B. <u>Email Notification to Permittees of Pending Parking Permit Expirations</u>

For the third quarter of fiscal year 2023-2024, DCAB emailed one thousand two hundred ninety two (1,292) permittees to notify them of their pending permit expirations.

C. Procurement of Parking Placards and Decals

DCAB received 140,000 month and year decals.

D. Death Records Crossmatch and Parking Permit Retrieval

Four thousand (4,000) death record of permitees were flagged by the Department of Health's Vital Records section. DCAB will update the database and mail retrieval letters with pre-paid envelopes to the estates of deceased permittees to retrieve the placards. The goal is to have the letter ready to mail in January.

E. Public Education Efforts

Webpage for Reporting Placard or Access Aisle Abuse

Four (4) inquiries were submitted through the webpage to report abuse of a disability parking permit. Two (2) letters were sent to permitees.

Webpage for Reporting Non-Design Compliant Accessible Spaces

Five (5) submissions were made to the webpage on a non-design compliant parking space.

Meeting with Television Public Service Announcement Providers

Staff met with several television stations about the possibility of producing and airing a public service announcement (PSA) on accessible parking.

Updating Posters for Issuing Locations

Staff observed several County issuing locations displaying an old poster designed by DCAB regarding how to renew a long term placard. Staff updated the poster design and will ask the issuing locations and other places if they can display it.

F. Van Accessible Spaces

<u>Voluntary Informational Sign for Van Accessible Spaces at Places of Public Accommodation</u>

Kirby Shaw is still reviewing the draft press release about the informational sign.

Letter to Retail Merchants of Hawaii

Kirby Shaw is ready to send the letter to the Retail Merchants Association requesting additional accessible and van accessible parking spaces that exceed the ADA minimums, voluntary installation of the priority for side ramp or lift signs, and a self-inspection to verify their current accessible parking spaces for compliance with federal and state design requirements.

G. State Capitol Building, Parking, and Accessibility Concerns

The letter was submitted to the Department of Health's Director along with a request to submit it to the Governor and Legislative leadership.

H. <u>United States Architectural and Transportation Barriers Compliance Board Notice of Proposed Rulemaking – Accessibility of Electric Vehicle Charging Stations – Update Draft Legislation</u>

Staff submitted testimony on behalf of the Board, the deadline was November 4, 2024.

I. Possible State Legislation

Counties to enforce accessible parking space design

This bill will allow counties to enforce accessible parking space design requirements at places of public accommodation and will provide a local enforcement mechanism when people observe non-compliant accessible parking spaces.

Travel Placard

This bill will allow someone with an existing parking permit to obtain a second parking permit for travel and the parking permit would expire the last day of the month following their return travel date.

Related to Parking for Disabled Persons

The bill would impose an additional surcharge or fine for violations of Hawaii Revised Statutes (HRS), Chapter 291, Part III and remit fifty percent (50%) to the police department in the county where the violation occurred.

V. New Business

A. Meeting with Parking Enforcement Agencies

In an effort to increase enforcement of accessible parking laws, Kirby Shaw and Bryan Mick have meet with the Hawaii Department of Law Enforcement and the Department of Land and Natural Resources as both Departments have uniformed officers who issues citations. Staff is still trying to meet with the Honolulu Police Chief.

B. <u>Concerns With Medical Facilities That Only Accept Parking</u> Payments VIA Smartphones

Staff received a complaint about a private parking lot serving a medical building that only accepts parking payment via an app. The concern is many older people do not have smart phones and are therefore unable to make payment. This policy does not appear to violate the ADA, although reasonable modifications might be required on a case by case basis. However, the Office of Aging might introduce a bill requiring alternate forms of payment be accepted as their constituency is highly impacted by an app only payment system.

VI. Open Forum

A discussion was held on the Daniel K. Inouye International Airport interisland reserved accessible parking spaces where it occurs able construction workers enroute to the neighbor islands are using permits which may not belong to them. Committee members would love for an enforcement agency to be present in the morning or afternoon when they all return and ask them to produce the identification card establishing that the placard was issued to them. Staff will follow up with the airport and police.

VII. Next Meeting

The next meeting is scheduled for Wednesday, January 13, 2025, at 12:00 p.m.

VIII. Adjournment

The meeting adjourned at 11:51 a.m.

PARKING COMMITTEE REPORT

January 2025

The parking committee met on January 13, 2025.

Parking Program Issuance and Statistics – Update

In the second quarter of FY 2024-2025, around 8,000 placards were issued and 350 special license plates reauthorized or issued. Of the placards, about 2,200 were temporary, 5,600 long term, and 23 were Disabled Paid Parking Exemption Permits. Of the long-term placards, about 2,400 were renewals issued by DCAB. The renewal rate was 68 percent.

Other Parking Activities from the Plan of Action

In the second quarter of the Fiscal Year:

2,084 emails were sent reminding permitees of a pending permit expiration.

Procurement of 23,000 temp and long term placards has begun.

A crosscheck with Vital Record flagged 3,700 records.


3 submissions were received via the webpage to report parking placard misuse and two letter were sent.

7 submissions were received via the webpage to report a non-design complaint space. One follow up with a business was conducted to confirm they had a design compliant accessible space which had been moved.

Staff met with the new Corporal in charge of Honolulu's Volunteer Special Enforcement Officer Program and is in the process of scheduling a meeting with a Deputy Police Chief to discuss the program.

Staff sent the Retail Merchants Association and the Chamber of Commerce a letter DCAB previously sent directly to large parking lot owners requesting they increase the number of accessible parking spaces and asked them to share it with their members.

There are three bills under review for possible submission that would impact the parking program. (1) Creates a travel placard for Hawaii residents to use when travelling (2) Authorizes the counties to enforce accessible parking design requirements (3) Establishes a special accessible parking space violation fine and remits 50 percent of the surcharge to the county police.

Disability parking permit application form PA3 is available at county issuing agencies, the Disability and Communication Access Board, most medical facilities, by calling (808) 586-8121, or online at http://health.hawaii.gov/dcab/.

Take the application form to your LICENSED PRACTICING PHYSICIAN, PHYSICIAN ASSISTANT (PAC) or ADVANCED PRACTICE REGISTERED NURSE (APRN) and have them complete SIDE TWO. Make sure they sign, date, and fill in their medical license number. Complete side one before submitting.

If you were certified for:

- 1. Six month (red) temporary placard; or
- 2. Six year (blue) long term placard for the first time

You must submit the form to a county issuing agency: Satellite City Hall (City and County of Honolulu), Office of Aging (County of Hawaii), Division of Motor Vehicles and Licensing (County of Maui), Division of Motor Vehicles (County of Kauai).





If you were certified for:

- 1. A renewal of a six year (blue) long term placard; or
- 2. A Disabled Paid Parking Exemption Permit (green) placard*



HONOLULU, Hawai'i – The Disability and Communication Access Board (DCAB), Hawai'i Department of Health, has introduced a new voluntary sign for use at reserved van-accessible parking spaces. This sign is intended for state and local governments, as well as private businesses, to place in spaces designated for van-accessible parking. It highlights that priority for these spaces should be given to side ramp or lift equipped vehicles (SRLVs).

Van-accessible parking spaces are designed to accommodate SRLVs, which require additional space to safely deploy their ramps or lifts. These spaces are typically 8 feet wide, with an extra 3 feet of width either in the parking space itself or the adjacent access aisle. According to the Americans with Disabilities Act (ADA), 1 in every 6 accessible parking spaces in a parking facility must be designated as van accessible. While these spaces can be used by any vehicle displaying a valid disability parking permit, regardless of whether it has a side ramp or lift, the spaces are critical for SRLVs. When these spaces are occupied by non-SRLVs, individuals with SRLVs are unable to park, exit their vehicle, or access their destination.

"Vehicles without side ramps or lifts parking in van-accessible spaces, especially when standard accessible spaces are available, is one of the most common complaints we receive from SRLV permit holders," said DCAB Executive Director Kirby Shaw. "Our goal is to encourage those who can use standard accessible parking to do so, thereby keeping van-accessible spaces open for those who need them. This initiative is part of our 'Park with Aloha' campaign, which aims to improve Hawaii's parking program for individuals with disabilities."

Last year, the Disability and Communication Access Board (DCAB) mailed the attached letter to several hundred places of public accommodation as defined under Title III of the Americans with Disabilities Act (ADA). These businesses had previously been identified as having parking lots with 100 or more total parking spaces. We wanted to request your assistance in forwarding the letter to your members as some of them may not have been on that mailing list.

The letter contains three requests. We are asking them to provide additional accessible and van accessible parking spaces in excess of the ADA required minimums. We have included a suggested chart. We are asking that locations with two or more accessible parking spaces voluntarily install our "priority for vehicles with a side ramp or lift" sign on their van accessible spaces. And finally, we are requesting that existing accessible parking spaces are checked to make sure they are in compliance with federal and state design requirements and best practices.

We have also attached an image depicting how the voluntary "priority for vehicles with a side ramp or lift" sign on their van accessible spaces would appear once installed.

Any assistance you can provide by circulating the letter to your membership would be greatly appreciated.



(Pillar impedes access)




(Space is not connected to an accessible route)

(Ideal design for van accessible spaces if a parking lot has multiple accessible spaces which share an access aisle)



Last year, the Disability and Communication Access Board (DCAB) sent the attached letter to several hundred places of public accommodation, as defined under Title III of the Americans with Disabilities Act (ADA). These businesses were identified as having parking lots with 100 or more parking spaces. We are reaching out to request your assistance in forwarding this letter to your members as some may not have received it in the original mailing.

The letter includes three key requests: first, we are asking businesses to provide additional accessible and van-accessible parking spaces beyond the ADA-required minimums, with a suggested chart for reference; second, for locations with two or more accessible parking spaces, we are requesting the voluntary installation of our "priority for vehicles with a side ramp or lift" sign on their van-accessible spaces; and third, we are asking that existing accessible parking spaces be reviewed to ensure they meet federal and state design requirements, as well as best practices.



(Pillar impedes access)




(Space is not connected to an accessible route)

(Ideal design for van accessible spaces if a parking lot has multiple accessible spaces which share an access aisle)



Accessibility Concerns with the Hawaii State Capitol Building

During the 2024 legislative session, the Disability and Communication Access Board (DCAB) identified several accessibility concerns reported by individuals with diverse disabilities. We wish to highlight these issues and remind you that DCAB is available for consultation on accessibility matters.

We have organized the concerns sequentially, from the point of receiving a hearing notice to providing testimony at a hearing.

- Accommodation Requests: The wording on hearing notices should be revised to 1. reflect that requests for accommodations can be made at any time, as stipulated by the Americans with Disabilities Act (ADA) Title II. We recommend the following wording: "If you need an auxiliary aid/service or other accommodation due to a disability, contact [Name] at [phone number and email address]. Requests made as early as possible have a greater likelihood of being fulfilled."
- Agenda Prioritization: Disability-related agenda items should be placed at the beginning of the agenda. This practice will help ensure that scheduled American Sign Language (ASL) interpreters do not exceed their allotted time, thereby avoiding additional costs and ensuring effective communication for those relying on them. It will also assist individuals who need to coordinate pickups with TheHandiVan.

- 3. Website Accessibility: The Legislature's website should be evaluated and updated to meet the Web Content Accessibility Guidelines (WCAG) 2.1 by April 24, 2026, as required by the U.S. Department of Justice. Additionally, we recommend discontinuing the color-coding scheme for submitted testimony, as it is not accessible to individuals with vision impairments. Confirmation of submitted testimony should not require a phone call for those with vision disabilities.
- 4. Accessible Parking: Many have expressed concerns regarding the relocation of public parking from under the Capitol. DCAB strongly advocates for maintaining accessible parking spaces in this area to ensure access for individuals with mobility disabilities. We also request that accessible spaces in the employee parking area comply with ADA Accessibility Guidelines (ADAAG) and be available as reasonable accommodations for qualified employees with disabilities.
- 5. Curb Ramps: Some wheelchair-accessible vehicles are too large and cannot drop off passengers using a wheelchair or scooter at the Capitol basement level, forcing them to use the loading area on South Beretania Street, which lacks curb ramps. DCAB recommends installing curb ramps in this area to enhance accessibility.
- 6. Security Training: We recommend that security personnel receive training on effectively interacting with individuals with various disabilities, as inconsistent procedures were observed during the last session.
- 7. Restroom Accessibility: All public restrooms in the Capitol should be evaluated for accessibility. For example, some paper towel dispensers require a pinching and turning of a wheel, which does not comply with ADAAG. We suggest exceeding ADAAG minimums by including an adult changing table in at least one restroom.
- 8. Automatic Door Openers: We recommend installing automatic door openers on certain hearing room doors. While not mandated by ADAAG, these devices significantly enhance accessibility.
- 9. Captioning on Video Screens: Hearing room video screens should be configured to display captions, as currently, captions are only available on screens outside the hearing rooms, hindering participation for those who rely on them.
- 10. ASL Interpreter Coordination: When requesting an ASL interpreter, it should be confirmed whether the requester will attend virtually or in person. Ideally, the interpreter attends in the same format. If an interpreter is only available via video while the individual testifies in person, a laptop should be provided at the testifier's table so the testifier may face the committee.
- 11. Hearing Room Configuration: Hearing rooms should allow adequate maneuvering space for individuals using mobility aids, such as motorized scooters or wheelchairs.

- 12. Microphone Accessibility: Public testimony microphones should be configured for accessibility. We recommend eliminating podiums and providing tables with sufficient clearance beneath them for wheelchair users to approach the microphone. Wireless microphones would enhance flexibility.
- 13. Hearing Room Retrofitting: While we encourage retrofitting all hearing rooms for maximum accessibility, if not feasible, we suggest prioritizing selected hearing rooms for disability-related legislation.
- 14. Ceremonial Desk Access: The ceremonial bill signing desk in the Governor's Office lacks an accessible route for individuals using mobility aids to get behind the desk, preventing their participation in standard photo opportunities with the State Seal as the backdrop.

The Hawaii State Capitol is a vital public building that should exemplify the highest standards of accessibility. Ensuring equal participation for individuals with disabilities sets a precedent for all state and local government buildings.

SUBJECT: Accessibility Concerns with the Hawaii State Capitol Building

During the 2024 legislative session, the Disability and Communication Access Board (DCAB) identified several accessibility concerns reported by individuals with diverse disabilities. We wish to highlight these issues and remind you that DCAB is available for consultation on accessibility matters.

We have organized the concerns sequentially, from the point of receiving a hearing notice to providing testimony at a hearing.

- 1. Accommodation Requests: The wording on hearing notices should be revised to reflect that requests for accommodations can be made at any time, as stipulated by the Americans with Disabilities Act (ADA) Title II. We recommend the following wording: "If you need an auxiliary aid/service or other accommodation due to a disability, contact [Name] at [phone number and email address]. Requests made as early as possible have a greater likelihood of being fulfilled."
- 2. Agenda Prioritization: Disability-related agenda items should be placed at the beginning of the agenda. This practice will help ensure that scheduled American Sign Language (ASL) interpreters do not exceed their allotted time, thereby avoiding additional costs and ensuring effective communication for those relying on them. It will also assist individuals who need to coordinate pickups with TheHandiVan.

- 3. Website Accessibility: The Legislature's website should be evaluated and updated to meet the Web Content Accessibility Guidelines (WCAG) 2.1 by April 24, 2026, as required by the U.S. Department of Justice. Additionally, we recommend discontinuing the color-coding scheme for submitted testimony, as it is not accessible to individuals with vision impairments. Confirmation of submitted testimony should not require a phone call for those with vision disabilities.
- 4. Accessible Parking: Many have expressed concerns regarding the relocation of public parking from under the Capitol. DCAB strongly advocates for maintaining accessible parking spaces in this area to ensure access for individuals with mobility disabilities. We also request that accessible spaces in the employee parking area comply with ADA Accessibility Guidelines (ADAAG) and be available as reasonable accommodations for qualified employees with disabilities.
- Curb Ramps: Some wheelchair-accessible vehicles are too large and cannot drop
 off passengers using a wheelchair or scooter at the Capitol basement level, forcing
 them to use the loading area on South Beretania Street, which lacks curb ramps.
 DCAB recommends installing curb ramps in this area to enhance accessibility.
- 6. Security Training: We recommend that security personnel receive training on effectively interacting with individuals with various disabilities, as inconsistent procedures were observed during the last session.
- 7. Restroom Accessibility: All public restrooms in the Capitol should be evaluated for accessibility. For example, some paper towel dispensers require a pinching and turning of a wheel, which does not comply with ADAAG. We suggest exceeding ADAAG minimums by including an adult changing table in at least one restroom.
- 8. Automatic Door Openers: We recommend installing automatic door openers on certain hearing room doors. While not mandated by ADAAG, these devices significantly enhance accessibility.
- 9. Captioning on Video Screens: Hearing room video screens should be configured to display captions, as currently, captions are only available on screens outside the hearing rooms, hindering participation for those who rely on them.
- 10. ASL Interpreter Coordination: When requesting an ASL interpreter, it should be confirmed whether the requester will attend virtually or in person. Ideally, the interpreter attends in the same format. If an interpreter is only available via video while the individual testifies in person, a laptop should be provided at the testifier's table so the testifier may face the committee.
- 11. Hearing Room Configuration: Hearing rooms should allow adequate maneuvering space for individuals using mobility aids, such as motorized scooters or wheelchairs.

- 12. Microphone Accessibility: Public testimony microphones should be configured for accessibility. We recommend eliminating podiums and providing tables with sufficient clearance beneath them for wheelchair users to approach the microphone. Wireless microphones would enhance flexibility.
- 13. Hearing Room Retrofitting: While we encourage retrofitting all hearing rooms for maximum accessibility, if not feasible, we suggest prioritizing selected hearing rooms for disability-related legislation.
- 14. Ceremonial Desk Access: The ceremonial bill signing desk in the Governor's Office lacks an accessible route for individuals using mobility aids to get behind the desk, preventing their participation in standard photo opportunities with the State Seal as the backdrop.

The Hawaii State Capitol is a vital public building that should exemplify the highest standards of accessibility. Ensuring equal participation for individuals with disabilities sets a precedent for all state and local government buildings.
