- I. Chairperson Gerald Isobe called the meeting to order at 11:05 a.m.
- II. Board members, staff, public participant, captioners, and sign language interpreters introduced themselves.
- III. Statement from Public and Written Testimonies Submitted.

No written testimonies were submitted.

IV. Approval of Meeting Minutes of January 23, 2025 and March 6, 2025.

The minutes of the January 23, 2025 and March 6, 2025 meetings were approved as circulated (M/S/P Isobe/Tom).

V. Old Business

- A. Report on Deaf and Hard of Hearing Advisory Board (DHHAB) Meeting held on February 15, 2025.
 - DCAB staff attended the DHHAB meeting on February 15, 2025.
 - The Act 204 report on the shortage of American Sign Language (ASL) interpreters in Hawaii was shared, including recommended solutions.

- B. Report on Hawaii DeafBlind Expo held on May 3, 2025.
 - DCAB participated as an exhibitor at the Hawaii DeafBlind Expo on May 3, 2025.
 - The event was a positive experience, staff networked and educated the community about DCAB's programs and services.
 - DCAB also donated a quilt lap blanket for the Expo giveaway.
- C. 2025 Communication Access State Conference. Update.
 - DCAB is excited to announce the 2025 Communication Access State Conference, "Bridging the Gap: Communication Access for All" on Thursday, June 26, 2025 at the Japanese Cultural Center of Hawaii from 8:00 a.m. to 4:00 p.m.
 - Registration is required. The conference is free and filling up quickly, with the maximum capacity of 150 participants.

 - Board member LisaAnn Tom inquired about parking availability. Staff confirmed that free parking is available at the venue.
 - Board member LisaAnn Tom also asked about the number of workshops; staff responded there will be six workshops in total.
 - Chairperson Gerald Isobe asked if exhibitor tables will be available. Staff confirmed that a foyer room will be reserved for vendors.

VI. New Business

- A. Report on Deaf and Hard of Hearing Advisory Board (DHHAB) Meeting on May 17, 2025.
 - DCAB staff attended the DHHAB meeting on May 17, 2025.
 - DCAB announced the upcoming 2025 Communication Access Conference and received a lot of positive feedback.
- B. <u>Final Evaluation Results Received for One Applicant for the Hawaii Quality</u>
 Assurance System (HQAS) Test.

- One applicant passed the HQAS test and received Tier IV credential.
- This is a valuable addition to the interpreting community and benefits the Deaf and Hard of Hearing community in Hawaii.
- Board member LisaAnn Tom asked if the applicant is local or from the mainland. Staff responded that the applicant is from another country, has recently moved to Hawaii, and plans to stay.

C. Report on Two New Applicants for the Hawaii Quality Assurance System (HQAS) Test.

- Two (2) applicants recently took the HQAS test on March 10 and April 24, 2025.
- Currently waiting for the evaluations and will announce the test results by August 2025.

VII. Open Forum

- Social Media Outreach: The group discussed the development of social media
 platforms to better inform the community about services offered by DCAB and
 DHHAB. Justin "Pono" Tokioka stated he will review DCAB's social media policy
 and begin setting up accounts (Facebook, Instagram, Twitter/X) after the
 upcoming Communication Access Conference. Content will be created,
 approved by administration, and then posted. The importance of including
 "DCAB Hawaii" in all account names was emphasized.
- Deaf Awareness Day Revival: Board member LisaAnn Tom proposed bringing back Deaf Awareness Day, typically held in the fall (September or October). The event would aim to promote Deaf culture, language, and community visibility. The idea will be added to the next meeting agenda for further planning and possible inclusion in the 2025–2026 Plan of Action. Staff reminded the group that decisions must be finalized before the July 17, 2025 General meeting, which marks the start of the new fiscal year.
