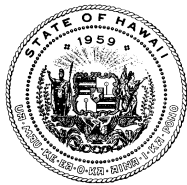

SUBJECT: All Provider Training on March 13, 2017

The Department of Health (DOH), Developmental Disabilities Division (DDD), will be conducting an All Provider Training for the Intellectual/Developmental Disabilities (I/DD) Home and Community Based Services (HCBS) Medicaid Waiver on Monday, March 13, 2017. The training will be held at the State Laboratory Auditorium on Oahu as well as video conferencing centers (VCC) on the neighbor islands. There will be two sessions available at each location except Kona and Molokai; one from 9:00 a.m. to 12:00 p.m. and one from 1:00 p.m. to 4:00 p.m. There will be only one session available at the Kona and Molokai locations from 9:00 a.m. to 12:00 p.m. Please find attached the logistical information for the VCC on each island.
