# **Adult Foster Homes** for Individuals with **Intellectual** and **Developmental Disabilities**



"Improving Quality of Care and Quality of Life for People with Disabilities"



Since 1986, the Department of Health, Developmental Disabilities Division has been

certifying adult foster homes to care for individuals with developmental disabilities and intellectual disabilities (DD/ID).



## What is an Adult Foster Home for Individuals with Developmental or Intellectual Disabilities?

A DD/ID Adult Foster Home is a private home in which care, training and supervision are provided on a twenty-four hour basis for not more than two adults with developmental or intellectual disabilities (DD/ID) who are unrelated to the foster family at any point in time. Each foster adult shall be cared for as a family member and shall share in the foster family's activities and responsibilities.

# General Requirements to Obtain Certification for a DD/ID Adult Foster Home

- Single Family Home
- Approved City and County Building plans for your home
- Criminal History Clearance
- Employment Verification
- Physical Examination
- TB Clearances for all household members
- First Aid/CPR Certification (recommended)
- 3 Personal References
- Submit Certification if RN, LPN or CNA Certified
- Attend Adult Foster Home Orientation
- General and Automobile Liability Insurance

## For Wheelchair Accessible Homes, 34 – 36 inches clearance for:

- Front and back exits
- Hallways
- Bathroom doors
- Foster adult's bedroom door
- Any internal doors leading to the common areas of the home
- Accessible shower highly recommended

#### For Foster Adult's Bedroom:

- 10' x 10' or larger can accommodate two (2) foster adults
- Any smaller room may be certified for only one (1) foster adult.
