Red Cross Offering First of Several Financial Assistance Programs

Thanks to the generosity of our donors, the American Red Cross is offering financial assistance for those who need help recovering and whose primary residences were destroyed or sustained eligible structural damage. The Red Cross also provides financial assistance to displaced survivors in Red Cross shelters or hotel emergency lodging and to next of kin who have experienced a disaster-caused fatality.

This first of several Red Cross Financial Assistance programs for survivors of the Hawaii Wildfires will begin on **Monday**, **August 21, 2023**. If your home was destroyed or suffered significant structural damage from the wildfires and you registered with FEMA, then you will likely receive an invitation to complete an application directly from the Red Cross through an email, text message, or phone call.

On **Monday, August 28, 2023**, households who have not received a call, text, or email from the Red Cross and believe they have qualifying damage will have the opportunity to make an in-person appointment to enroll for assistance. More information on how to schedule an appointment and locations of these fixed enrollment sites will be shared publicly before August 28.

To be eligible for Red Cross damage-based financial assistance, households apply for the program and meet the following three requirements:

- Their pre-disaster primary residence (renter or homeowner) is in a confirmed disaster-impacted geographic area in Maui County.
- The head of household must be able to provide proof of identity and residence.
- Their primary residence is either destroyed or has suffered significant structural damage that requires extensive repairs. A residence that is destroyed is one that is a total loss or with damage so severe that repairs are not feasible.

The only way to receive this assistance is through a call, text, or email from the Red Cross or by making an appointment to meet with a Red Cross caseworker once appointments are open after August 28. Red Cross workers at hotels or service sites will be able to provide additional information on how to register for financial assistance.

We ask that people apply for federal Disaster Assistance at **disasterassistance.gov or by calling 800-621-3362.** However, approval for FEMA assistance is not a requirement to receive the Red Cross financial assistance.

All Red Cross services, including financial assistance, are available to individuals regardless of citizenship status, nationality, race, sexual orientation, gender identity, religious beliefs, class, or political opinions. The Red Cross is a charity, not a government agency and people do not need to be American citizens to receive our help. Red Cross financial assistance is not a loan and will never need to be repaid.

OUTREACH EXAMPLE of THE EMAIL MESSAGE YOU MAY RECIEVE

The American Red Cross is inviting you to apply for a disaster relief program. Our records indicate that your home was destroyed or sustained major damage during and you may be eligible for financial assistance.

This program closes on xx/xx/xxxx- you will not be able to participate in this program after this date.

If you already have a case related to xxxx, you can disregard this message. To apply, please call 1-800-RED-CROSS (1-800-733-2767). Your reference number when speaking to an agent is xxxxxx.

Please note that this email is personalized to the recipient and will not work if it is forwarded to other people for their use. The invitation to participate in this program is intended for one recipient per household. The Red Cross will not ask you for your bank account information or social security number to process your request for assistance.
