SUBJECT: 1915(c) Waiver Provider Standards Manual Version B and Rate Study

The Department of Health (DOH), Developmental Disabilities Division (DDD) is pleased to issue an update to the Medicaid 1915(c) Waiver Provider Standards Manual Version B (Standards B) for Individuals with Intellectual and Developmental Disabilities (Medicaid I/DD Waiver).

The provisional Standards B with an effective date of November 1, 2023, is pending Department of Human Services, Med-QUEST Division approval and the Centers for Medicare and Medicaid Services (CMS) approval of the Medicaid I/DD Waiver Amendment. Standards B is posted to the DDD website https://health.hawaii.gov/ddd/waiverproviders/medicaid-idd-waiver-provider/. Per the Medicaid Provider Agreement, this memo serves as the 30-day notice of the effective date.

Training on Standards B for providers and case managers has been scheduled for October 19, 2023, from 1:00 pm to 2:30 pm via Zoom (see attached flyer for registration information).

The updated Rate Study with Final Rate Models that will be in effect November 1, 2023, pending CMS approval of the Medicaid I/DD Waiver Amendment, is posted to the DDD website https://health.hawaii.gov/ddd/waiverproviders/medicaid-idd-waiver-provider/. The updated Medicaid I/DD Waiver rate sheets will be issued after CMS approval is received.

Standards B updates include:

1) Added exceptions for emergency situations where the signed Consent for Services may be obtained after service delivery has begun.

- 2) Added language that nurse delegation is part of certain services and Training and Consultation RN for delegation activities is still available for certain services.
- 3) Added minimum qualifications for service supervisors without a bachelor's degree.
- 4) Added cost reconciliation methodology for Waiver Emergency Services.
- 5) Added section on Financial Accountability Pre-Payment Review to include the requirement of Electronic Visit Verification (EVV) for pre-payment reviews.
- 6) Added language to Community Learning Service Individual may be delivered out-ofstate
- 7) Added language that participants who live in licensed/certified homes may receive Personal Assistance/Habilitation while traveling out-of-state or while in an acute-care hospital setting.
