ON WATCH FOR MEASLES

According to the Centers for Disease Control and Prevention (CDC), as of April 1, in the U.S. there have been 10 measles outbreaks. A total of 104 cases of measles has been reported so far this year, with two (2) of these cases here in Hawaii. Eighty-four (84) of the cases were unvaccinated or had an unknown vaccination history. Thirty (30) of these were not vaccinated due to parental, philosophical or religious beliefs.

Measles was declared eradicated from the U.S. in 2000, but the disease still circulates in other countries and is imported into the U.S. by unprotected/unvaccinated individuals who travel abroad. These individuals then infect others here at home.

Please be on watch for signs and symptoms of measles:

Blotchy rash, fever, cough, runny nose, conjunctivitis, malaise, and Koplik's spots (not always present).

Have You HIR'd?

Can providers send their data electronically to the Hawaii Immunization Registry (HIR) to fulfill Stage 2 Meaningful Use? The short answer is yes, however; providers are required to complete a data exchange on-boarding process before transmitting data from their Electronic Medical Record (EMR) to HIR.



Follow these steps to ensure that your HIR data exchange on-boarding process goes smoothly:

- Talk to your EMR vendor to ensure that a HIR data exchange interface has been developed and tested. HIR staff are currently working with several EMR vendors on the development of their data exchange capabilities to ensure that messages are formatted properly and include the fields required by the Hawaii Department of Health.
- Work with your EMR vendor and HIR staff to complete the data quality testing process which utilizes test scenarios to ensure that demographic and immunization data from your EMR is being accurately transferred to HIR. Data quality checks will be completed during the development and initial implementation phases and will continue periodically as needed.
- Schedule a HIR data exchange training session for you and your staff.
- Designate someone from your office to work with HIR staff on correcting data exchange errors and completing data quality checks.

Remember to Accept Your Order Transfer Records in HIR

When you receive a VFC vaccine shipment, remember to check that your order status has been updated to “fulfilled” and for order shipment transfer records in HIR. If the information in the order shipment transfer record matches what you received, accept the transfer record by following the steps below. This will ensure that the next time you submit your inventory (e.g., prior to placing your next VFC vaccine order) you won’t need to manually enter the NDC, lot number, and vaccine expiration date for each inventory line item. Accepting your transfer records will automatically populate this information in HIR for you!

Step 1: Once you’ve logged into HIR, select the “manage transfers” option located under the “Inventory” menu on the left side of your screen.



Step 2: In the “Manage Transfer” screen, click on the blue hyperlinked “create date” for each Inbound Transfer record.

Step 3: In the “Receive Transfer” screen, select “Accept Transfer” to add the received vaccine to your HIR inventory.



Repeat Steps 2 and 3 until all inbound transfer line items are accepted.

After accepting all of your transfers, the vaccine trade name, NDC, lot number, and expiration date information for each vaccine will be pre-populated in the record inventory, “inventory on hand” page, saving you from having to manually enter this information the next time you submit your inventory (prior to placing a vaccine order).

TALK TO THE DOC

We have a 13 year old patient with documentation of one dose of MMR and one dose of varicella vaccine. May we give this patient Proquad®?

No. This patient does need an additional dose of both the MMR and varicella vaccine. However, the combination MMR and varicella vaccine (MMRV or Proquad®) is licensed only for use in children aged 12 months through 12 years. This patient will need to receive a dose of MMR vaccine and a dose of varicella vaccine.

Note: live virus vaccines not administered on the same day must be administered a minimum of 4 weeks apart. The minimum interval between two doses of MMRV vaccine is 3 months.

Reporting Illness—It’s the Law!

As mandated by Hawaii Administrative Rule, Title 11, Department of Health, Chapter 156, Communicable Diseases and its exhibits, certain infectious diseases, including vaccine preventable diseases such as chickenpox, are reportable in Hawaii.

There are two ways to report:
