VFC Orders - Required Elements

- Current VFC and HIR enrollment status
 - Annual re-enrollment is required for both the VFC program and HIR.
- Completion of annual VFC Educational Requirement
 - VFC Educational Requirement consists of either:
 - Completion of VFC Compliance Site Visit within the last year
 - Completion of both CDC "You Call the Shots" training modules within the last year:
 - Vaccines for Children Program
 - Vaccine Storage and Handling
- Evidence that the provider has submitted Vaccine Administration Visit Records (VAVRs) or submitted vaccine administration data to HIR within the past 6 months



VFC Influenza Vaccine Order Fulfillment

- Influenza vaccines differ from all other VFC-supplied vaccines in that initial supplies are often limited.
- CDC releases influenza vaccines to the State in “allotments” or waves.
- If initial CDC allotments are not sufficient to fill provider prebook requests in their entirety, the Hawaii VFC program will fulfill partial orders.
- It may require several vaccine shipments to fulfill a provider’s entire VFC influenza prebook request.



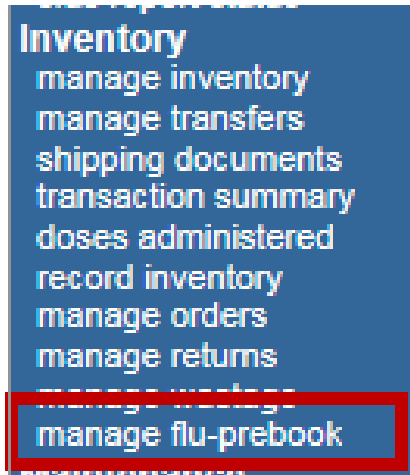
Determining Flu Prebook Order Amounts

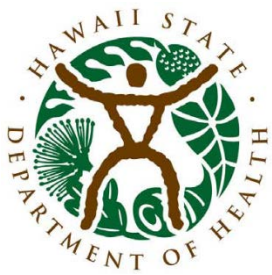
- Providers must place orders for the **FULL** amount of VFC inactivated influenza vaccines required by your practice for the entire influenza season.
- The following **inactivated, quadrivalent** influenza vaccines (IIV4) will be distributed by the Hawaii VFC program:
 - Fluzone-Quad, 0.25 mL pre-filled syringes
 - Indicated for children 6-35 months of age only
 - Fluzone-Quad, 5 mL multi-dose vial
 - Indicated for children 6 months-18 years of age



HIR Demonstration - Flu Prebook Functionality

- After you have logged-in to your organization, click on the “manage flu prebook” menu option on the left side of the screen:

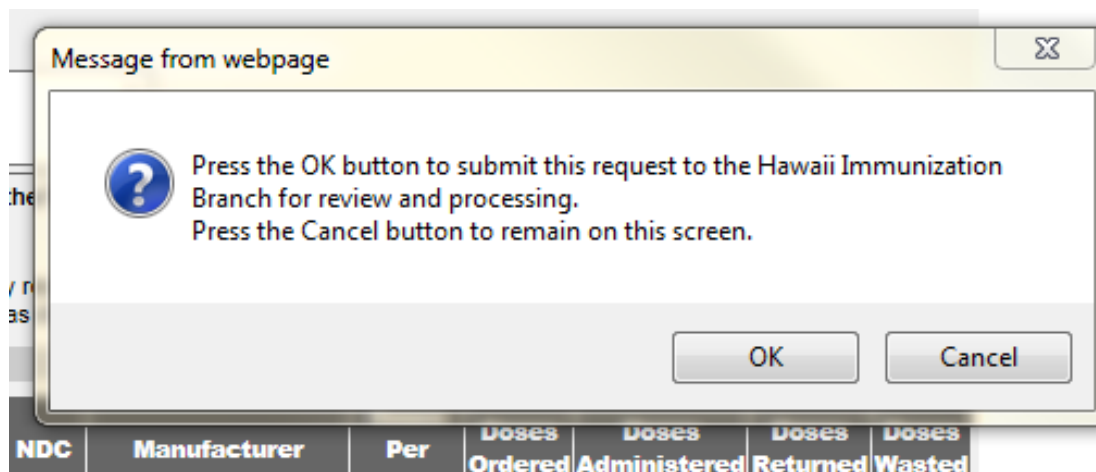

- Once the prebook request is submitted you will return to the “Manage Flu Prebooking Requests” screen. Your prebook order will display in “Pending” status.
- While in “Pending” status, your prebook request dose amounts will remain editable.
- Click on the blue status hyperlink to review/edit your request.

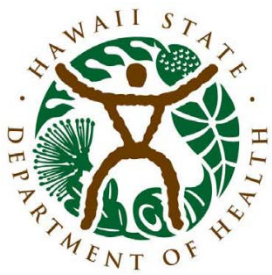

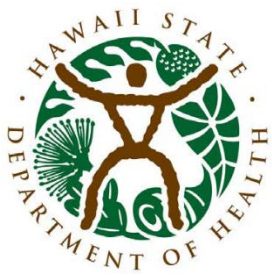

“Modify Prebooking Requests” Screen

- By clicking on the “Pending” status hyperlink, you will be taken to the “Modify Prebooking Requests” screen.
- To change the number of doses requested, enter the new amount and click on the “Update Request” button.
- To cancel/delete your prebook request, click on the “Cancel Request” button.
- If no changes are needed, click on the “Cancel” button to return to the “Manage Flu Prebooking Requests” screen.

Influenza Vaccine Order Fulfillment

- Providers may initially receive only partial fulfillments of their original requests.
- To check the amount to be received, view the prebook request and look at the “Ordered” column.
- Note that the “Ordered” figure will represent the running total of influenza vaccines shipped to fill the “open” prebook request.

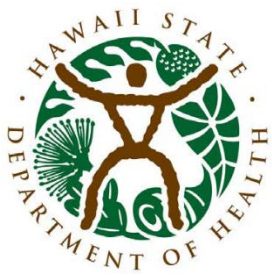

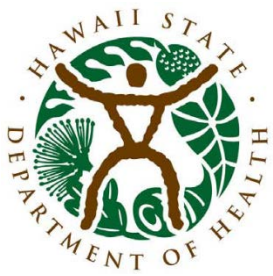

Fulfillment Report, Cont.

- The report will display the number of doses requested, approved, ordered, received, administered, returned, and wasted for the entire season.
- Note that providers will be able to produce this report for each subsequent influenza season so year-to-year comparisons may be made in the future.

- The Hawaii VFC program will be managing influenza vaccine orders exclusively through the HIR “manage flu prebook” functionality.
- If you receive your entire prebooked amount and find that you need to place an additional order for flu vaccine, please place another prebook order.



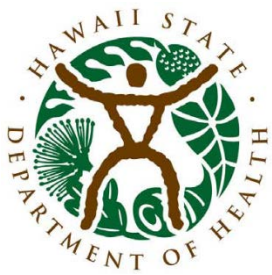
Note on Timing

Pending evaluation of the current HIR VFC influenza prebook functionality, we may choose to shift the prebook period to occur earlier in the year (e.g., Winter/Spring rather than Summer) to better inform State vaccine purchasing projections.
