Dr. Chunmei Wu receives CDC Immunization Award for Hawaii

Hawaii VFC provider, **Chunmei Wu, MD**, has been selected as the recipient of the 2018 Centers for Disease Control and Prevention (CDC) **HPV Vaccine Is Cancer Prevention Champion Award** for Hawaii.

According to CDC, only about half of Hawaii's adolescents aged 13-17 years were up-to-date on their HPV vaccinations in 2017. In comparison, **90% of Dr. Wu's patients have completed the HPV vaccine series.**

"Dr. Wu is regarded as a caring and trusted professional by her patients and her staff," said Alicia Diem, Epidemiological Specialist. "She educates her staff as well as her patients and their families about the importance of **HPV vaccine as cancer prevention** and enlists her staff as partners in championing all immunizations with equal importance."

In partnership with the Association of American Cancer Institutes (AACI) and the American Cancer Society (ACS), CDC established the award program to recognize leaders in healthcare who are going above and beyond to promote or foster HPV vaccination among adolescents in their communities. The *HPV Vaccine Is Cancer Prevention Champion Award* honors up to one champion from each of the 50 U.S. states, 8 U.S. Territories and Freely Associated States, and the District of Columbia.

Dr. Wu's Best Practices

- Check each patient's vaccination status in the electronic health record system the day before a visit to prevent missed opportunities
- Call patients to remind them of upcoming appointments
- Respectfully acknowledge and respond to parent questions and concerns

Important Reminders:

- ◆ VFC vaccine ordering privileges will be suspended for providers/facilities that do not submit VFC enrollment information by **January 31, 2019**.
- ◆ Completed forms may be submitted via fax ([808] 586-8302) or mail (Hawaii Department of Health, ATTN: Vaccines for Children Program, P.O. Box 3378, Honolulu, HI 96801).
- ◆ Completed Hawaii Immunization Registry (HIR) Enrollment and Confidentiality and Security Statements are not required this year due to HIR system unavailability.

Annual Education and Training Requirement



For those providers who are overdue, don't forget to complete the annual education and training on VFC program and vaccine storage and handling requirements to avoid having VFC vaccine ordering privileges suspended.

FIGHT HEP A It starts with you

Ask the Doc: Hep A Pre-exposure Prophylaxis



Question:

My patient (aged 10 months) is traveling to Kenya. I know he should receive a MMR vaccine because he is traveling internationally, but does he need pre-exposure prophylaxis for hepatitis A as well, and if so, what should he receive?

Answer:

In November 2018, the ACIP updated the recommendations for use of hepatitis A vaccine for preexposure prophylaxis for international travel. Because hepatitis A vaccine is not licensed for use in children aged <1 year, immune globulin (IG) has historically been recommended for travelers in this age group. However, IG cannot be administered simultaneously with MMR vaccine, which is also recommended for infants aged 6-11 months traveling internationally from the U.S.

ACIP now recommends that hepatitis A vaccine should be administered to

healthy infants aged 6-11 months (indication for off-label use) traveling outside the U.S. to countries with high or intermediate hepatitis A endemicity (e.g., Kenya). The travel-related dose for infants aged 6-11 months should not be counted toward the routine 2-dose series. Therefore, the 2-dose hepatitis A vaccination series should be initiated at age 12 months according to the routine, age-appropriate vaccination schedule.

Recommendations for preexposure protection against hepatitis A for travelers aged <6 months and aged ≥12 months remain unchanged from previous recommendations, except for the updated dosage of IG where applicable.

Vaccine Order Errors

When placing orders for VFC vaccines, please double check to ensure that you have indicated/selected the correct vaccine product. Vaccines are very expensive and we want to avoid sending products in error. Note that many vaccines have multiple brands/options available.

Vaccine Order Errors to Avoid

- Hep A: Havrix (GSK) and Vaqta (Merck)
- MenACWY: Menactra (Sanofi) and Menveo (GSK)
- MenB: Trumenba (Pfizer) and Bexsero (GSK)
- Rotavirus: RotaTeq (Merck) and Rotarix (GSK)
