**gm:** Good morning. My name is Gino Merreg. I am the hearings officer for today's public hearing. Before I begin, let me introduce to you Ron [0:00:10 inaudible] Hadia who's going to be helping me out this morning's hearing. The purpose of today's public hearing is to [0:00:19 inaudible] testimony regarding rules changing. We are here only to take testimony and not to make decision regarding the proposed rule change. And we will not be taking questions. If you plan to submit oral testimony or comment on the testimony of others, please be sure that when you do so, state your name and spell your name for the record, okay? How many people here who tend to [0:00:49 inaudible] testimony? Can I see your hands? Okay. Depending on the number of people who are going to testify, we're going to begin by limiting the testimony time to two minutes per person. If you're [0:01:03 inaudible] before we put that on clocking, we can [0:01:07 inaudible] testifying, okay. We just want to give your fellow attendees the opportunity to also present their oral testimony. If you had signed up to testimony, when I call your name, please come up here [0:01:23 inaudible] and you may present your testimony or scan on your written testimony if you [0:01:30 inaudible]. Okay. If [0:01:35 inaudible] you run out of time and you are not able to present your full testimony, I encourage you to submit written testimony either by email or by regular mail to the Department of Health. Now, oral testimony and written testimony are given the exact same weights. The reason I say this is because some other hearings, we have enough people or too many people who we can't accommodate their oral testimony. Again, I will give you the address and the email address for -- where you can submit your written testimony. Okay? **Gm:** Okay. The date -- the end date is December 27th, 2018 at 12 noon. Any other question? Okay. Let's proceed. Let the record reflect that it is now 9:06 AM, December 20th, 2018. We are on the Island of Hawaii at the Hilo [0:03:22 inaudible] Building 75 Aupuni Street, Hilo, Hawaii Conference Room A, B and C. This is the Department of Health State of Hawaii Public Hearing for Docket Number R-157-18-07. Now, the first person I'm going to call to testify is Kent. Is there a Kent here? Or is it K-E-R-E-N-T Forrest? Okay. Please state your name and spell it.

**Kf:** My name is Forrest Kerent, FORREST [0:04:06 inaudible]. I'd like to thank you for the opportunity to provide testimony as a father, as a community member and public [0:04:16 inaudible]. I strongly opposed the proposed ruled changes, the proposed changes that bring Hawaii's most important [0:04:23 inaudible] for the most superb recommendation of the Advisory Committee for Immunization Practices, ACIP. The proposed rules updated especially the importance of acquiring statements first ever in 7th grade or higher to receive the HPV [0:04:41 inaudible] levels especially for the HPV vaccine which prevents HPV related cancers that might otherwise [0:04:49 inaudible] life. The Standards for [0:04:52 inaudible] and Intervention [0:04:54 inaudible] advised that [0:04:55 inaudible] vaccination requirement for day care and school entry are important rules to maintain high community vaccination rates [0:05:04 inaudible] lower rates for vaccine preventable diseases. **Low** vaccine is a hundred percent effective for everyone and not everyone can be vaccinated. Newborns and those compromised immune system such as those experienced in chemotherapy or other [0:05:22 inaudible] conditions are not immunized. It approximately [0:05:27 inaudible] the population is vaccinated [0:05:30 inaudible] stay protected, immunized are both protected from vaccine preventable diseases and protect those not immunized. The reason [0:05:40 inaudible] this immunity for more vaccine exemptions are at greater risk for vaccine preventable disease outbreak. The [0:05:47 inaudible] exemptions for those who are medically and [0:05:50 inaudible] improved protection for our entire community including those who are particularly [0:05:56 inaudible] very young and our elders. I respectfully request those changes be supported and passed for the benefit of all our community. Thank you.

**Gm:** Thank you. In case I didn't mention this earlier, this is a hearing for proposed Hawaii Administrative Rule change Title 11 Chapter 157 regarding examination and immunization. Okay. Mark Smith?

**Mark Smith:** Hello. I'm a community member, I'm a father in Hawaii and I have [0:06:33 inaudible] in behalf of [0:06:36 inaudible]...

**Gm:** Excuse me, Mr. Smith, can you state your name and spell it for the record, please?

**Mark Smith:** My name is Mark A. Smith, M-A-R-K A [0:06:43 inaudible] S-M-I-T-H. [0:06:47 inaudible] I'm retired but [0:06:52 inaudible] by this viruses and this vaccine. What we know is this who knows that the [0:07:05 inaudible] high vaccine [0:07:07 inaudible] pharmaceutical for [0:07:09 inaudible] with the promise that may impacted this vaccine [0:07:14 inaudible] includes [0:07:16 inaudible] and so forth. We know that 55,000 women around the world is protected [0:07:24 inaudible]. We know that 44% of vaccine records as [0:07:28 inaudible], we know. We are back. [0:07:32 inaudible] market because they -- when another problem [0:07:39 inaudible] came out state

[0:07:39 inaudible] Merck Pharmaceutical [0:07:43 inaudible] they have a [0:07:44 inaudible] they were [0:07:46 inaudible] and Japan's promised was [0:07:49 inaudible] there wasn't [0:07:52 inaudible] was problem out of your [0:07:54 inaudible]. We know the pharmaceuticals, we know they have a better [0:07:59 inaudible] them with the doctors. The one who developed [0:08:03 inaudible] pharmaceutical can say [0:08:05 inaudible] Brian Parker. He's a researcher of Merck Pharmaceutical. He stands up against their own product today or [0:08:12 inaudible] the benefits of health is [0:08:15 inaudible]. There is no [0:08:16 inaudible] by this product. This is the [0:08:22 inaudible] research of the Merck [0:08:26 inaudible]. I know about the other vaccine, what he knows [0:08:32 inaudible] and advocating [0:08:34 inaudible] with every [0:08:36 inaudible] in your body [0:08:38 inaudible]. And once they get sick, they do not ever go [0:08:43 inaudible] is given to the children [0:08:48 inaudible] it does not [0:08:50 inaudible]. Thank you.

**Gm:** Thank you. Josh -- is it Garey?

**Joshua Garey:** Yes.

**Gm:** Okay. Could you state and spell your name for the record, please?

**Joshua Garey:** Yes. My name is Joshua Ford Gary, J-O-S-H--U-A G-A-R-E-Y. Thank you for having this discussion today. When I was about to become a parent for the first time, I looked at the vaccines very carefully. I concluded that it would be [0:09:23 inaudible] for me to inject potentially dangerous substances into a healthy human body especially the young ones. The risks far outweigh [0:09:32 inaudible]. I requested the actual inserts of ingredients, side effects, legal [0:09:37 inaudible] report from our pediatrician. It falls out [0:09:40 inaudible] double-sided [0:09:42 inaudible] of the tiny [0:09:43 inaudible] I have ever seen. I've spent several hours reading [0:09:47 inaudible] left. [0:09:49 inaudible] insert I was given [0:09:50 inaudible] seizures, fever and brain slow. I researched more and learned that several [0:09:56 inaudible] doesn't [0:09:58 inaudible] unconstitutional and separate from our normal justice system and [0:10:02 inaudible] paid out several billion dollars from our tax money [0:10:06 inaudible]. I've learned that only the small [0:10:09 inaudible], only the ones who are [0:10:12 inaudible] direct [0:10:12 inaudible] and easily approval are [0:10:14 inaudible] clearly [0:10:17 inaudible]. If others want [0:10:20 inaudible] pharmaceutical corporations who's [0:10:23 inaudible] and improved vaccine [0:10:27 inaudible] I won't compromise myself [0:10:30 inaudible] evidence but it is not [0:10:32 inaudible]. If people want to take the vaccine [0:10:36 inaudible] for being contagious. I can only acknowledge that with protest since that is [0:10:44 inaudible] grave threat to public health than unvaccinated people [0:10:49 inaudible]. If your vaccines work, what are you worried about? Herd immunity is a [0:10:54 inaudible] for people who [0:10:56 inaudible] without telling people [0:10:59 inaudible] work. It is my opinion the vaccine [0:11:04

[inaudible] and that is not an adjuvant. People who are against vaccines are not anti-science, we are anti-malevolent science and [0:11:17 inaudible] malevolent science [0:11:19 inaudible] will eventually to vaccinate. Thank you.

**Gm:** Okay. Is there a Nicole Yokoyama?

**Nicole Yokoyama:** My name is Nicole Yokoyama, N-I-C-O-L-E Y-O-K-O-Y-A-M-A [0:11:46 inaudible] say because [0:11:51 inaudible]. I would like to say I live in hawaii for several years [0:11:58 inaudible] proposed number. I'm not coming here to argue about vaccines, I'm here to tell you that you do not have to [0:12:11 inaudible] what goes into their children's body. How dare you? This is violation against human and civil rights and violates [0:12:19 inaudible]. We have [0:12:21 inaudible] about the woman's the right to choose whether or not to permit [0:12:25 inaudible] because her body, her choice. So why should we have [0:12:31 inaudible] vaccination for proponent? Vaccination's high significant rate to [0:12:36 inaudible] long time [0:12:38 inaudible] that it is my body, my choice. My highest body and my choice [0:12:45 inaudible] because what's my child's best interest [0:12:49 inaudible]. People [0:12:50 inaudible] say that might involved [0:12:54 inaudible]. We have become a [0:12:55 inaudible] and what we swear [0:12:58 inaudible] to heal and not harm. What [0:13:02 inaudible] that is. [0:13:04 inaudible] this year take up \$40,000 [0:13:07 inaudible] vaccination 180 [0:13:08 inaudible]. It's about [0:13:11 inaudible] to fully vaccinate 200 patients [0:13:13 inaudible] 8,000 [0:13:15 inaudible] only the mother [0:13:20 inaudible] earn the package [0:13:21 inaudible] vaccine from the previous [0:13:22 inaudible] every year. [0:13:25 inaudible] support. How about [0:13:27 inaudible] priority here? Why are we so desperate one day what was [0:13:32 inaudible] in other country because of the thousands of vaccine [0:13:35 inaudible]. How much do you get paid for [0:13:38 inaudible] to put this mandate through? Why are vaccine companies [0:13:43 inaudible] liabilities? Why are they [0:13:46 inaudible]? Because I get to show you evidence [0:13:51 inaudible] for our testimony and read all the scientific [0:13:56 inaudible] because I know I will testify with you. [0:13:59 inaudible] the trash. How about [0:14:03 inaudible] accountable. If you [0:14:10 inaudible] how about testing individuals for being patient depends the sensitivities and allergies to vaccine [0:14:18 inaudible] before vaccination because that will help save lives. [0:14:23 inaudible] because it costs money and it always comes down to money because they [0:14:28 inaudible] will spend their lives suffering due to adverse reactions and [0:14:33 inaudible]. They didn't know about the health and wellness of the children, it's about money and [0:14:37 inaudible]. It's very the same [0:14:41 inaudible]. What's next? [0:14:43 inaudible] vaccines [0:14:44 inaudible] conclusion. But once the active [0:14:49 inaudible] and then what, mandatory abortion, mandatory [0:14:53 inaudible] the society, mandatory [0:14:58 inaudible]. No one has the right to [0:15:02 inaudible] and what they do to their own body.

Show some respect to our civil rights. If someone [0:15:09 inaudible] considered assault. Forcing a medical procedure is medical [0:15:15 inaudible]. [0:15:16 inaudible] the same choice. And once I look down to [0:15:20 inaudible] and not be accountable [0:15:22 inaudible]. It is mandate [0:15:24 inaudible] the children [0:15:25 inaudible] the dangers might have in vaccine for you [0:15:28 inaudible]. It is not [0:15:31 inaudible].

**Gm:** Is there a Catherine Lightfoot-Martin?

**Catherine Lightfoot-Martin:** Hello. My name is Catherine, C-A-T-H-E-R-I-N-E, Lightfoot-Martin, M-A-R-T-I-N. I am [0:16:05 inaudible] in Kauai. And I'd like to share [0:16:08 inaudible] of how to vaccinate children in the United States. In 1950, before vaccines were offered to our children, [0:16:16 inaudible] never more than one vaccine at a time. At that time, the US [0:16:23 inaudible] infant mortality in the world between only 200 of infant mortality rates [0:16:28 inaudible] than United States. In the 1970, we increased some of our vaccinations to 14 for early childhood. At that time, the CDC had developed a way of addressing majority numbers of adverse effects scene reported. That was the [0:16:42 inaudible] that vaccine adverse event reporting system. In the 1980s, they combined the measles, mumps, rubella vaccines into one injection called the MMR. [0:16:51 inaudible] 15 months and then 18 months along with the other 7 or more vaccines. At that time, the US went [0:17:02 inaudible] in infant mortality. Whoa. That's a big change in [0:17:05 inaudible]. In the 1990s, we increased the number of required vaccinations to 20 injections in early childhood. They add vaccines for Hepatitis B, herpes and [0:17:15 inaudible]. In the 1990s, they introduced thimerosal, the mercury [0:17:20 inaudible] vaccine [0:17:22 inaudible] injury vaccine -- a lot of injuries from vaccine. And at that time, the US went on third in infant mortality. We're getting worse. Now, we have seen an increase of nearly 442% and another vaccines [0:17:37 inaudible] children since the 1950. 45 are mandated in childhood [0:17:42 inaudible]. Seven of those includes combination shots which is multiple vaccines in one injection. It means we're getting a total of 54 vaccines for children total. Americans are [0:17:52 inaudible] by law there's more vaccines than [0:17:54 inaudible] of the world. And now the US [0:17:57 inaudible] 49. [0:17:59 inaudible] 2012 since I believe the numbers [0:18:01 inaudible]. 49, you know, worse than any under developed country on infant mortality. Is this really the best we can do to promote and protect the health of our children. The evidence says no. In 1975, [0:18:14 inaudible] minimum vaccination in to two years old, meaning that zero vaccines were given to babies [0:18:20 inaudible] two. After that, the infant mortality rate in [0:18:24 inaudible] the best in the world. Most of United States today received 20 vaccines in their injections in their 42 years of life and we are the worse infant mortality in the world, we're the worse in developed countries. Is this really the best we can do to promote and protect the health of our children? The evidence says no. More open-minded countries like the Netherlands have set and shown that [0:18:48 inaudible]

injections and definitely [0:18:50 inaudible] the fever leave increase numbers of chronic diseases in [0:18:54 inaudible]. That's right. The people who experience more fevers in childhood have significantly lower rate of [0:19:00 inaudible] developed. So we may be classified when we're giving our children [0:19:05 inaudible] fever that [0:19:08 inaudible] with this now. [0:19:12 inaudible] sacrifice for the future health even the [0:19:15 inaudible] auto immune [0:19:15 inaudible]. It increases the number and [0:19:20 inaudible] the vaccination for our children really the best we can do to promote and protect the health of our children and on the future. The evidence overwhelming says no. Therefore, I urge Department of Health of Hawaii, please do not increase the number [0:19:34 inaudible] vaccination for our keikis. Please complete [0:19:37 inaudible] to inform refusal of vaccination for [0:19:40 inaudible] letters. One more thing I'd to say, if you look at the ratings of that infant mortality, the country [0:19:46 inaudible] the best [0:19:47 inaudible] at the very top and many more European countries are ahead of us. They do not have mandatory vaccines [0:19:54 inaudible] recommendations, recommended vaccines [0:19:56 inaudible] and that is why I urge Hawaii to take [0:19:59 inaudible]. Thank you.

**Gm:** Is there Ione Chittenden here? My [0:20:08 inaudible] Ione?

**Ione Chittenden:** I-O-N-E, Ione Chittenden, C-H-I-T-T-E-N-D-E-N. My first son [0:20:21 inaudible]. I'm the mother of an autistic 12-year old. I opposed this. [0:20:48 inaudible] for autoimmune issue before giving [0:20:54 inaudible] vaccine. The pharmaceutical companies surely can afford [0:21:01 inaudible] before administering the vaccines. Have the vaccine schedules adjusted. There's no reason why a child should have more than one vaccine at a time spread out in [0:21:15 inaudible]. This all happened so far to get it [0:21:20 inaudible]. There's no reason why we should have four or five [0:21:23 inaudible]. People who passed these laws are not the ones who were helping me when my children bang their heads against the wall. [0:21:39 inaudible] disorder. No one has been helping me when [0:21:44 inaudible] night after night after night so no one should the right to tell me what to do with my child. She will never have another vaccine again over my dead body. [0:22:05 inaudible] for many years to have this child. We [0:22:09 inaudible]. She's our only child and we monitor and we watch her and we saw what's the vaccine [0:22:19 inaudible]. After MMR, she lost her speech. There's [0:22:24 inaudible]. I know that the vaccines did it. And, again, she will never have another vaccine done, she [0:22:41 inaudible]. No one shares that you can get the child into school with the religious exempt. It is not common knowledge and it should be. And, again, I oppose this. Thank you.

**Gm:** Is there a Phillip Martin?

**Phillip Martin:** My name is Phillip Martin, P-H-I-L-L-I-P M-A-R-T-I-N. And I want to voice my opinion which is I do not want a government official of any kind or any

other tell me what I need to do or not do for my children. I like to honor the fact that I hope that they're trying to do their best to help the population but I think one of the best ways is to have the freedom of choice. And [0:23:58 inaudible] is important and education is important. And we, the people, know what the choices are. We can make our own decision and that's what I believe in important not have somebody else to make a decision for me or for my children. [0:24:17 inaudible] is different that's why I'm different from my wife and our children are different from each other. So it's very important I believe the choice and that's what [0:24:28 inaudible].

**Gm:** Is there a Unity Nguyen

**Unity Nguyen:** Good morning. My name is Unity Nguyen. My middle name is Tuy Nguyen, T like Tom, U-Y and [0:24:56 inaudible] G-O-C, last name [0:24:58 inaudible] N-G-U-Y-E-N. I'm a practicing family medicine physician in Hilo and Kona. And I am not radically against all vaccines. Some had saved a lot of lives. Some had caused death and harm to the point where they needed to be [0:25:17 inaudible] after having been approved by the government. I'm a physician who have taken [0:25:22 inaudible] oath to do no harm. I believe it is unethical to mandate or even strongly impose all vaccines [0:25:32 inaudible] by the government. I was [0:25:34 inaudible] flu vaccine as a low line [0:25:37 inaudible] because the [0:25:39 inaudible] for is very [0:25:41 inaudible]. The 70% efficacy rate [0:25:45 inaudible] by the industry requires series [0:25:47 inaudible] of data. The most clinically relevant issue of a number needed to shoot [0:25:54 inaudible] is a hundred. They need to present 10 people to prevent one case of flu, not one death, not one [0:26:03 inaudible] but one case of flu. [0:26:07 inaudible] the efficacy rate was 17%. You don't hear this number. So the number needed to treat would be [0:26:16 inaudible]. So the [0:26:18 inaudible] data is use to present the [0:26:21 inaudible]. The issue becomes more acute and we are taking the vaccines for very young children. The immune system under age two is very poorly understood by modern science. One thing we are aware of is that the immune system at this age is not meant to react strongly as many stimulant that the vaccines force a reaction to. The immune system at this age is still learning what to react to and what [0:26:51 inaudible]. So that's why aluminum is added to many vaccines to force a reaction in the system which is [0:27:00 inaudible] otherwise would not [0:27:02 inaudible]. The ones [0:27:04 inaudible] are unknown and there are strong data and gives worry that this process is related to autoimmune diseases where the immune system is reacting in unhealthy ways that cause serious consequence for in growing number of people. More tests about the flu vaccine, this one type of vaccine [0:27:31 inaudible] 1% of [0:27:33 inaudible] in a \$50 billion industry. The manufacturers have produced [0:27:39 inaudible] vaccine. They are [0:27:41 inaudible] from lawsuits for adverse outcomes. How this [0:27:47 inaudible] together [0:27:48 inaudible] humungous financial intentions for depicting to be pushed on [0:27:54 inaudible]. This is [0:27:57 inaudible] vaccines

amongst how many that are [0:28:01 inaudible]. Some believe that the National Institute of Health and other government agencies will protect us from dangerous vaccines. An independent study showed that among the governing board for approving vaccines, the majority of numbers had affiliations with pharmaceutical industry. All these efforts combine make it unreasonable and unethical [0:28:27 inaudible] mandatory requirements of all vaccines that passed the government approval. Thank you very much [0:28:33 inaudible].

**Gm:** Thank you. Is there anybody else here who wishes to testify? [0:28:44 inaudible] Is Leilani Lindsey-Kaapuni?

**Leilani Lindsey-Kaapuni:** Aloha. Recently...

**Gm:** Excuse me, can you state your name and spell it for me?

**Leilani Lindsey-Kaapuni:** Aloha. My name is Leilani Lindsey-Kaapuni, L-E-I-L-A-N-I L-I-N-D-S-E-Y-K-A-A-P-U-N-I. I am a resident of Hilo. I'm a Hawaiian but [0:29:19 inaudible] of promise are stated to Hawaiian because they [0:29:24 inaudible] and we are all set we are made from that and that has always been our position and we have exemption -- religious exemptions from vaccination for our cultural [0:29:35 inaudible] of Hawaiians. So the idea of removing that exemption would impact that [0:29:44 inaudible] culturally, physically [0:29:47 inaudible]. And then the question that our children cannot go to school in [0:29:52 inaudible] education if we do not [0:29:55 inaudible] ourselves and them -- and put them at risk for severe [0:30:01 inaudible] reminds us of 125 years ago the Hawaiian [0:30:08 inaudible] overthrown. And in 1896, the Hawaiian language was done for good. So within two generations, our [0:30:19 inaudible] almost [0:30:22 inaudible] because there was a time when our [0:30:26 inaudible] have to choose between education in children of holding on to their language. It was our way of conveying details and wisdom and history and the truth of who we are. And today, if this religious exemption is removed, then again parents have to choose between educating the children or allowing them to possibly [0:30:49 inaudible] harm. We will not do it. Recently, there was a lawsuit Robert Kennedy Jr. sued the government over vaccine safety and [0:31:00 inaudible]. The result of the lawsuit is that the US [0:31:07 inaudible] had to finally and shockingly admitted that it never, not even once, submitted a single bi-annual report to Congress [0:31:16 inaudible] improvements in vaccine safety which speaks volumes of seriousness of vaccine safety mistreated at HHS and heightened the concern that HHS doesn't have a clue of the actual safety profile of the now 29 [0:31:32 inaudible] volume of vaccine given before age 1 to babies. The rate of autism, autoimmune disease, rare childhood cancer, on and on the list goes, has skyrocketed. But there are small segment of the US population [0:31:52 inaudible] and they are the segment of the population that don't vaccinate the children, the [0:32:00 inaudible] children of Chicago. We will

not do this. And as a Hawaiian, I'm at protected custom under the Parliament Geneva Convention, an exact [0:32:13 inaudible] that is [0:32:16 inaudible]. The Department and the individual will be held accountable for. Thank you.

**Gm:** Thank you. Christina Jung?

**Christina Jung:** Thank you. Aloha.

**Gm:** State your name and spell it for the record.

**Christina Jung:** Okay. My name is Christina Jung. I've been a resident of Hawaii for 17 years. I don't know [0:33:03 inaudible]. All right. [0:33:09 inaudible] evidence to [0:33:15 inaudible] update should not been given. I want to just show that list meaning the mission statement for the Hawaii Department of Health because I think you should vote at least go against the mission statement and the goals and the philosophy that [0:33:30 inaudible] for the people. And your mission statement is to protect and improve and health and environment for all people in Hawaii. And if this update is going to effect [0:33:43 inaudible] protecting all the people of Hawaii. They will increase the chances of severe adverse effects and the increase the vaccine and especially they're giving more vaccines in any other state in the country now. There's definitely an inevitable to this having more adverse effects on the severe ones, more deaths, more infertility, autism, seizures and all the many, many risk factors that are involve with vaccines and so many people have been sharing of theirs to the public. Our National Vaccine Injury Compensation Program were given \$4 billion from our tax money to pay for this injured and families and deaths caused by vaccines. And it is so that people are getting hurt by this and so this becomes mandated and children can't go to school because they refuse it. This could be [0:34:45 inaudible] if people [0:34:47 inaudible] and send their children school and they want more home schooling and people in the state [0:34:53 inaudible] the Department of Education. It can be [0:34:57 inaudible] of their business and it's going to really kind of [0:35:01 inaudible] everyone in Hawaii. There is more special education practice when more children are having [0:35:10 inaudible] disabilities, all the health issues that come from vaccines. Another thing in the philosophies of the Department of Health is these philosophies of health [0:35:24 inaudible] physical, natural and social environment [0:35:26 inaudible] is a right and responsibility of all Hawaiian people. So it is our right to help and anyone that knows anyone that's been injured by vaccine know that this is not helping the health and anyone that is [0:35:42 inaudible] didn't have [0:35:42 inaudible] sickness from someone who had the vaccine because they said and they can't cause some of these diseases instead many others not helping the health of the children. Even the less severe adverse effect that [0:35:57 inaudible] family. None of my children have been vaccinated but [0:36:01 inaudible] and he's on [0:36:04 inaudible] developmental [0:36:06 inaudible]. She has ADHD. She has severe [0:36:11 inaudible] age, she had to be in therapy. She had [0:36:15

[inaudible] vaccines by the way and [0:36:20 inaudible] give her a lot of that. And looking it now, she's on 5th grade and [0:36:23 inaudible] daughter a major [0:36:27 inaudible] issues and [0:36:30 inaudible] for the vaccines [0:36:33 inaudible] a lot of her issues but, again, [0:36:40 inaudible] a lot more worse for families [0:36:42 inaudible]. When children are going this issues, [0:36:46 inaudible] seizures and death. It's way more safe for them [0:36:53 inaudible] whole state if this would happen on [0:36:56 inaudible] vaccines [0:36:58 inaudible] tons of families having a lot more stress and a lot more challenges to deal with health, with education, with [0:37:06 inaudible]. It's going to be really difficult and I just -- it is a big priority that the Department of Health is [0:37:17 inaudible] to happen if it's going to be that -- the weight, the heaviness, the responsibility of all of the [0:37:27 inaudible] that can happen. It's going to be tied to this because of the Department of Health and I want to make sure that the board of member of the Department of Health will help consider that that more children died in our state only because of this choice here must be responsible for that despite the people and other [0:37:47 inaudible] history that if there's a decision had been made, lives could have been save. After the infertility which is [0:37:57 inaudible] having infertility, [0:38:01 inaudible] infertility in Hawaii, I don't think it's exciting for everybody especially for people [0:38:07 inaudible] this is where more Hawaiian people live and if infertility rate goes up to, you know, goes 75% because of this HPV vaccine or, you know, we're talking about the [0:38:19 inaudible] of the Hawaiian people and there is huge heavy weight to have Department of Health to have the weight on their shoulder. [0:38:28 inaudible] children for causing so many health problems for as long as [0:38:34 inaudible]. One more point I wanted to make about this -- another thing that goes to the Department of Health [0:38:42 inaudible], the first one was ensuring that the health department [0:38:46 inaudible] I kind of [0:38:53 inaudible] here. I know there can be a lot more people [0:38:55 inaudible] so I'm not the last one. It was about family. Your goal is to promote [0:39:02 inaudible] and integrity of families and communities and [0:39:07 inaudible] update you the [0:39:08 inaudible]. It's going to tear up family with [0:39:12 inaudible] school makes the parenting work and that they don't have to set home school [0:39:17 inaudible] that a lot of people cannot afford that especially [0:39:22 inaudible] independent families. And if it's going to make everything [0:39:26 inaudible] for everyone, many people might [0:39:29 inaudible] which you won't care probably because [0:39:32 inaudible] but it's if you could think [0:39:35 inaudible] these children in schools, if you can [0:39:42 inaudible] and the other important ones to bring up [0:39:46 inaudible] in the school and giving them -- our children [0:39:51 inaudible] it's because of [0:39:53 inaudible] allergies. It has all this other ingredients that when we look at the dangers of vaccine in National Vaccine Injury for the [0:40:03 inaudible] program, the number one, the highest compensated vaccine is the flu shot. And over almost 3,000 cases of people having compensated and make it \$250,000 if a child die from it and, you know, it doesn't make up for a life, you know. No amount of money can impact the

life of a child that's been killed by a vaccine. So there is no -- it's not [0:40:29 inaudible] make it better, you know, but it also showed that some -- other people aren't [0:40:34 inaudible] from it and all [0:40:37 inaudible] going to try and use it better because they know it's wrong and the funding by pharmaceutical companies that are trying to keep on -- keeping this [0:40:47 inaudible] and, you know, hurting the children and it's not okay. There's a huge resistance. There is [0:40:53 inaudible] many children not going to school [0:40:57 inaudible]. So I think it's very important [0:41:00 inaudible] to know that there's many people who's opposed this. I mean, I am [0:41:03 inaudible] because I know so many people that are [0:41:07 inaudible]. And I've learned information online tons of people are sharing it, many people sent email testimonies and because people didn't send an email or didn't show up to this hearing today, there's huge and tons of people out there, I mean, Big Island especially, a lot of people that are in the national already not into, you know, they're [0:41:30 inaudible] for the injection to the blood stream of vaccines. It's a huge decision. And it is [0:41:36 inaudible] where children cannot go to school without them, then you're going to see a huge resistance for these people are already upset and it's going to cause a lot of problem. It's going to really affect our estates and I'm hoping that today [0:41:57 inaudible] strong enough [0:41:57 inaudible] in a positive way so that we cannot be like [0:42:02 inaudible] considering no other state has this many vaccines. We don't even know what it's like [0:42:09 inaudible] together, the combination of that many, you know, just be adding really unsafe. Who's the people say that HPV over 500 people died in that and over 5,000 have -- people [0:42:24 inaudible] and so we don't know how [0:42:30 inaudible] a huge, you know, Department of Health [0:42:34 inaudible] this is not okay and we're not going to just talk [0:42:37 inaudible] and I'm sure the doctors are not [0:42:40 inaudible] a lot of people are upset if their children can't go to school now and that will affect the education. It's better than seeing the terrible effect if everyone started doing this and all of these children [0:42:57 inaudible] severe ones [0:43:05 inaudible] our community. [0:43:08 inaudible] Wednesday, I didn't see a bunch of data and information but it is out there and I know the other parents have [0:43:15 inaudible] testimonies and for anyone, [0:43:20 inaudible] that there's anyone here that support it. If you [0:43:25 inaudible] not like some -- if you [0:43:27 inaudible] do that are probably aren't [0:43:31 inaudible]. There's so much scientific evidence [0:43:34 inaudible] the actual, the data that you provide some of the CDC research. I mean, all of this, you know, even that all of the stuff, I mean, they're probably controlling but they're still showing nothing, you know. It all depends to all of these problems. And [0:43:51 inaudible] the Department of Health [0:43:52 inaudible] this year, are a moderator?

**Gm:** Moderator. I'm the hearings officer.

**Christina Jung:** Okay. [0:43:56 inaudible], you know, it really shows that they don't care. I know [0:44:01 inaudible] but this is a major problem [0:44:04 inaudible] this

is [0:44:06 inaudible] especially when it comes to health and freedom and informed consent, our right to choose what goes into our bodies that they do not even care to do that. And that goes that, you know, we have to be [0:44:17 inaudible]. This is not okay. it's not going to [0:44:21 inaudible] and, you know, [0:44:26 inaudible] you're not going to [0:44:30 inaudible] people and they did not even come to hear us [0:44:32 inaudible] that. And it's just Department of Health, you know, great mission statement, great goals, great philosophy but if you really care about the health of people of Hawaii, then [0:44:48 inaudible] updates. There's also hearings [0:44:50 inaudible] say about it and [0:44:52 inaudible]. The law that made it [0:44:56 inaudible] Department of Health is in charge of this instead of [0:45:01 inaudible] shows that that means the same. You know, that law made it so that this people that aren't even care to show are making these decisions [0:45:09 inaudible]. We need to change that law too, it's just wrong because [0:45:18 inaudible] Department of Health [0:45:22 inaudible] but this one is wrong. This one is not okay. And you can see, you know, [0:45:29 inaudible] they get incentive for putting the vaccines and [0:45:36 inaudible] doctor's office, you know, no child [0:45:38 inaudible] you know, all of the [0:45:44 inaudible]. You know, it's not there. They're saying, oh, it's there [0:45:48 inaudible] over half a million kids have been hurt. And [0:45:54 inaudible] it's not happening. So whatever -- Department of Health needs to change this, to stop these updates. And I honestly don't know what that is but it needs to be done. if they're not going to come here [0:46:12 inaudible] people and there's tons of parents who's vaccine injured children that if they hear their stories, [0:46:20 inaudible] I've only experience the severe reactions but [0:46:26 inaudible]. The people that actually experience losing a child or all of the tragic things involved with [0:46:37 inaudible] vaccines, then maybe we change that. So I'm hoping the Department of Health [0:46:43 inaudible] to protect the people and so [0:46:50 inaudible] vaccines is not helping -- it's not going to help the health [0:46:56 inaudible] the exemption is a major concern. We [0:47:03 inaudible] to get medical exemption is a major concern because [0:47:11 inaudible]. I strongly oppose this updates [0:47:19 inaudible] proposal update and there's going to be a lot [0:47:22 inaudible]. We are not going to let this happen. I know lots and lots and lots of people, hundreds on the Big Island that will [0:47:29 inaudible] against this even if they're not here at this hearing. They're going to send email. There's a huge [0:47:35 inaudible] going on if [0:47:37 inaudible] on going and the people in the Department of Health that are responsible for making this decision are going to have the karma, the weight, the [0:47:47 inaudible] hands of children dying and having, you know, these disabilities, all of that [0:47:52 inaudible] of these making this decision now. So I [0:47:55 inaudible] about that Department of Health [0:47:59 inaudible] decision makers, please consider that that when the death rate of children in Hawaii goes up, it will be because of you and this decision you're making now. So thank you for the [0:48:11 inaudible] testimony and I know a lot more people are showing up. I know a lot more people will be

here. So I'm not the last. And please consider the severity of this decision. Thank you.

**Gm:** Okay. Rn Andrade? Can you state and spell your name for the record?

**Ron Andrade:** I'm Ron Andrade, R-O-N A-N-D-R-A-D-E. I'm sorry, I don't have [0:48:48 inaudible] and I originally wasn't going to speak but I want to have all the facts [0:48:55 inaudible] or I'm not here to debate anything. I just want to say that I have one -- two children, my son is 18 and that he is vaccine [0:49:06 inaudible]. And so my daughter is 5 years old. When she was 4, I did a lot of expensive boosters and then I started to see that it wasn't okay to vaccinate my daughter. So my daughter is vaccine-free and I feel like it should be my decision to make to vaccinate my child. I don't think it's helping that any government should be pushing. My daughter is not a wish to the public. If anything, the public ever wish for my daughter is if she's unvaccinated. So I guess that's all I wanted to say and I'm against pushing this mandatory vaccinations [0:49:49 inaudible]. And if it will go through, I'm going to home school my daughter. She just [0:49:54 inaudible] a really good school that is a high school and it is [0:49:59 inaudible] the Department of Education. But if this law does take place, I'm pulling her out and I'm going to home school her and this is going to happen to a lot of public students who [0:50:10 inaudible] as I do. And then as [0:50:13 inaudible] funding for each child that is [0:50:15 inaudible] because of their decision. So I am against this and thank you for having me.

**Gm:** Cynthia Carpenter. Is there a Cynthia Carpenter here?

**Cynthia Carpenter:** [0:50:34 inaudible]

**Gm:** Yes.

**Cynthia Carpenter:** Okay. So...

**Gm:** Could you state your name and spell for the record, please?

**Cynthia Carpenter:** I'm Cynthia Carpenter, C-Y-N-T-H-I-A Carpenter, C-A-R-P-E-N-T-E-R. [0:50:51 inaudible] because I [0:50:53 inaudible] this day and so my husband is a [0:50:58 inaudible] when [0:51:03 inaudible] 32 years old. He's 32 years old when he got vaccinated [0:51:09 inaudible] bad reactions [0:51:11 inaudible] at that time. And so my husband going into medical school, he did a ton research, he said, no, no, more vaccinations. So he told me [0:51:22 inaudible] over the years about it and he's a medical guy. So [0:51:27 inaudible] we had our other children, no vaccination, [0:51:30 inaudible] children, they don't get vaccination [0:51:33 inaudible] and healthy. As a physician, he's [0:51:38 inaudible] doesn't have to give vaccination. He only gives them -- he did the doctor [0:51:49 inaudible] because there's so much

[0:51:53 inaudible] information put out there by the big pharmaceutical companies. He [0:51:58 inaudible] other than [0:52:01 inaudible]. He doesn't like big pharmaceuticals at all but he still doesn't think [0:52:08 inaudible] so he doesn't have to, you know, [0:52:13 inaudible] he wants to [0:52:14 inaudible] alternative treatment but he frankly he doesn't have to take that choice. So he has his own choice for his own family to this people that he knows a lot of information until we [0:52:31 inaudible]. But they have [0:52:34 inaudible] school. We're lucky where my husband could write a waiver. If we want to, we can go there and go to school. Here, if it became mandatory, he'll write a waiver. He will write them for anyone who wants [0:52:49 inaudible]. He is [0:52:53 inaudible]. Anyway, so I would be so sad
