EMR/HEMSIS medical records system selected. Plan to implement ~ 1st of the year. NEMSIS 3.0 compliant. 3.4 data set more robust.

Maui EMS medical director, Dr. Mirek Szatko, officially starts today.

Trauma. TECC course = KapCC: Nov 9 & 10; Fed Fire: Nov 13 & 15, 18 & 19; register via website. Updates: Executed agreement with Castle Medical Center; Maui Memorial Medical Center level 3 review next week; ECHO system case base learning platform; peds trauma Nov 18.

Air Medical Committee. New air ambulance company has Honda jet. Bariatric; Coast Guard formalize contracts
