EMS Spring 2025 cohorts and enrolled students

EMT Oahu (civilian):15EMT Hilo (HFD and civilian):17EMT (recruit) Kauai Fire Dept:6MICT Statewide:17 (8 Oahu, 5 Maui, and 4 Hawaii Island)

KapCC Students

Eighteen students graduated from the EMT program in the Fall of 2024. Most have passed the NREMT on their first attempt and are applying for their licenses at the DCCA.

Four KFD and PMRF EMT recruits completed the EMT-1 (non-transport) program in Fall 2024.

Hawaii CC Pālamanui Campus

Hawaii CC in Hilo and its Palamanui campus in Kona plan to do EMT (transport) courses in Spring 2025.

Neighboring Island EMT Programs

Kauai is projected to offer an EMT (transport) course in Fall 2025. Kauai CC counselors have been encouraging potential students to enter the healthcare field.

Maui EMS Training Center will also have an EMT (transport) course in Fall 2025.

Community Health Workers

Lanai will have an Emergency Medical Responder (EMR) course in the Summer of 2025. Maui EMS Training Center (MEMST) faculty will teach this course.

Paramedic Stipend

Ten students (five from Maui and five from Oahu) received the paramedic stipend from September to December 2024. The Maui students and one Oahu student are projected to receive an employer-sponsored scholarship, and another Oahu student will be sponsored by their respective agency.

CME Update

Oahu: The Continuing Medical Education (CME) refresher courses through the Health Education Non-Credit Department (<u>HENC</u>) are temporarily on hold due to a lack of enrollment. Each class must have a minimum of ten students. It's projected to restart close to the time for recertification.

Department of Emergency Medical Services

Maui: They continue to schedule their CME courses through HENC for the calendar year. Kauai: CME courses are done as requested by the contracted agency. Hawaii: CME courses can be done upon request.

Faculty Staff Openings

Oahu: Four candidates applied for the two open faculty positions. They are undergoing a screening process to evaluate their minimum and desired qualifications. Interviews are projected to occur later this month. We are hopeful two will be hired during the spring semester.

Oahu: Eight candidates applied for the office assistant position. They are undergoing a screening process to evaluate their minimum and desired qualifications. Interviews are projected to occur later this month. We are hopeful at least one, if not two, will be hired during the spring semester.

Maui: The office assistant position has been approved and is awaiting HR to post.

KapCC has one faculty on administrative leave.

Accreditation Site Visit

The Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP) will visit Kapi'olani Community College in Fall 2025. The site evaluators are expected to tour the training centers and emergency departments in Oahu, Maui, and Hawaii. They will also interview current and former students, faculty, mentors, nurses, physicians, and administrators. The purpose of accreditation is that the National Registry of Emergency Medical Technicians (NREMT) requires all paramedic applicants to graduate from an accredited program. The NREMT certification is a requirement for state licensure. Thus, it is essential for the public safety of our communities. Otherwise, students would have to go to the mainland for training.
