The State of Hawaii, Department of Health (DOH), received a letter from Group 70 International requesting that the DOH decision making time on the HDF FEIS be extended by eight (8) calendar days to Friday, February 24th, 2017. DOH is granting this extension request as the accepting authority for the HDF FEIS. Per Hawaii Administrative Rule, a request for an extension of the 30 calendar day decision making period is permissible under 11-200-23(d).
