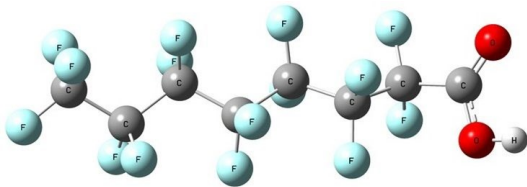
Ewe annuk

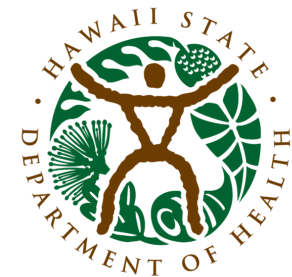

Chon nesopwenon eaeen ren mettochun pakechin mongo kena:

- Nenien mongo kena (watte me pwan kukun)

Meta asiwinin kena ra kan kaworeno?

Kose mochen eaea eom kewe awukukun ren pisekin pakechin ra wor reomw me pwan order pisekin pakech kena ra fofor ngeni non mwach kaan. Kuut ren **maaken ese wor PFAS kena** ika afatano ewe fonu a etto me ie – **pakechin awukukun ren mongo ra forino non ekkewe U.S.** resapw chuen no masow ren PFAS pokiten ren an ewe U.S. Food and Drug Administration achochon ne asopwano eaeen ren PFAS non pakechin mongo. En ka pwan tongeni tungor echo taropwen afateno seni eomuwe chon inetiwow pwe ewe pakechin a kan fofor ngeni.

Asiwinin mettochun pakech kena mei pachenong:

- Mettochun taropwe kena rese kan tukutukuno
- Foil ika mettoch kena ra tukutukuno ren foil
- Bioplastic ika mettochun bioplastic-foamed kena
- Awunununon mettochun fiber kena fiti tukutukun bioplastic kena
- Mettochun nenien iseis mei for seni taropwe (awewe, clamshells ika waa kena) fiti clay, wax, ika tukutukun bioplastic kena
- Chon taropwe kena me pwan paik kena fiti wax ika tukutukun bioplastic kena

Bioplastic kena ra kan forino seni eaeen kirisin vegetables kena ika oil kena, corn starch, me pwan ekkoch nenien angaiin pisek kena ra tongeni eaea sefan.
