

Ka 'Ike Kahua

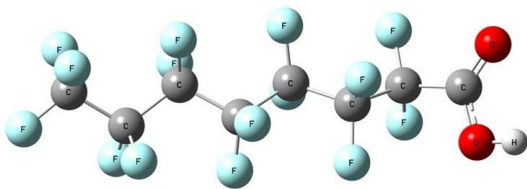
Ke kānāwai

Ma ke kānāwai 152 (2022) pāpā 'ia ka hana kāpili 'ana, ke kū'ai 'ana, a me ka ho'omalele 'ana no ke kū'ai 'aku a i 'ole no ka ho'ohana 'ana i nā wahī pepa mea'ai i hana 'ia me ke kemikala 'o perfluoroalkyl a me nā 'akano polyfluoroalkyl (i kapa pū 'ia nā **PFAS**).

Ho'ohana 'ia ia mau kemikala no ka hana 'ana i nā wahī mea'ai i mea e 'a'alo 'aila, 'a'alo wai, pipili 'ole, a palahe'a 'ole.

No ke aha e pāpā 'ia ai nā PFAS?

'O nā PFAS kekahi mau kemikala wāwahi 'ole i ke au o ka manawa, a hiki ke ho'āhua ma ke kaiapuni a ma ko kākou mau kino, e ho'okumu ana paha i kekahi mau pilikia olakino. Hiki ke haumia ka mea'ai i ka pā 'ana i kekahi wahī i hana 'ia me nā PFAS.

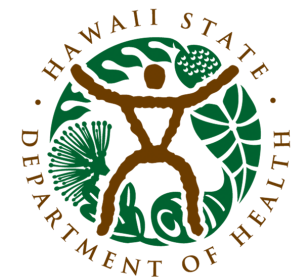

Āhea e hoʻomaka ai ka pāpā 'ia 'ana o nā PFAS?

He aha nā mea i pāpā 'ia?

Pāpā 'ia nā wahī mea'ai **A PAU LOA** i hana 'ia me nā PFAS .

Eia kekahi mau la'ana o nā wahī a hōkelo ho'i e koi 'ia ana ka LOA'A 'OLE o nā PFAS:

- Nā wahī a pepa pale
- Nā pā
- Nā hōkelo "clamshell"
- Nā pola 'ano "wa'apā"
- Nā pahu paipika

'O wai ka po'e pili i kēia kānāwai?

Ka po'e ho'ohana i nā wahī mea'ai:

- Nā Hui Hana Kāpili Mea'ai
- Nā 'Oihana Ho'omalele i nā Lako Lumi Kuke a me nā Hale Kū'ai
- Nā Hale 'Aina (nui a li'ilii' kekahi)

He aha nā koho 'ē a'e?

E ho'ohana i nā wahī mea'ai o kāu waihona i loa'a 'ē a pau, a e 'oka i nā wahī hou kū i ke kānāwai ma kēia mua aku E 'imi i nā **lepili PFAS-free** a i 'ole e hō'oiia i ke kaumoku'āina i hana 'ia – **'oiai 'o nā wahī kūlana-me'a'ai i hana kāpili 'ia ma 'Amelika** 'o ka pololei, 'a'ohe PFAS ma muli o ka ho'ā'o o ka U.S. Food and Drug Administration e kāpae i ka ho'ohana 'ia 'ana o nā PFAS ma nā wahī mea'ai. Hiki iā 'oe ke noi i palapala hō'oiia mai kāu 'oihana ho'omalele kekahi, no ke kūpono 'ana o ka wahī i ke kānāwai.

'O kekahi mau koho wahī mea'ai 'ē ae, 'o ia ho'i:

- Nā mea pepa papa 'a'alo 'ole
- Ka pepa kini a i 'ole nā mea pale pepa kini
- Ke ea i hana 'ia me nā mea kūlohelohe 'o ia ho'i 'o bioplastic a i 'ole nā mea hu'a i hana 'ia me bioplastic
- Nā mea ma'awe i hō'omo'omo 'ia me nā pale bioplastic
- Nā hōkelo pepa ('o ia ho'i, "clamshells" a 'ano "wa'apā") me ka pale pālolo, pīlali, a i 'ole bioplastic
- Nā 'āpana pepa a 'eke paha me ka pale pīlali a i 'ole bioplastic

Hana kāpili 'ia nā bioplastics me nā 'aila meakanu a 'ailakele paha, ka pia kūlina, a me nā mea kūlohelohe 'ē a'e.

E maka'ala ho'i i nā kānāwai kūloko o ke kalana e pāpā 'ia ana nā wahī mea'ai ea i hana 'ia me ka 'aila kā, e like ho'i me ke Kānāwai o ke Kaona a Kalana 'o Honolulu 'o ia ho'i ka Disposable Food Ware Ordinance.
