For example, sources of funding such as the Clean Water and Safe Drinking Water State Revolving Funds, can be used to address many security needs at wastewater and drinking water facilities.

(The mid-year meeting of NASTTPO is being held Dec. 5 in conjunction with Nevada's Hazmat Explo on Dec. 2 - 6 in Las Vegas, NV.)

LEPCs and Deliberate Releases: Addressing Terrorist Activities in the Local Emergency Plan (August 2001).

In recent years, the threat of incidents involving chemical and biological materials has increased. This fact sheet discusses how LEPCs can incorporate counter-terrorism issues when they review and update their local plans.

Chemical Safety Alert -- "Chemical Accident Prevention: Site Security" (February 2000). As a precaution during this heightened state of alert, the U.S. EPA in coordination with the U.S. Dept. of Transportation (DOT) and the Federal Bureau of Investigation (FBI) suggests that those who manufacture, distribute, transport or store hazardous chemicals should be especially vigilant regarding the physical security of those chemicals. In addition to this EPA advisory, DOT has produced a separate advisory for transporters, available by contacting DOT at (202) 366-6525. The FBI requests that you expeditiously report any threats or suspicious behavior to your local FBI field office.

Chemical Safety Alert -- "Chemical Accidents from Electric Power Outages" (September 2001). EPA issued this alert as an outcome of this year's energy crisis in California. However, the alert is also applicable for precautions during stormy weather or times of threats from terrorist acts that could impact the power grid.

NRT-1 Hazardous Materials Planning Guide (Updated July 2001) - This guide fulfills a Congressional requirement that the National Response Team provide unified federal guidance for hazardous materials emergency planning and presents a federal consensus on which future guidance, technical assistance and training will be based. This updated version of NRT-1 includes guidance on integrating LEPC plans with planning requirements contained in recent federal legislation.

The National Institute of Chemical Studies (NICS) training materials and reports for EPA include a "Sheltering-in-Place" training CD which will be available soon from the NICS website (www.nicsinfo.org). Two reports will also be available: (1) Sheltering in Place as a Public Protective Action, and (2) Local Emergency Planning Committees and Risk Management Plans: Encouraging Hazard Reduction.

Chemical Facility Vulnerability Assessment Project

Sandia National Laboratories, under the direction of the Office of Science and Technology, National Institute of Justice is conducting the Chemical Facility Vulnerability Assessment project. This project is in response to the FY 2001 Appropriations Bill, which directs the National Institute of Justice to develop, test and validate a prototype methodology for assessing the security of chemical facilities against terrorist and criminal attacks. 

SUBJECT: Protocol on How to Handle Anthrax and Other Biological Agent Threats for the City

and County of Honolulu

The activation of emergency response agencies to allay public concerns regarding possible anthrax exposure or exposure to other toxic substances requires established protocols for first responder agencies to utilize. The effective and appropriate use of our emergency response resources dictate we all follow established protocols to handle anthrax and other biological agent threats.

The Department of Health (DOH), in conjunction with law enforcement officials, fire and HAZMAT teams, as well as civil defense has established the following protocols for use prior to the transportation of specimens to the State Laboratories Division (SLD).

The protocols assume that an individual who receives a suspicious letter or package will call 911 for assistance.

Protocols have been developed between the United States Postal Service and law enforcement officials to determine if a letter or package is deemed to be suspicious in origin and content.

Fire Department

An individual questioning the safety of an open or closed letter or package which originated within the US Postal System, and not originating from any other commercial carrier, and does not exhibit signs of leakage or visible substances, will be referred by Fire Department to call the Postal Inspector in Hawaii (423-3790 [24 hours]). The postal inspector will then respond back to the individual within an hour as to the verification and legitimacy of the letter or package according to predefined criteria. If the verification of the origin of the letter or package meets US Postal System criteria for a non-threat then no fire or police response will be initiated. Resolution of the investigation by the US Postal Inspector will be reported to the HPD and HFD.

If the Fire Department should receive a 911 call that an individual received an **opened** or **closed** suspicious letter or package exhibiting signs of leakage or unknown substances then a Fire Department representative will initiate an HFD dispatch under existing response protocols

An individual questioning the safety of a letter or package which originated *outside* the US Postal System, and does not exhibit signs of leakage or visible "substance" will be instructed to contact the commercial carrier for consultation and instruction. If the Individual refuses and wants the HFD to respond to their requests then the HFD will initiate a dispatch to the scene.

The Fire Department will dispatch a HAZMAT team for appropriate response if there are signs of an unknown suspicious substance. The Fire Department's Assessment Teams (A1 or A2) will respond to unopened letters or packages and conduct an assessment of the situation. The HFD, via the State Epidemiologist, will notify the individual if the test result is positive, otherwise the HFD will instruct the individual that they will not re-contact individual if the results are negative.

Any samples collected will be placed in an approved Department of Transportation (DOT) container (Saf-T-Pak). When appropriate, the HAZMAT team will decontaminate the area where the suspicious letter or package was found.

Each suspicious letter or package will be accompanied by a chain-of-custody document, as well as an incident threat checklist.

The HAZMAT team will not open a suspicious letter or package at the scene and therefore will not be able to verify its contents. The HAZMAT team will transport the item to a designated location at a mutually agreed upon time. The Hazard Evaluation and Emergency Response Office (HEER) will transport unopened items from the Fire Department's Assessments Teams to the State Laboratories Division (SLD).

If a field test (Guardian System) is warranted/requested and is available, negative and positive results will follow as detailed below.

Fleid Test Results for Bioagent Identification

Negative Results

If the field-test on the letter or package results is a **negative** determination, the HAZMAT team will transport the letter or package to a designated location for the final disposition of the specimen.

Positive Results

If the field-test on the letter or package results in a positive determination the HAZMAT or HEER Office will transport the letter or package to the SLD for conventional microbiological analyses. The HFD/HAZMAT will contact the FBI and US Postal Office if an environmental sample is presumptively found to be positive on a field test.

Police Department

If an individual calls the HPD to report a suspicious letter or package originated within the US Postal System, and not originating from any other commercial carrier, and does not exhibit signs of leakage or visible substance, the Communications Division will obtain the caller's name, address and telephone and inform the individual the case will be referred to the US Postal Service. The US Postal Inspector's office will call the individual within the hour to assist with the letter or package. HPD will notify the Oahu Civil Defense Agency of postal

referrals. If the individual refuses to wait for the postal inspector's results, or requests to meet with a police office, HPD may dispatch an officer and a detective to the scene. The officer/detective will contact the US Postal Inspector in an attempt to resolve the case. If the case can not be resolved, the Honolulu Fire Department will be notified for assistance.

If an Individual calls the HPD to report a suspicious letter or package originated *outside* the US Postal System, the individual will be instructed to contact the commercial carrier to pick up the letter/package. If the individual refuses to contact the commercial carrier, an HPD officer and detective may be dispatched to the scene. The assigned investigator may contact the commercial carrier in an attempt to resolve the case. If the case can not be resolved, the Honolulu Fire Department will be notified for assistance. The US Postal Inspector will not be notified unless the US Postal Service is involved.

When it is suspected that a letter or package may contain an explosive device, the Specialized Services Division will be called to examine the item before it is handled by the HFD/HAZMAT Team. HPD Offices will not handle the suspicious letter or package, transport it, or take it into evidence.

Closure of a public or private facility will be based on a credible threat and the Incident Commander's decision to proceed with closure of the facility in question. The on-scene Incident Commander will notify the Oahu Civil Defense Agency who in turn will contact State Civil Defense for multi-agency coordination.

The Federal Bureau of Investigation (FBI)

Upon request the FBI will provide first responders with the following support via conference calls (566-4300 [24 hours]).

- 1. Immediate access to scientific information (e.g., suggestions involving probable identification of substances).
- 2. Immediate assistance with HAZMAT response (i.e., isolation, containment and field screening protocols).

The FBI will be notified by HAZMAT after one positive field test. The FBI will also be notified if an articulated or implied threat is present, or in cases of a hoax letter(s) or package(s) containing a "powdery" substance. This included all letters and packages, regardless of the manner of delivery. The Director of Health, or designee, will notify the FBI of any clinically or laboratory confirmed cases of a bioagent.

The FBI has been assigned the lead federal law enforcement role in biological terrorism investigations. Early notification will enable the FBI to begin coordinating investigative resources.

If the threat assessment is determined by the FBI to be credible then the FBI will assume responsibility for crisis management.

The Hazard Evaluation and Emergency Response Office (HEER)

Upon receipt of a request for assistance from the Fire Department's HAZMAT team, the HEER Office State On-Scene Coordinator will respond with technical support. The HAZMAT team, in conjunction with the HEER Office, will conduct a reasonable threat assessment to determine if the letter or package contains material considered to pose a public health risk to the individual or community.

The HEER Office will notify the SLD on-call personnel of an in-coming letter or package for analysis.

Only samples of packages will be sent to the SLD for analysis. Packages that do not fit into a Saf-T-Pak container will require a sample to be sent to the SLD for analysis. The HEER Office will transport a properly packaged letter or sample to the SLD for analysis. The remainder of the package will be placed in a predefined site awaiting final disposition.

At a request/determination from the HEER On-Scene Coordinator, a request may be made for the Police and/or Fire Department(s) (HAZMAT) to escort the letter or package to the SLD.

State Laboratories Division

The SLD will perform conventional microbiology techniques to issue a presumptive and confirmatory analysis as to the potential of the letter or package in question having been contaminated with a biological agent that may pose a public health threat to the individual or community.

The State Laboratories Division will enter all results on their specimen tracking system and make available to Police Department, Fire/HAZMAT and others via e-mail. If the results from culturing samples/swabs are determined to be negative by the SLD, the Oahu Civil Defense Agency (523-4121) will notify the individual(s) who submitted the letter or package in question.

In order for the SLD to obtain military support for a "rapid" analysis and identification of a bioagent the on-call SLD personnel will notify the Department of Health's Civil Defense Coordinator to contact State Civil Defense via formal channels of notification.

SLD Rapid and Conventional Methodology for Bioagent Identification

Negative Results

The SLD will contact, via e-mail, multiple agencies with test results (i.e., Fire/HAZMAT, Police and the DOH and Civil Defense. Kauai, Maui and Hawaii Counties will be contacted with results by the SLD.

Positive Results

- 1. Environmental Sample: Positive results will be reported by the SLD to the State Epidemiologist. The State Epidemiologist will then initiate a disease outbreak investigation to determine the source and extent of the exposure and recommends prophylaxis and disease control recommendations. The State Epidemiologist will contact the DOH Civil Defense Coordinator who will In turn contact the appropriate County and State agencies of the positive environmental sample results. The State Epidemiologist will call 911 if a positive environmental sample is determined by the SLD.
- 2. Clinical Sample: The SLD will contact the Department of Health, Epidemiology Program of a positive result. The State Epidemiologist will then notify the individual's health care provider of the test results and will recommend to the health care provider treatment and control recommendations for the individual. Health Care Providers and laboratories must notify the DOH, Epidemiology Program of all positive anthrax cases by law (Hawaii Disease Reporting Requirements).

- 3. The Civil Defense Coordinator for the DOH will contact SCD of any positive results in the event additional coordination is required.
- 4. The response for mass prophylaxis and treatment will be under the administration of the Department of Health. Closed and/or contained outbreaks may be able to be handled by health care providers with possible assistance from the DOH.

Final Disposition of the Letter or Package

Fire/HAZMAT representatives who accept a suspicious letter or package for potential analysis will indicate to the individual requesting the assistance that the contents of these items will not be returned (unless requested by law enforcement to hold as evidence in a potential criminal investigation). The letter or package will be retained/stored for 30 days and then disposed of by the SLD (if it is physically located at the SLD). Letters or packages retained/stored by the Fire Department or County District Health Offices will be disposed of by the responsible agency.


Screen positive cases awaiting CDC lab results (n = 8)






CDC Confirmed Dengue cases by week of onset



CDC Dengue Confirmed Cases - updated 11/07/01




Number of Days from Symptom Onset to Blood Draw* / Method of Confirmation CDC Confirmed Dengue Cases





UH ready to revive School of Public Health

In its new incarnation, it could become a source of expertise for the state on both bioterrorism and unexpected threats such as the recent outbreak of dengue fever.

Dr. Edwin Cadman, dean of the John A. Burns School of Medicine, expects to name a new associate dean of public health within the next six weeks. Four additional epidemiologists already have been recruited for the faculty and for research.

After it lost accreditation in mid-1999, remnants of the School of Public Health became part of the medical school. Cadman is pushing to regain accreditation in epidemiology, the first of five areas of strength the school must build. The other four are biostatistics, behavioral health, environmental health and healthcare policy.

"This state needs to have a presence in public health and there's no better way to do this than get the school reaccredited," said Cadman, who has championed a reinvigorated School of Public Health since the first week he took over at the medical school two years ago.

"When they disaccredited it, it became part of the medical school. What we're committed to is reaccrediting it and splitting it off," he said.









That could happen as quickly as four years, considered "fast-tracking" in academic circles. Accreditation in epidemiology could come as early as spring, when the Council on Education for Public Health, the national independent accrediting body, makes a site visit.

"What we wanted to do was work on the educational program that most people in this country want to be trained in," said Cadman. "Seventy percent are in epidemiology. The epidemiology of disease — that's what dengue and anthrax is about."

While none of this recent activity is a direct result of the anthrax scares or the dengue fever outbreak, both have given new urgency to the effort to rebuild a strong and broadly based system of graduate degrees in public health.

"We would have expertise in some of these areas, and we would be a resource for the state," said Cadman. "Instead of calling people on the Mainland, we would have the intellectual resources."

F. DeWolfe Miller, chairman of the public health services department within the medical school, has been leading the drive to reaccredit a School of Public Health.

"It's like night and day," said Miller. "We've gone from having a lack of academic value (for public health) to support. It's so refreshing to have that. I'm wedded entirely to this vision."

When the school closed in June 2000, the research budget for public health was nonexistent; now it's \$1.5 million annually, and growing. Commitments for research funding pulled in by the medical school as a whole have doubled in the past year, growing to approximately \$60 million this year.

The dramatic increase in research money will help underwrite rebuilding public health capabilities, said Cadman.

An equally important reason for rebuilding the school is the traditional role it has played in training health officials throughout the Pacific and Asia, its supporters say. "Pick an Asian country," said Cadman, "and we've trained somebody there."

OSHA requirements must be taken into consideration. 2) For the training that is provided by the State, he would like to know what funds were available and what was spent. Clem Jung will provide the information. 3) Status of the Hawaii Emergency Response Plan, Annex M. Initial requirement was to have it completed by 9/30/00. A vender was interested but could not meet the deadline so vender did not bid. This vender is questioning present contract because deadline has not been met.

 - 1.1 Minutes from meeting #42 were adopted with no changes. (Bowen/Ikeda)
 - 1.2 Legislature. Gary Gill-Pay extra attention to upcoming bills that may raid special funds which may include the ERRF.
 - 1.3 Mercury spill-Gary Gill gave an update of the mercury spill. The pump station (source of mercury) has been completely cleaned up. The total cost of the clean up is estimated to be \$800,000. There is an "Agreement in Principle" with DLNR to seek reimbursement of funds to the ERRF. Details for the settlement still has to be worked out with DLNR. The DOH has no inventory of all gauges with mercury.

2) LEPC Updates

2.1 Hawaii

John Bowen-1) By a majority vote of the Hawaii County LEPC, the Hazmat Awareness Training refresher will be 8 hours. 2) Refresher qualified can also be done by exam. 3) Participation in the Hawaii Electric Co. drill. 4) There is an abandoned ice plant in Hilo that has a history of leaks. There is an estimated 600 pounds of liquid ammonia on site. PENCO is contracted to remove the ammonia. It will be shipped to the mainland for disposal. A status report will be presented at the next HSERC meeting.

2.2 Kauai

Clifford Ikeda-1) The contractor is nearly completed with the update of the Kauai LEPC Hazardous Materials Response Plan. 2) Participated in several training sessions with the fire dept. 3) CST gave a briefing of future exercises. 4) At the June 25, 2001 Kauai LEPC meeting, a list of the current LEPC members were presented. List presented to the HSERC has to be amended because a member was inadvertently left out. 5) LEPC Chair attended a training conference in Anniston, Alabama. EMS is not prepared or capable for a huge mass casualty situation.

Leland Nakai-Gave update of the August 3, 2001 Honolulu LEPC meeting as follows: 1) The Honolulu LEPC members decided that specific hours for hazmat awareness refresher training should not be established. Employers need flexibility and should not be restricted to an hour-based training requirement. 2) Project to update the Honolulu LEPC emergency plan was not executed due to procurement process. Will resubmit a new project proposal. 3) Update of CLEAN by Jim Vinton. 4) Update of the NASTTPO Conference by Clem Jung. Ed Teixeira-1) Attended a WMD Conference that included a bio-terrorism exercise. 2) The exercise brought to light the lack in the healthcare facilities to address mass casualties. The healthcare facilities require resources to be able to prepare for mass casualties. 3) Suggest that letters addressing our concerns be sent to our delegates in congress.

3) HMEP Planning Grant: LEPC Project Proposals

Denis Shimamoto- The initial project proposals for the HMEP Planning Grant funds amounted to \$89,973, but the allocated amount is only \$52,585. The LEPCs met on July 31, 2001 to discuss the distribution of funds. A motion was made to distribute the funds in the following manner: Maui LEPC-\$4,500; Kauai LEPC-\$16,000; Honolulu LEPC-\$16,000; and Hawaii County LEPC-\$16,085 for a total of \$52,585. (Ikeda/Bowen) Unanimously approved. Kauai, Honolulu, and Hawaii County LEPCs will prepare new project proposals to meet the allocated funds distribution.

Clem Jung-The allocated funds are yet to be confirmed and projects cannot be executed until October 1, 2001.

4) NASTTPO 2002 Conference

Clem Jung-Gave an update of the NASTTPO Conference to be held in Honolulu on April 8-13, 2002. Registration is estimated to be \$270.00 and the agenda is about 95% complete.
