

HAWAII DEPARTMENT OF HEALTH (DOH) MANUFACTURED HEMP PRODUCT (MHP) RETAILER AND DISTRIBUTOR REGISTRY

IMPORTANT INFORMATION – Under no circumstances does a MHP Certificate of Registration issued by DOH – OMCCR allow a business to sell, hold, offer or distribute any of the following:

PROHIBITED FOR SALE
All viable hemp seeds, hemp flower or leaf material, including hemp pre-rolls, regardless of the labeled percentage or amount of tetrahydrocannabinol (THC) or tetrahydrocannabinol acid (THCA).
All vape cartridges, concentrates, etc. purporting to contain cannabinoids, including CBD.
Foods purporting to contain cannabinoids, like CBD (i.e., chocolate, honey, baked goods, candies, etc.).
Any allowable manufactured hemp product that exceeds total THC mg limits per serving and per container OR is above 0.3% total THC by weight.
Any product containing artificially derived or synthetic cannabinoids. This includes, but not limited to, cannabinoids, like delta-8 THC, THCO, HHC, CBN created from any hemp-derived cannabinoid, like CBD.

A MHP CERTIFICATE OF REGISTRATION DOES NOT ALLOW A BUSINESS TO SELL MHP THAT IS NON-COMPLIANT

The registrant is responsible for ensuring the MHP being sold complies with all Hawaii requirements, including:

- In a form allowed in Hawaii (i.e., topically applied; edibles - gummies, oil-based tinctures, beverages, tablets, capsules, powders, softgels, gelcaps).
- Does not exceed total THC limits on per serving and per package basis (if applicable)
- Meets lab testing requirements
- Does not contain restricted ingredients, including synthetic and artificially derived cannabinoids
- Properly labeled, including all advisory statements and consumer access to lab test results
- Child resistant packaging

DOH – OMCCR does not issue pre-market approval for manufactured hemp products or any product claiming to contain cannabinoids derived from hemp.

“Manufactured hemp product retailer” or “retailer” means a person selling manufactured hemp products to consumers and includes the person’s agents and employees.

“Manufactured hemp product distributor” or “distributor” means a person selling manufactured hemp products to a manufactured hemp product retailer and includes the person’s agents and employees.

“Temporary Event” means any event, market, fair, festival, or other gathering where manufactured hemp products are offered for sale to consumers that occurs only once or on an occasional basis, less frequently than once per month. Sale of manufactured hemp products at events that occur on a daily, weekly, or monthly basis, at the same location, such as farmers markets, is considered to take place at a retail location rather than a temporary event.
