



## INSTRUCTIONS FOR RE-APPLICATION FOR LICENSURE IN RADIOLOGIC TECHNOLOGY

### I. GENERAL INFORMATION

- A. REFERENCES: Title 11, Hawaii Administrative Rules, Chapter 44, Radiologic Technology Rules, as amended.

Hawaii Revised Statutes, Chapter 466J, Radiologic Technology

- B. MINIMUM ELIGIBILITY REQUIREMENTS FOR LICENSURE AS A CERTIFIED RADIOGRAPHER, CERTIFIED RADIATION THERAPIST, OR CERTIFIED NUCLEAR MEDICINE TECHNOLOGIST

1. Applicants applying in the field of radiography or radiation therapy must be currently registered with the American Registry of Radiologic Technologists (ARRT) in the appropriate field.

Applicants applying in the field of nuclear medicine must be currently registered with ARRT in nuclear medicine **OR** currently certified by the Nuclear Medicine Technology Certification Board (NMTCB).

2. Applicants must be of good moral character. Those who have been convicted of a crime must have their civil rights restored.
3. Applicants who are **NOT** ARRT-registered or NMTCB-certified are required to apply directly to the appropriate organization for examination, be accepted for an examination **and pass** the examination in order to be eligible for licensure.

- C. Section 466J-9 of the Hawaii Revised Statutes states that: It shall be a misdemeanor for any person, including any corporation, association, or individual to:
1. Sell or fraudulently obtain or furnish any radiographer's, radiation therapist's or nuclear medicine technologist's diploma, license, renewal, or record or aid or abet therein;
  2. Use in connection with the person's name any designation tending to imply that the person is a certified radiographer, a certified radiation therapist, or certified nuclear medicine technologist unless licensed to practice under this chapter;
  3. Practice radiologic technology during the time the person's license issued under this chapter is suspended or revoked; or
  4. Violate this chapter.
- D. The information requested of the applicant is intended for the use of the Radiologic Technology Board in connection with your application for licensure in radiologic technology. You are legally required to supply the information requested herein, and your failure to do so will prevent the Board from determining your eligibility for a license.

## II. DIRECTIONS FOR COMPLETING THE RE-APPLICATION

- A. Type or legibly print all information requested.
- B. Provide verification of current certification by ARRT or verification of current certification by NMTCB.
- C. Attach a recent photograph of yourself.
- D. Have the application notarized by a notary public.
- E. Submit a re-application fee of **\$120.00** by personal check or money order payable to the **STATE DEPARTMENT OF HEALTH**. If you are re-applying for more than one license, add **\$5.00 for any additional license**. There will be a service fee of \$25.00 for any check dishonored by the bank. All fees are non-refundable.
- F. **All required documentation listed above must be included with your completed re-application form. Documentation previously held on file will not be substituted.**
