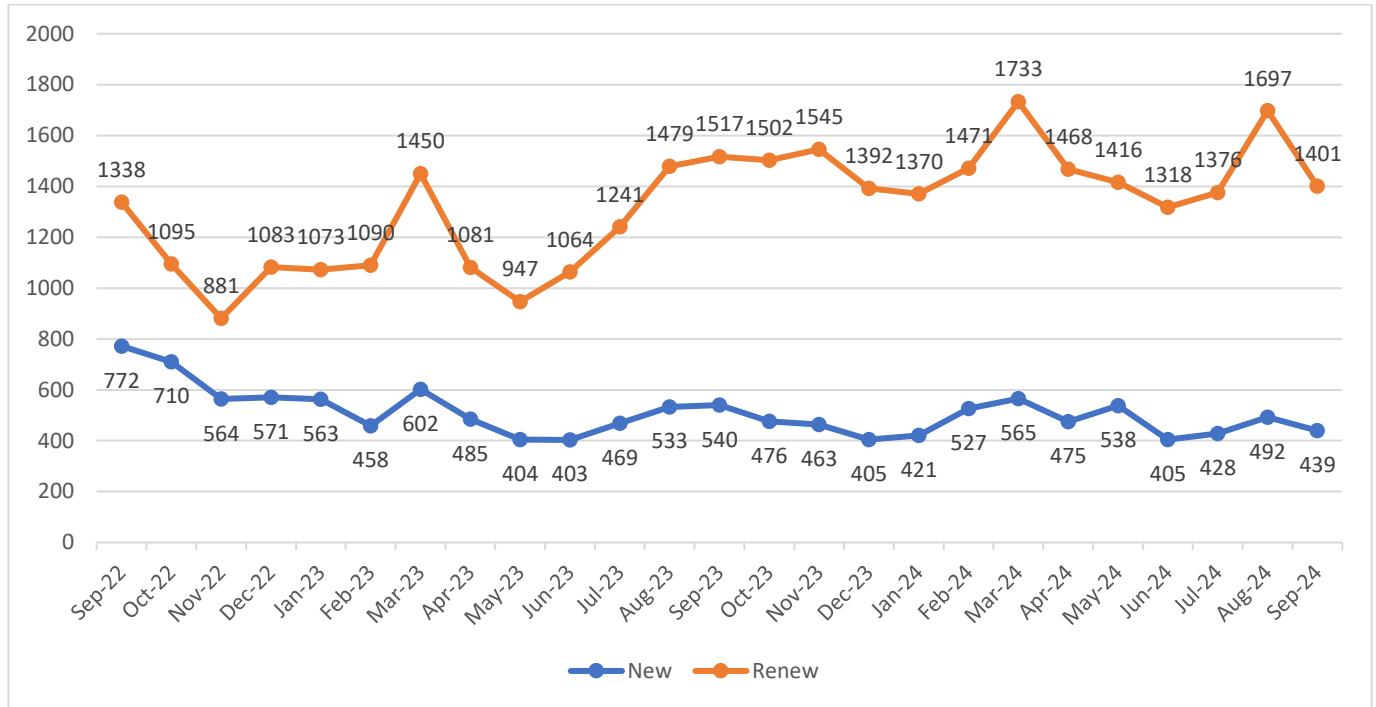

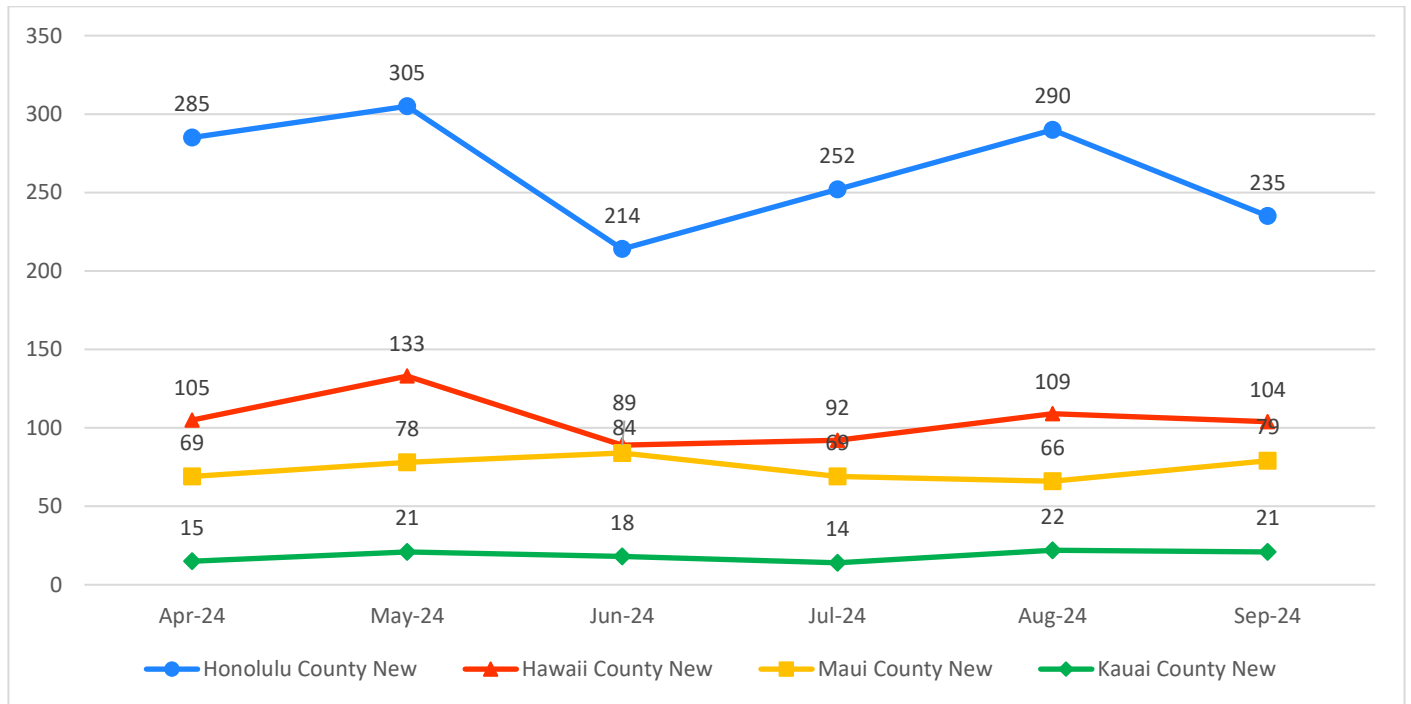

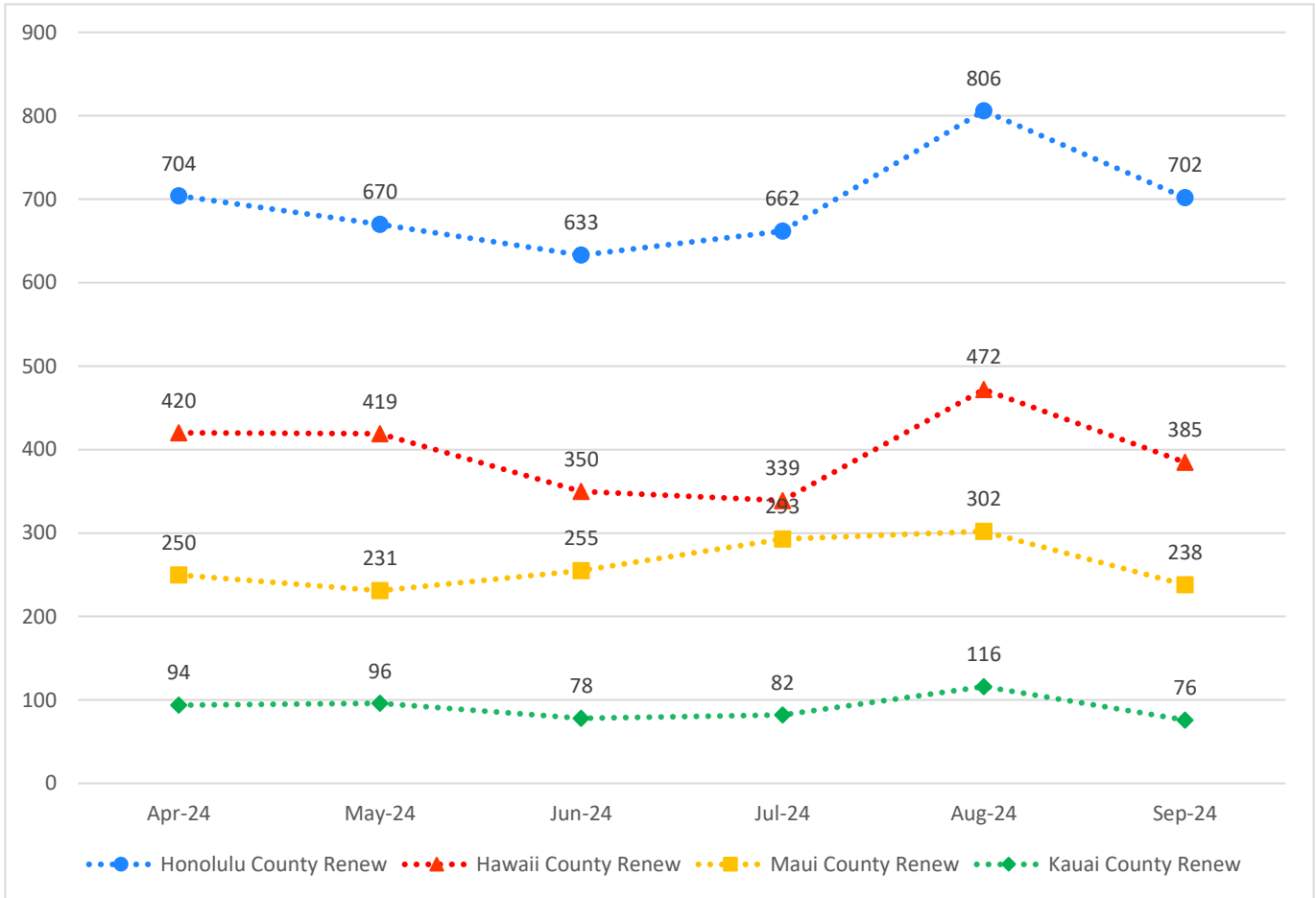
Graph 1. Number of Approved Applications: New Applications vs Renewal Applications, September 2022 – September 2024
