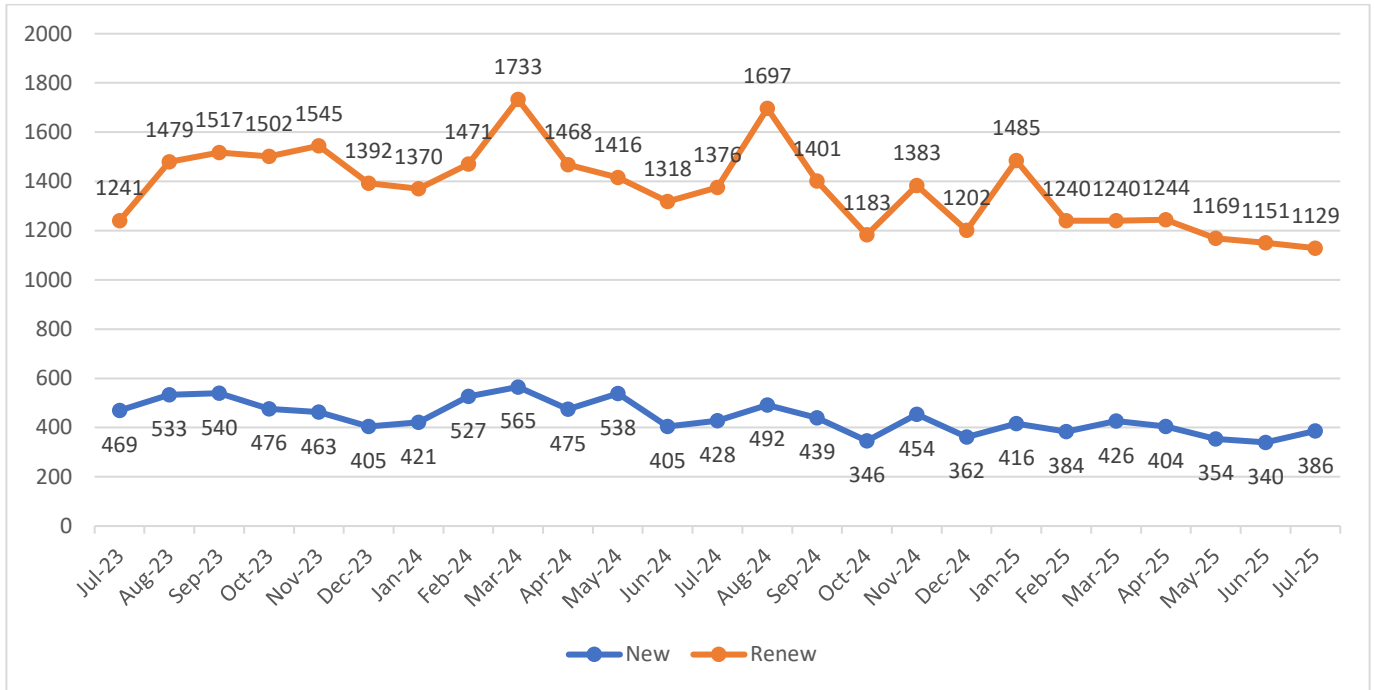

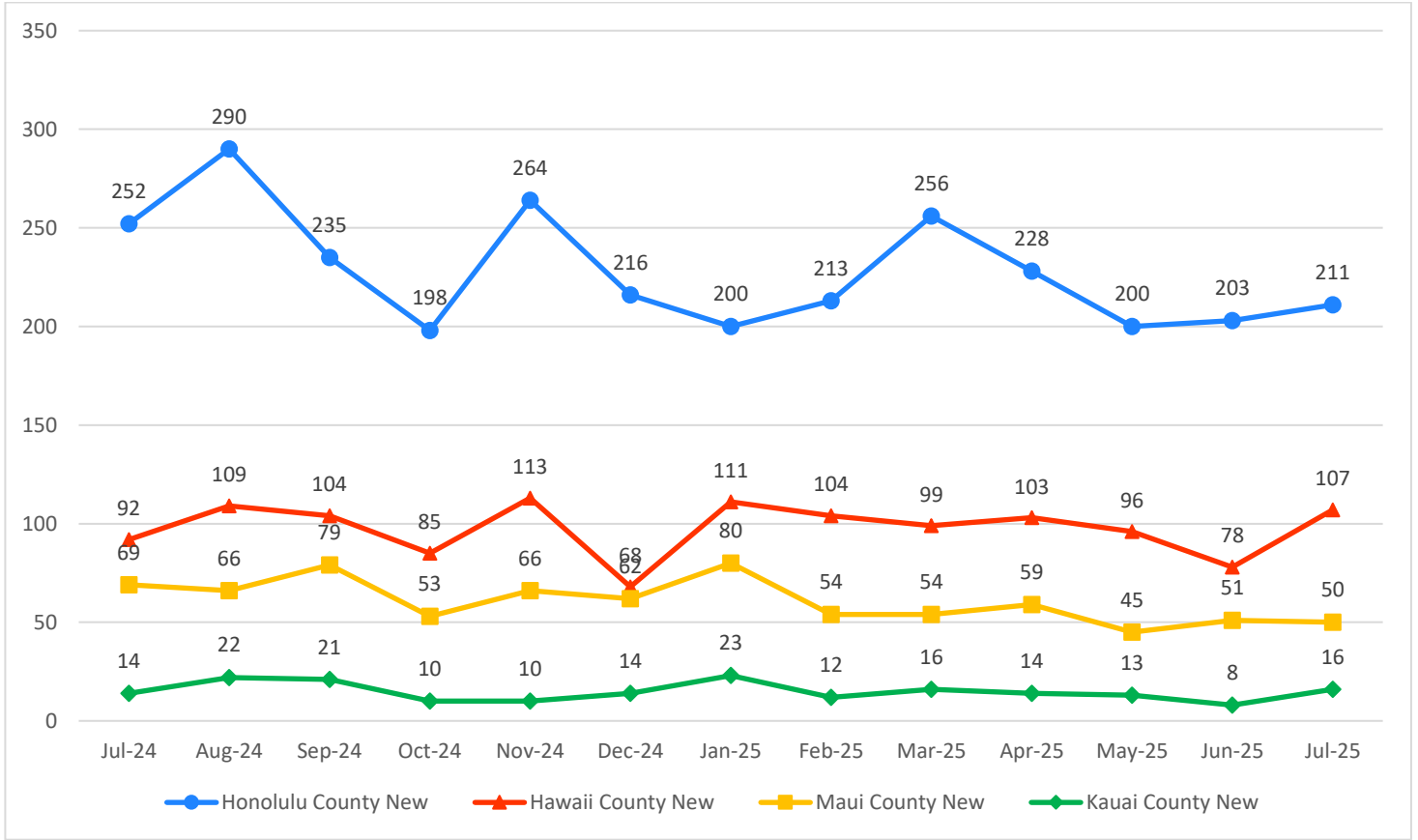

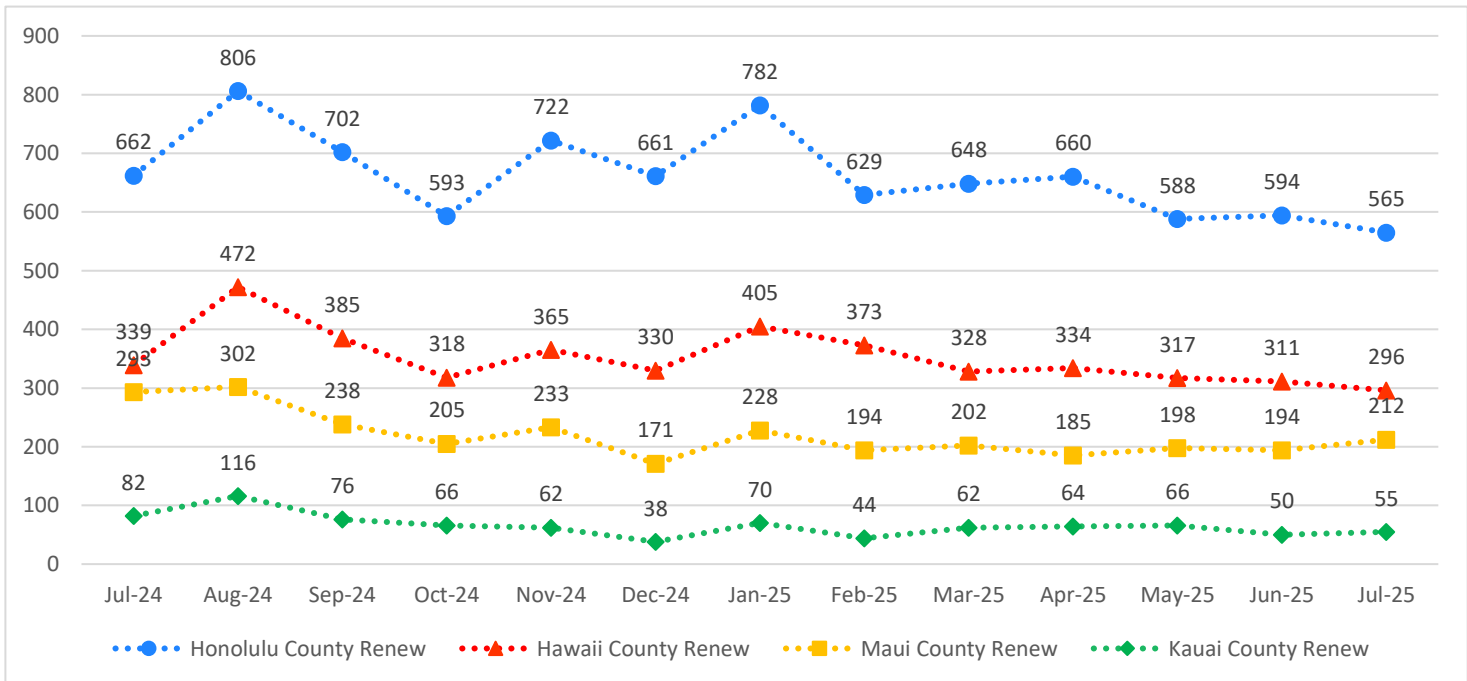
**Graph 1. Number of Approved Applications: New Applications vs Renewal Applications,
