**ALOHA COMPASSIONATE CARE'S NOTICE OF APPEAL REGARDING  
THE NOTICES OF DENIAL FOR MEDICAL MARIJUANA  
DISPENSARY LICENSES, DATED JUNE 16, 2016**

Applicant-Appellant Aloha Compassionate Care, LLC (“ACC” or “Applicant”) hereby appeals three Denials for Medical Marijuana Dispensary Licenses, dated June 16, 2016, numbered 3735, 3733, and 3727 (the “Denials”). ACC requests a hearing before the Director pursuant to section 11-850-101, HAR.

ACC respectfully submits this appeal and request for hearing (hereinafter “Appeal”), asserting that the Department of Health (“DOH”) erred in denying ACC’s three applications because the DOH relied upon erroneous and impossible information in rendering the Denials. Accordingly, the DOH’s Denials were arbitrary and capricious for reasons set forth in greater detail below. ACC reserves the right to amend this appeal or raise additional grounds for appeal of the Denials pending discovery of any new information supporting this appeal and request for hearing.

**1. ACC’s Timely Appeal was Filed Within 20 Days of Service and Receipt of the Notice**

Denial of a medical marijuana dispensary license is governed by section 11-850-24(c), which states in relevant part, “[a] person aggrieved by a decision made pursuant to this section

may appeal in accordance with this chapter.” Section 11-850-24(c). Subchapter 9 (Enforcement) details the procedure for a review of a denial, which includes provisions outlining the notice of Denial and the timing for review:

- [T]he order shall become *final twenty days after service* unless within those twenty days the alleged violator requests in hearing a writing before the director. Section 11-850-101(b)(emphasis added);
- When an applicant who has not received a license requests a hearing pursuant to section 329D-21, HRS, the department shall timely post that applicant’s request on its website. A successful applicant may intervene as of right in any hearing by an unsuccessful applicant for the same license. *Id.*, at (e);
- Notices under this section shall be served either by mail, return receipt requested, or in person. Notice shall be served upon the individual applicant or any employee who is present in the facility, and *is effective upon receipt. Id.*, at (g)(emphasis added).

In this case, the Denials were delivered by letter dated June 16, 2016, via certified mail, return receipt requested under tracking number 7002 0510 0004 3292 4027. *See* Notices of Denial for Application No. 3727, 3735, and 3733, attached hereto as Group Exhibit A.

According to the United States Postal Service, the Denials were received on July 7, 2016 shortly before 11:00 a.m. See USPS.com Product & Tracking Information for number 7002 0510 0004 3292 4027, attached hereto as Exhibit B. Thus, under the twenty-day rule of section 11-850-101(b), the deadline for this Appeal is July 27, 2016.

**2. The Department of Health’s Inconsistent and Legally Impossible Scoring was Arbitrary and Capricious**

While perhaps well-intentioned, the DOH scoring process was fatally flawed. Under the administrative rules governing the consideration of license medical marijuana dispensary applications, the DOH developed a “merit criteria” system. A copy of the State of Hawaii Department of Health Medical Marijuana Dispensary License Application Merit Criteria and Maximum Awarded Points memorandum, dated December 16, 2015, is attached hereto as

Exhibit C. In the agency's scoring process, applicants were to submit responses to each of thirteen separate criteria, including:

- Ability to operate a business, including but not limited to education, knowledge and experience with a list of general requirements;
- Business plan for operating a medical marijuana dispensary in the county for which the applicant is seeking a license;
- Proof of financial stability and access to financial resources;
- Ability to comply with the requirements for security compliance;
- Capacity to meet the needs of qualifying patients;
- Ability to comply with criminal background check requirements pursuant to this chapter and sections 329D-7, 329D-12, and 846-2.7, HRS;
- Ability to comply with the requirements for inventory tracking, security, and sales limits for qualifying patients;
- Ability to maintain confidentiality of a qualifying patient's medical condition, health status or purchases of medical marijuana;
- Ability to comply with the requirements for certified laboratory testing;
- Ability to comply with requirements for signage, packaging, labeling, and chain of custody;
- A plan for the secure disposal or destruction of marijuana;
- Ability to ensure product safety;
- No history of having a business license revoked.

See Exhibit C, at pp. 1-3.

Under the DOH's scoring scheme, four judges of a review panel<sup>1</sup> were required to group all applications by the county of proposed licensure, review all applications, and award a maximum of ten (10) points for each application merit criterion. Exhibit C, at p 1, *et seq.*, see also Section 11-850-21(b). The points awarded each applicant under this scheme would be

<sup>1</sup> According to the DOH, the four judges were H. David Bess ("DB"), James E. Duffy, Jr. ("JD"), Keith R. Ridley ("KR"), and Phyllis Shimabukuro-Geiser ("PS"). Because the DOH's scoring summary refers to each judge by his or her two-letter initials, Applicant will follow suit.





precisely the same submission is an example of “arbitrary” typified, and is outside of the scope of fundamental fairness in a state agency’s action.<sup>3</sup>

*c. Background Check (Criterion #6)*

For this particular criterion, the scoring is more than arbitrarily inconsistent, it rises to the level of actual impossibility. Criterion #6 calls for a response demonstrating the “[a]bility to comply with criminal background check requirements pursuant to this chapter and sections 320D-7, 329D-12, and 846-2.7, HRS[.]” See Exhibit C, at pp. 2-3.

In the present case, review panel judge JD awarded a perfect 10.00 score for Maui and Honolulu to ACC, but inexplicably awarded ACC only a 5.0 in Hawaii. Exhibit D, at pp. 3, 6, 8. The issue here is one of simple logic: An applicant’s agents either pass a background check or they do not. There could never be any meaningful difference between the ability of an individual to pass a background check in one county, while not passing (or even receiving a lower score) in another.

*d. Patient Confidentiality (Criterion #8)*

On item 8, “Patient Confidentiality,” review panel judge DB awarded a score of 10.00 on the Maui and Hawaii applications to ACC, but a 5.0 on the Honolulu application. *Id.* Once again, it is difficult to conceive how the identical response to a merit criterion can be awarded a different score when graded by the same judge.

*e. Chain of Custody (Criterion #10)*

<sup>3</sup> While not clearly apparent from the face of the Denials and public information released by the DOH, a score of 5.0 (“meets some requirements but not all”) seems impossible under DOH’s own criteria. At the time of application submission, ACC had over \$1.2 million in assets under its control and ACC’s principals had raised over \$50 million private equity in the past 18 months.

Similarly, review panel judge DB gave ACC's identical submissions a score of 5.0 on the Maui and Hawaii applications, but a 1.50 ("*meets some requirements but unacceptable*") on the Honolulu application for its ability to comply with the requirements for signage, packaging, labeling and chain of custody of products. *Id.*

Given the DOH's reliance on the arbitrary and capricious scoring done by its review panel judges, the Denials of ACC's applications must be rescinded and the entire scoring process reviewed to ensure that the fundamental notions of fairness and transparency are preserved.

***f. Revoked Business License (Criterion #13)***

The final criterion in the DOH's Medical Marijuana Dispensary License Application Merit Criteria process was "[n]o history of having a business license revoked." See Exhibit C, at p. 3. The review panel judges' scoring, and the DOH's acceptance of this nonsensical score, is perhaps the most puzzling element of this entire scoring process.

Though review panel judge DB awarded a 5.0 (*meets most requirements but not all*) on this criterion, ACC could never have received any lower than a 10.00, because neither ACC, nor any of its principals has ever had any sort of business license revoked. Exhibit D, at pp. 3, 6, 8. Indeed, like Criterion #6 (Background Check) above, the failure of the DOH to award the full 10.00 points for these two categories can only lead to the conclusion that the scoring process must be scrutinized to ensure that the process for awarding Hawaii's medical marijuana dispensary licenses is transparent, fair, and in the best interest of the State's public health considerations.

WHEREFORE, pursuant to HRS Chapters 91 and 329D and HAR Title 11, ACC requests that this appeal be granted and a hearing be set before the Director, as follows:

- That this matter be set for a contested-case hearing and that a reasonable schedule be established for briefing, discovery, and the presentation of evidence;
- That DOH be ordered to provide ACC with information sufficient to determine the specific reasons ACC received each merit category score from each evaluator;
- That it be found that DOH's Denials exceeded its statutory authority under Chapter 329D and HAR Chapter 11-850, acted upon unlawful procedure, acted in error of law, was clearly erroneous, and/or was arbitrary and capricious;
- If applicable, that the application score for ACC be amended as required;
- If applicable, that a dispensary license be issued to ACC in the event that ACC's corrected score be one of the top three scores awarded for the city and county of Honolulu, one of the top two scores for the county of Maui, or one of the top two scores for the county of Hawaii; and
- For such further relief that the Director deems just and appropriate.

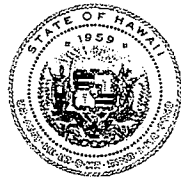

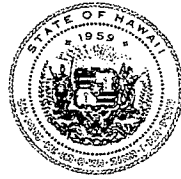

Dispensary license applicants may submit responses to each merit criterion for consideration as part of their application. The criteria listed below are included in Hawaii Administrative Rules Chapter 11-850-20. The rules describe the selection process for granting a license. The criteria below will be included on the department's application form which will be submitted through a web-based process. The application will be available on Jan. 11, 2016.

The department will only accept responses submitted as part of the department's application form during the open application period beginning January 12, 2016 and closing January 29, 2016.

The format for responses shall be double-spaced, 12 point font size or larger, margins no less than one inch on all sides, and no longer than the specified page length.
