SUMMARY

§11-160-56 Confidential information; exceptions.

(a) All information received and records kept by the department for purposes of administering this chapter are confidential and not subject to disclosure except to:

- (1) Employees or agents of the department as necessary to perform their official duties under this chapter;
- (2) Federal, state, or local law enforcement agencies for the purpose of verifying registration with the department pursuant to this chapter or for official law enforcement purposes;
- (3) A person or entity pursuant to an order or subpoena from a court or agency of competent jurisdiction;
- (4) A person or entity with the written permission of the qualifying patient or, if the qualifying patient is a minor or an adult lacking legal capacity, of the qualifying patient's parent, guardian, or person having legal custody;
- (5) Employees or agents of the State's medical marijuana dispensary system;
- (6) Employees or agents of the department's contracted computer software tracking system used within the State's medical marijuana dispensary system;
- (7) Medical marijuana dispensary system licensees as deemed necessary by the department for purposes of:
 - (A) Verifying the status of a person as a qualifying patient or primary caregiver; and
 - (B) Tracking a qualifying patient's allowable marijuana purchase limits; and
- (8) Other persons or entities deemed necessary by the department to administer this chapter or the State's medical marijuana dispensary system.

- (b) Nothing in this section precludes the department from the following:
 - (1) Notifying law enforcement or relevant authorities about falsified or fraudulent information submitted to the department;

- (2) Notifying state or local law enforcement about suspected criminal violations; and
- (3) Publishing non-identifying aggregated data or statistics of program information.
