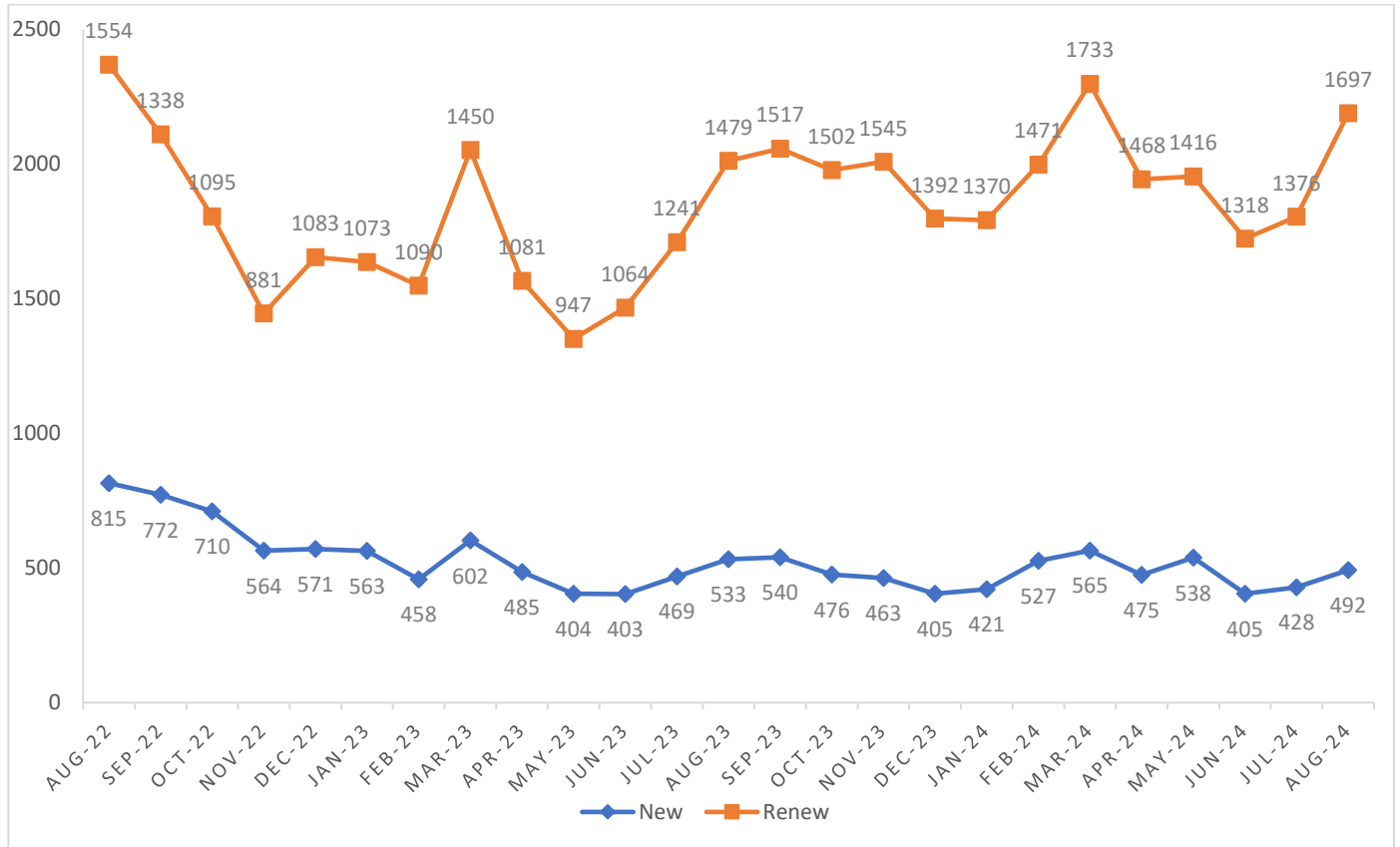

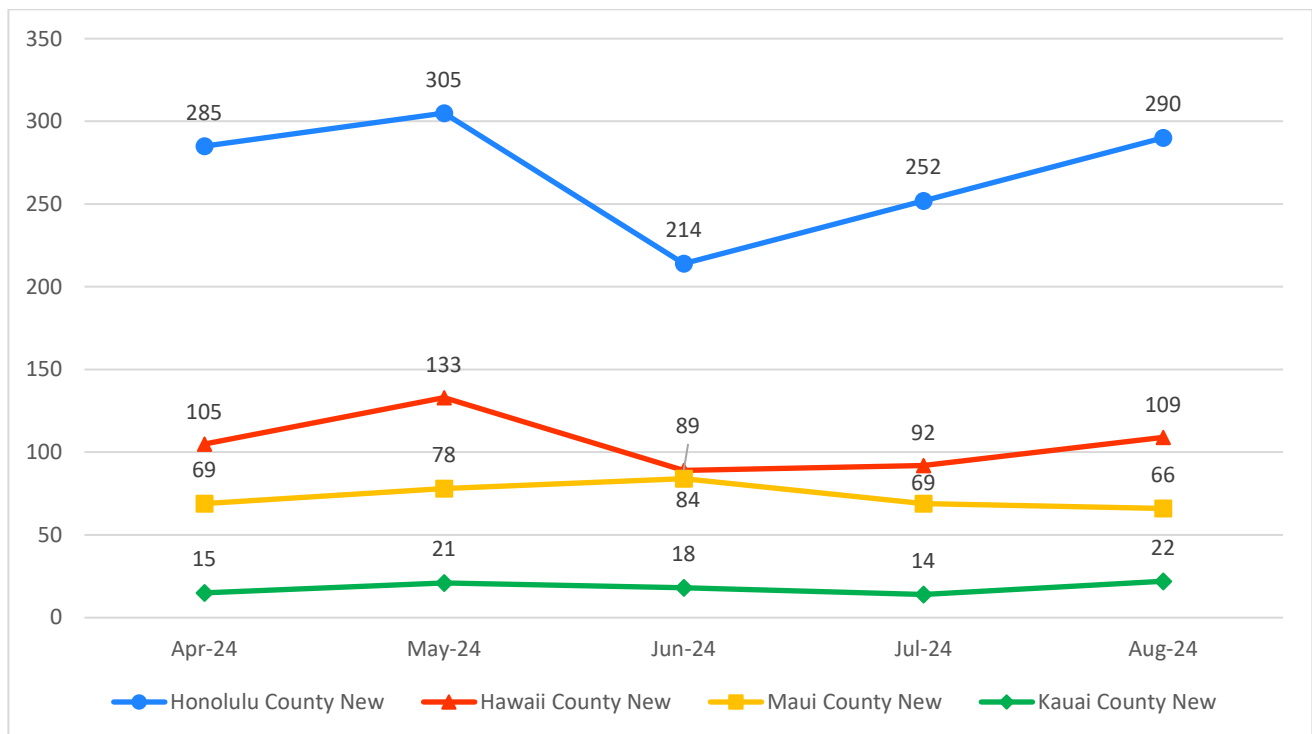

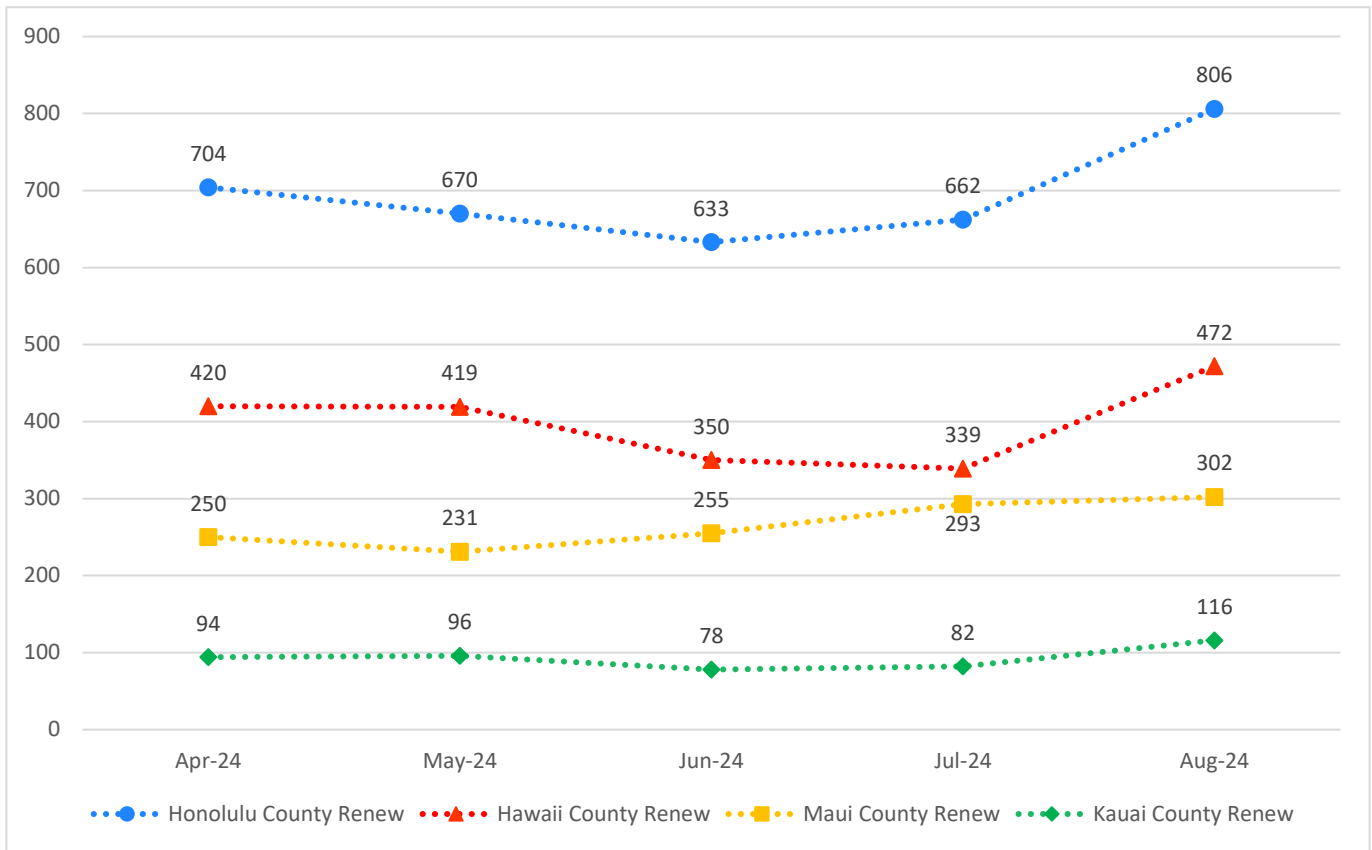
Graph 1. Number of Approved Applications: New Applications vs Renewal Applications, August 2022 – August 2024
