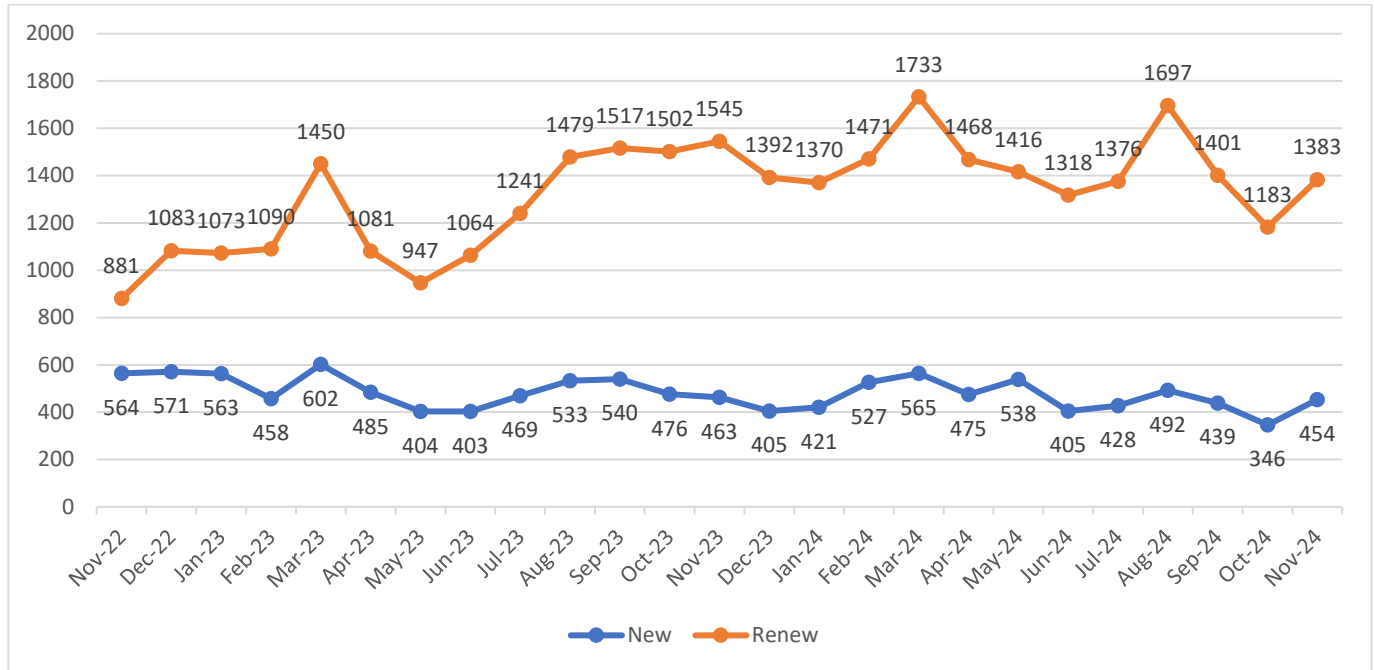

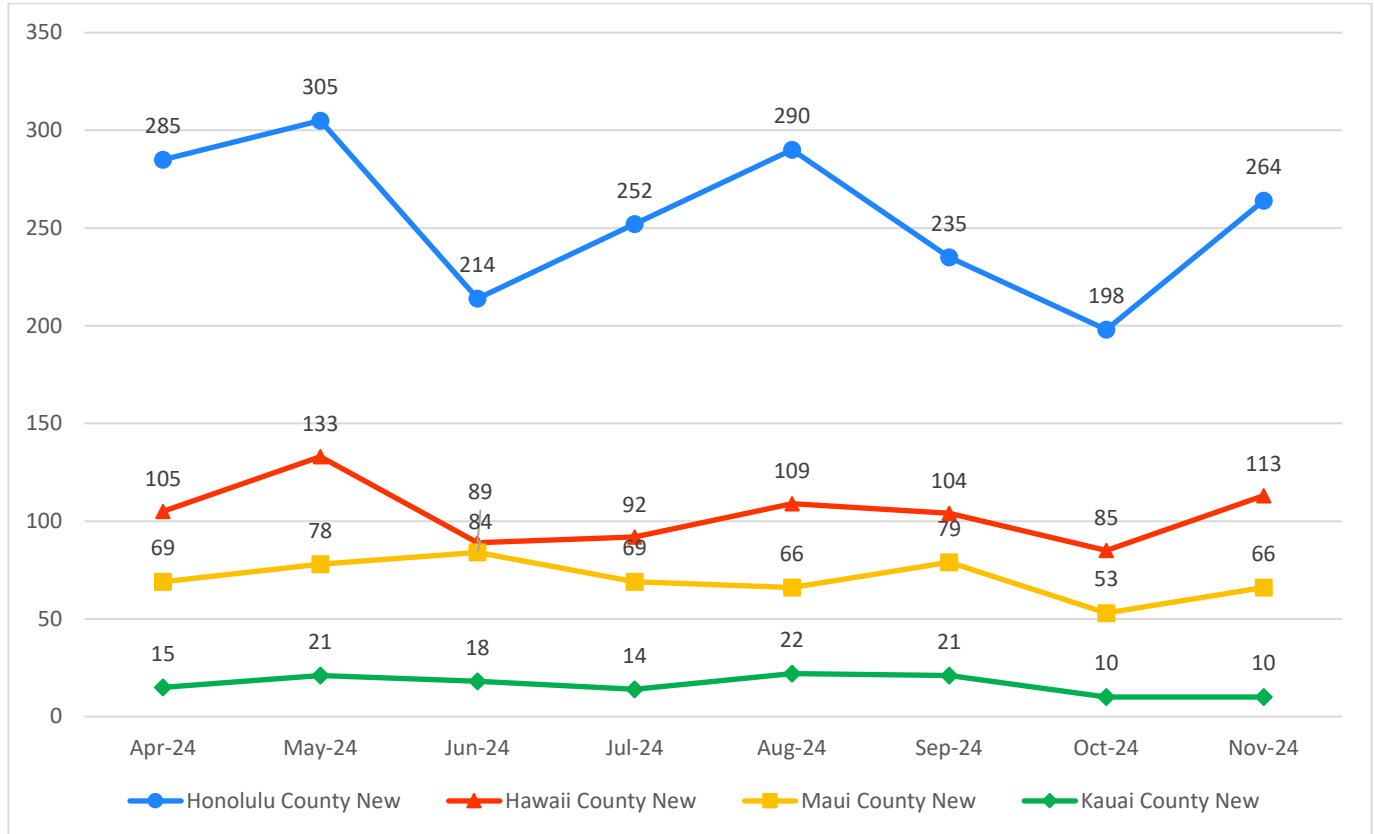

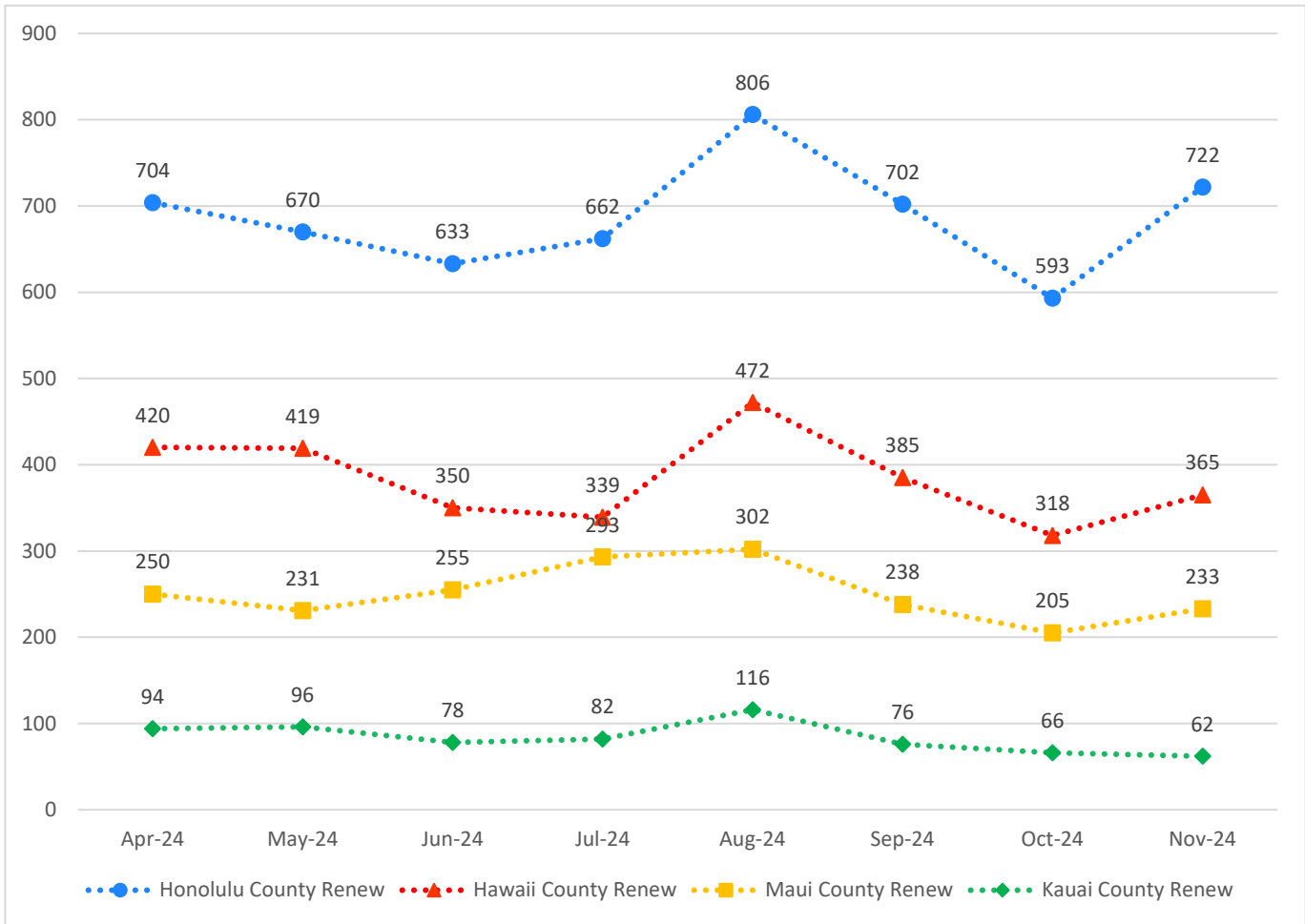
Graph 1. Number of Approved Applications: New Applications vs Renewal Applications, November 2022 – November 2024
