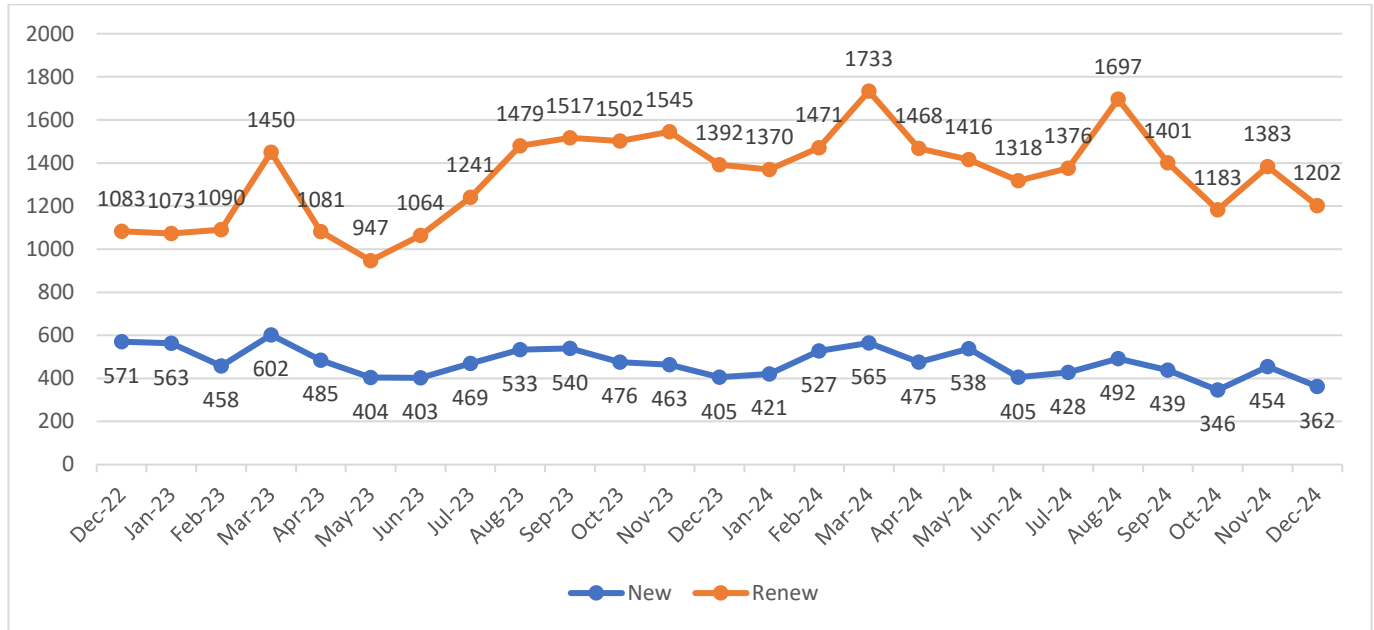

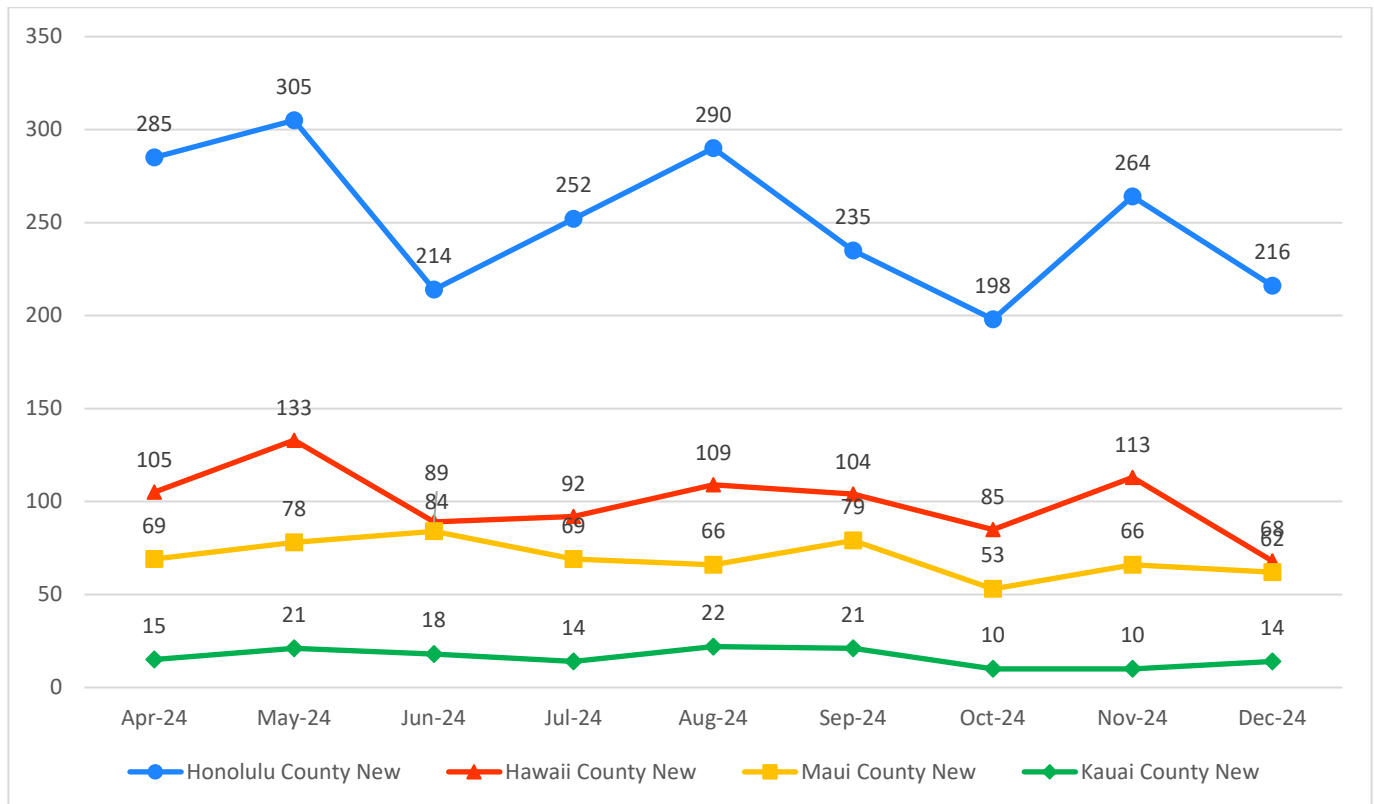

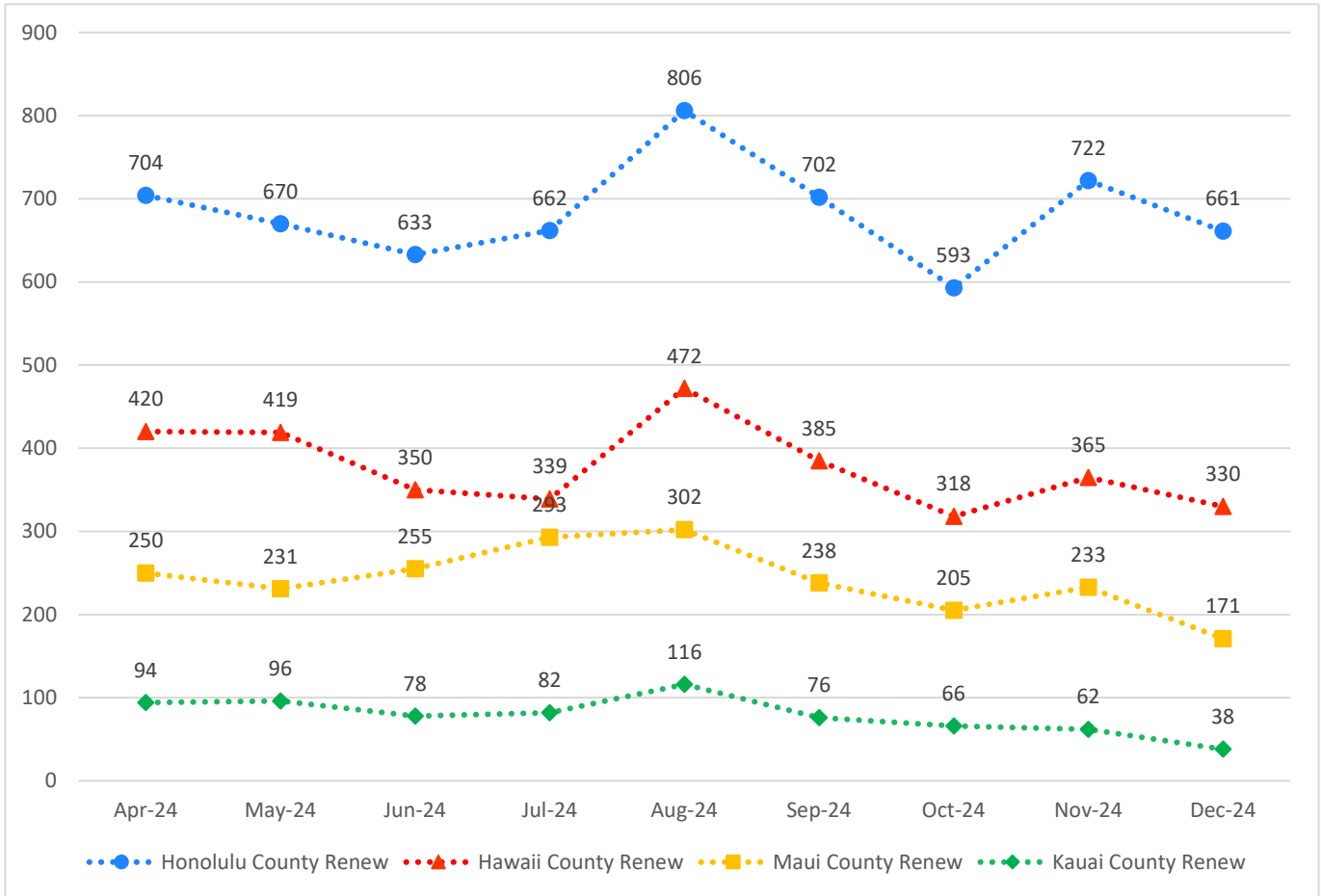
Graph 1. Number of Approved Applications: New Applications vs Renewal Applications, December 2022 – December 2024
