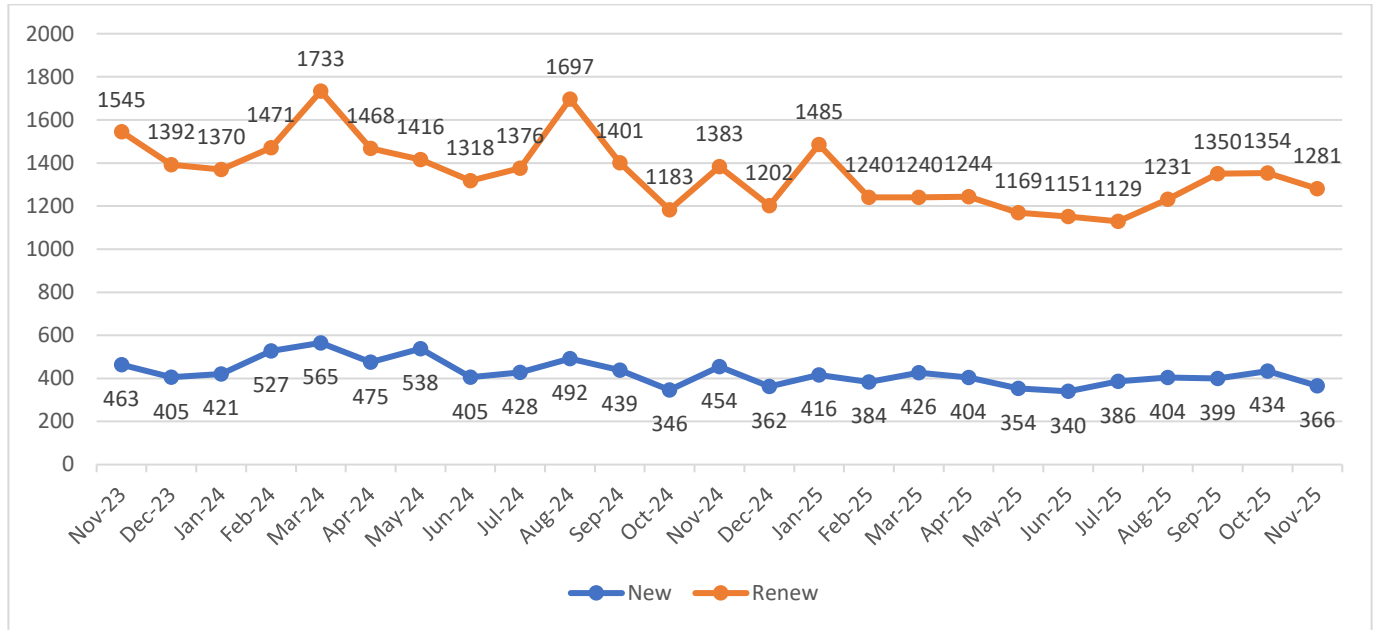

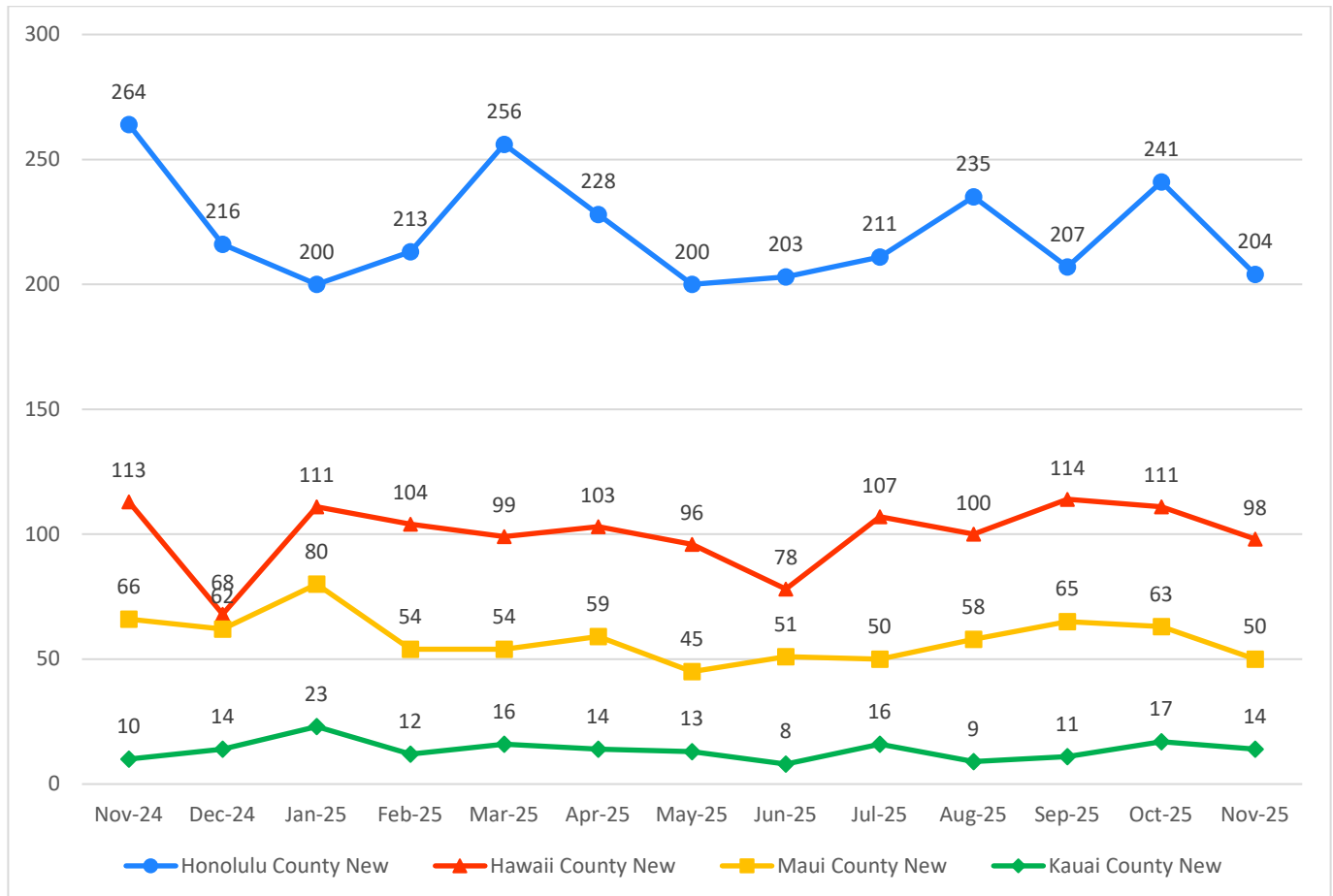

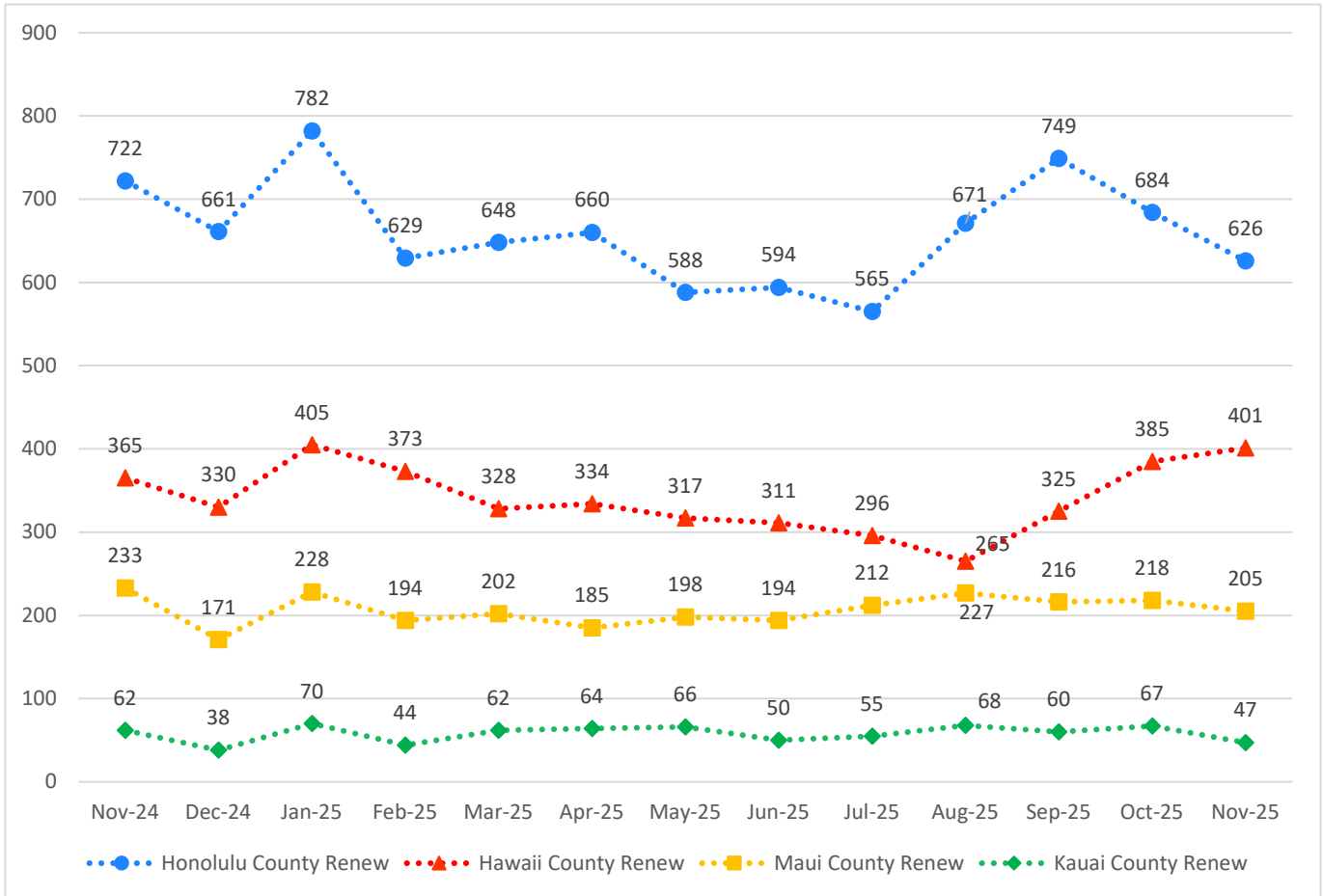
Graph 1. Number of Approved Applications: New Applications vs Renewal Applications, November 2023 – November 2025
