- I. Call to Order Meeting was called to order at 2:11 pm by Chair Scott

#### IV. **New Business:**

#### A. Concussion Summit 2020:

Ross Oshiro, Coordinator of Queen's Medical Center's for Sports Medicine conducted a presentation to propose the use of Neurotrauma's special funds to hold a training conference to increase provider knowledge and awareness of concussions. The Concussion Summit will be held on July 11, 2020 at the St. Louis School Mamiya Theater. They have currently recruited guest Christopher Giza, MD, UCLA, Erik Swartz, PhD, ATC, University of Massachusetts, Lowell, Jen Prins, MD. Sports Psychiatry Pittsburg, Gerald Gioia, PhD, Children's Hospital, Jennifer Wilhelm, PT, DPT, NCS, OHSU, and Kyoko Shirahata, ABD, ATC, HCAMP.

Board Member Molly Trihey motioned to approve the proposal; Board Member Lyna Burian seconded the motion. All board members present voted in favor.

#### V. Old Business:

A. Project Head, Neck, Spine (PHNS) Update:

Per Allison Tsuchida of UH COE, PHNS data has changed slightly since NTAB meeting on August 30, 2019. As it stands, report showed Seven schools (4 high schools, 3 middle schools), four on Oahu and three on Maui, utilizing the online curriculum.

A total of 8 instructors have been utilizing the curriculum with 2 instructors using it for the second time. Ms. Tsuchida and the Hawaii Concussion Awareness Management Program (HCAMP) team was an exhibitor at the Schools of the Future Conference. They were able to recruit 18 new sign-ups. A comic book is being created to be implemented for use at the elementary level.

## B. Pacific Disabilities Center (PDC)/Hawaii Neurotrauma Registry (HNTR) Update:

In August 2019, a total of 58 persons have registered with HNTR with 17 based on Oahu, 25 from Maui County, and 10 from Kauai for Year 7 of the contract; total number of persons registered since Year 1 is 443.

HNTR attended 5 events in September 2019, a caregiver conference in Kona, and keiki fairs in Hilo, Maui, Oahu, and Kauai. HNTR will continue to attend events and provide presentations statewide to increase registry enrollment that will assist individuals with brain injury.

### C. RAPID Hawaii Update:

DOH staff Chelsea Ko reported that contract was executed on October 1, 2019. The RAPID software will be used statewide to evaluate stroke treatment to eligible patients with Mechanical Thrombectomy. An update will be provided at the next NTAB meeting on December 13th.

#### D. Storytelling Event Update:

DOH staff Michele Tong reported that the Storytelling Event will be held on November 17, 2019 at the Oahu Veteran's Center from 11 am to 2 pm. There will also be activities and informational booths by Hawaii Disability Rights Center, University of Hawaii at Manoa College of Education, Pacific Disabilities Center, Department of Health Neurotrauma Supports, Dr. Sheri DuBay, Brain Injury Association of Hawaii, Olelo Media, Diana Ho Yoga, Hui Malama Po'o, and Hawaii Bicycling League.

## Project Head, Neck, Spine Update NTAB Meeting on 10/25/19

#### Six schools utilizing curriculum:

- Four high school and three middle schools
- Four on Oahu
  - 3 Honolulu (Middle N = 248; High N = 129)
  - 1 West Oahu 2 teachers (High = 131)
- Three on Maui (Middle N = 114; High N=110)
  - 15 students from Maui high schools are new this year and have only taken pre-test so excluded from count.

#### Data:

- 8 instructors (\*\*two instructors used/using it for the second time)
- Total students N = 732 \*On the last report we had a technical error and some students were doubled up. Apologies for the error it has been corrected.
  - Average summary score of 82.1%
  - 530 completed module 4 (half-way) Average summary score: 84.4%
  - 390 complete Average summary score: 87.0%
- Pre- and Post-test data
  - Pre-test average of 58.85%
  - Post-test average of 76.89%
- Module average scores
  - All above 80%, except for Module 2 (74%) which is a bit more technical (i.e. parts of brain)
