# NEUROTRAUMA ADVISORY BOARD (NTAB) MEETING MINUTES

October 23, 2020

- I. Call to Order Meeting was called to order at 1:41 pm by DOH Staff Christel
   Magallanes. Quorum present.
- II. Approval of Minutes from the August 28, 2020 meeting Board Member Stella Wong motioned to accept the minutes as written. Board Member Matt Wells

seconded the motion. All Board Members present voted in favor of minutes being accepted as written. No questions or discussions.

III. **Review of Agenda** – Agenda accepted as written. No questions or discussions.

#### IV. New Business:

### A. Permitted Interaction Groups (PIGs):

Guidance was received from the Hawaii Ethics Commission on how to establish subcommittees. Per policy, Neurotrauma Program must obtain input through public testimony or establish a permitted interaction group to allow board members to discuss and investigate matters without violating the Sunshine Law. The Sunshine Law prohibits two or more board members from discussing matters outside of board meetings.

The Public and Provider Education subcommittee members are Lisa Dau, Molly Trihey, Dr. Sara Farnham, and DOH Staff. Members will develop and implement strategies to ensure Neurotrauma Program goals are achieved. Per DOH Staff Christel Magallanes, first meeting will discuss scope of investigation and each member's authority as defined. Members will be responsible to represent in the interest of stakeholders and will present their findings and recommendations with all other subcommittees. If desired, the advisory board will participate in discussion, deliberate, and decision-making.

A motion to approve establishment of PIG was called. Matt Wells motioned to accept. Stella Wong seconded the motion.

# B. March 2021-Brain Injury Awareness Month

Neurotrauma Program proposed the use of media to commemorate Brain Injury Awareness Month in March 2021 by way of a three-part TV ad campaign. Board Member Rita Manriquez suggested featuring persons with brain injury to show how it can affect anyone. Dr. Violet Horvath of PDC recommended a one-hour webinar. Chair Scotty Sagum emphasized the need of brain injury prevention, and Troy Furutani of UH-COE suggested on creating a public service announcement.

#### V. **Old Business:**

#### A. RAPID Hawaii Update:

Dr. Matt Koenig of QMC reported RAPID installed at all sites except one; Kuakini Hospital is delayed and HHSC will be in operations once staff complete training. Dr. Koenig shared the training schedule with the advisory board. Training is tracked through QMC, but each site designates staff that requires the training.

The Hawaii Stroke Symposium is scheduled for November 14, 2020, from 8:00 am - 4:00 pm. Registration is \$50. Attendees receive 5.25 hrs. of continuing credits. All are encouraged to attend.

# B. Project Head, Neck, Spine (HNS) Update:

A total of 14 schools are currently using the online curriculum. Per Dr. Allison Tsuchida of UH-COE, data shows an increase of 115 students newly enrolled and performance assessment is up 80%. There is a positive increase from pre and posttest percentages.

HNS participated in the virtual Children and Youth Day on October 4, 2020, and as a result, 10 home-schooled students on Oahu have registered. Four of

the 10 students have progressed to Module 1 of the curriculum. Dr. Tsuchida also registered a 3<sup>rd</sup> grade class on Oahu and is in contact with Ele'ele School on Kauai.
