- I. Call to Order Meeting was called to order at 1:37 pm by Chair Scotty Sagum.
 Quorum present.
- II. Approval of Minutes from the October 28, 2021 meeting Board Member Stella Wong motioned to accept the minutes as written. Board Member Rita

Manriquez seconded the motion. All Board Members present voted in favor of minutes being accepted as written. No questions or discussions.

V. **Old Business:**

A. RAPID Hawaii Update:

Dr. Koenig reported on Year 2-RAPID Hawaii Statewide collaboration on Acute Stroke Care. Report detailed description of the RAPID project and data status updates.

In summary, Year 2 concluded with 906 completed CT scans for patients suspected of stroke. Treatment rate for thrombolytic therapies, including tPA and mechanical thrombectomy (MT), are nearly 20% year-to-date. Data showed a continued increase in the number of MT cases in Hawaii, with the State making progress toward the contract's goals of 150 per year by 2022. Significant improvement is still needed for Door-in-Door-out times which measures the amount of time a patient is first admitted to the hospital to the time the patient left the hospital to be transferred for a higher level of care. In 2021, a little over 5% met the standard of care of less than 90 minutes. Data on safety and outcomes (bleeding complications due to treatment) is at 1.9% year-to-date, which was a significant improvement compared to the past three years.

RAPID is in its final year of funding. Kuakini hospital is still not active. Ischema View (RAPID) will credit two years of service back to Kuakini if it is operable by the end of contract. A definitive update will be presented at the next board meeting. Dr. Koenig is currently working with IschemaView on individualized financial packages to help sustain services for each hospital site once funding ceases.

B. Project Head, Neck, Spine (HNS) Update:

Seventy-six (76) new students started the curriculum, and eighty-one (81) students completed the curriculum. Three home-schooled students enrolled but have not started. Two (2) new teachers started and completed the educator course. Pre-test score is at 76% and post-test is 85%. Data showed all modules are meeting the 80% benchmark.

In other updates, HNS mailed brain balls to an elementary school on the Big Island. PE teacher is working to implement HNS curriculum with 650 students. DOE approved the HNS professional development course. New upper elementary students signed-up but only pre-test data is available.
