- Kristen Keech QMC is still implementing the sleep/wake bundle to help individuals having acute injury regulate day and night. Staff will learn how to interact with survivors during the acute phase. Data is being collected and will be shared at a later time. Ms. Keech submitted a proposal, and it was accepted. Proposal focused on developing an evidence-based care model on how to better serve individuals in a coma, unresponsive wakefulness, or minimal conscious state using available resources to translate knowledge into practice.
