To ensure this doesn't happen again, PCGs will do random and periodic audits of the medication cabinets while they do their weekly house visits to ensure all medications are locked away and are in the correct containers.

FINDINGS Resident #2 – 12/1/2023 order for Acetaminophen = 325 mg – 2 tabs orally every six (6) hours as needed for mild pain or temperature of 100.4 degrees Fahrenheit or higher, not to exceed 3 grams from all sources. Medication label missing added "as needed indication of temperature 100.4 degrees Fahrenheit or higher."	To prevent reoccurrence, the PCGs will make regular rounds in the homes during their house visits and receive updates on the residents. During the report, the SCG will inform the PCGs of medication changes. PCGs will check the medication bottle, MAR, and physician order. To ensure compliance with medication labeling and that the correct medication is present. 2 SCGs are required to do double checks on all ordered medications to make sure the label, order, medication (strength, dose, route, and time), and MAR all match. Additionally, SCGs will be re-educated on the importance of labeling medications upon receiving them and utilizing the three-check system before administering medications to residents.
